Why Blacks Don't Vote for Republicans ... and Why Donald Trump Can Change That

A swe celebrate Black History month, one of the most vexing political realities is the overwhelming support the Democratic Party receives from black voters. On November 8th, eight percent of black voters cast ballots for Donald Trump. This was about average for Republican presidential candidates in recent years, and quite respectable in view of media-driven

anticipation that The Donald would receive less than three percent.

For almost 50 years, I have been deeply involved in the black community and an outspoken proponent of Republican outreach to the black community. It started in my college days in the 1960s when, as president of the Knox College Young Republicans, I brought black students into leadership. Following graduation, I joined with a young black man named Connie Mack Higgins and a young Hispanic man named Jose Carlos Gomez in forming a Republican rainbow coalition long before Jesse Jackson popularized the term.

Through our efforts, Higgins was elected vice president of the Illinois Young Republicans—the first black elected to leadership—and was appointed by Nixon to head up the minority business office of the Small Business Administration.

I have spent considerable time in the inner city investigating and exposing poor housing conditions, educational deficiencies and joblessness. As executive director of the City Club of Chicago, I launched numerous programs to fight black oppression. While living in Evanston, Illinois, I co-founded the biracial Evanston Coalition with a local black activist friend.

I often jest that if you know anyone who has spoken in more black churches than me, they are called "pastor." I offer this biography as a foundation for my opinion as to why I believe that the GOP does not get more black votes. There are several reasons.

 Republicans simply do not try—at least not until Trump. Campaigns will privately say that it is not worth the effort and financial resources. Why the Republican Party organizations at the national and local levels have not developed effective programs to recruit blacks is more a matter of shortsightedness and incompetence. I have heard the protests to the contrary, but the answer is in the vote totals.

- 2. Republicans do not fight back. On their website history, the Democratic Party claims that "for more than 200 years, we have fought for civil rights." That is an audacious lie that is widely believed and so easily refuted. But, has the GOP demanded that it be removed as a means to open a true public dialogue on race? Nope. Did the Republican leadership pitch in when a number of black students demanded the removal of the Woodrow Wilson name at Princeton? Nope. The Democrat false narrative on civil rights is what Lincoln called an ill-founded widely held belief that has the impact of fact.
- 3. Republicans settle for window dressing. Yes, there are black conservative Republicans—and the number is growing. But even at that, grassroots black Republicans tend to look like they just returned from the country club. Too many Republicans believe they are reaching out to the black community by having a black friend or having pictures taken with black people. If the Party is to engage with the black community in a meaningful way, it needs to connect with the oppressed inner city blacks who are more likely to raise eyebrows walking into one of the "better clubs." Ghetto-ized blacks do not look like they just graduated from college because they never had that opportunity—and they are the ones who most need the Republican Party's vision and policies of America as an opportunity society.
- 4. Too many Republicans believe that the way to win over black voters is to talk and act like Democrats. They embrace the Democrats' false narrative of generational welfare as civil rights. They vote for the failed social welfare legislation that has cost trillions of dollars without discernible benefit to the urban segregated black community, to the Republican Party or to the nation. It is no small irony that the Democrats succeed by offering blacks the addictive economic narcotic of welfare while denying them the inalienable constitutional rights of equal justice under the law, safe streets, job opportunities and, above all, access to education that can produce career level jobs.
- 5. Republicans do not know their history. It is not enough to talk about Abraham Lincoln. The long history of the Democratic Party's institutional racism started in its defense of slavery, followed by the imposition of *de jure* segregation in the south. Democrat racism exists to this day in the segregated urban centers long ruled over by their political machines—cities where black frustration

and anger boil over generation after generation. Still, few Republicans will prosecute the case against the Democratic Party.

- 6. Republican black leaders too often focus on the personal benefits of black tokenism. Black Republican leadership is important, but they tend to come and go without much impact on the voting demographics of the greater black community. While the GOP has black liaisons and officials at all levels, it is almost impossible to find a Republican meeting with more than a spattering of black attendees—and even the GOP's black clubs and organizations are poorly attended. The GOP does not go into the heart of the impoverished and segregated black communities run by Democrat political machines.
- 7. It is sad to say, but too many Republican leaders believe that any attempt to bring the black community into the GOP if futile. In fact, it is essential to the future existence of the Party. The Democratic Party's *de facto* racism against urban black America has given the GOP an enormous opportunity that is largely unrecognized by Republican leadership at all levels.

Since the evidential history of Democrat oppression of the black community is so overwhelming, and the RepubRepublican Party to make the case. President-elect Donald Trump is the first Republican presidential candidate to make addressing the plight of the impoverished inner city minority communities a major commitment. Time will tell if he has the determination and the right strategies, but it is the most hopeful sign I have seen in more than 50 years. Breaking off 15 to 25 percent of the black vote could give the GOP national election dominance for the next 50 years, effectively putting an end to the welfare dependency alliance between Democrats and the black community that began under Franklin Roosevelt.

Democrats Challenge Missing Mail Ballot Procedures

O n October 3, 2016 the Democratic National Committee (DNC) and Florida Democratic Party (FDP) filed a federal lawsuit in Tallahassee to contest the lack of procedure to provide a cure of mail-in ballots found to have a signature that is different than the signature on file. These mail-in ballots are not counted under the procedures complained about in this case.

Mail-in ballots with no signature whatever are treated by allowing the Supervisor of Elections (SOE) to notify the voter there was no signature. If the procedure is followed, the voter might have the vote counted.

By October 25, 2016 the court issued a brief order stating: "On October 16, 2016, this Court issued a Preliminary In-junction ordering that voters who submit vote-by-mail ballots with mismatched signatures must have the same opportunity to cure that is provided to voters who submit unsigned vote-by-mail ballots. ECF No. 34. The parties are directed to file a notice by Friday, October 28, 2016, at 5:00 p.m. if they require any further action in this case. If not, this matter will be closed on Monday, October 31, 2016."

The parties filed a Joint Notice on October 28, followed the same day by another Notice from plaintiffs' attorney, Mark Herron, Esq. of Messer Caparello, P.A. in Tallahassee, asking for a status conference to be set after the November 8 election.

District Judge Mark E. Walker then set a telephone conference for noon on December 12, 2016. Thus a pre-election decision was avoided on the merits of the case.

In the Complaint, the plaintiffs allege that:

"1. ... Plaintiffs bring the instant lawsuit to protect this right and to prevent the disenfranchisement of thousands of Florida voters whose right to vote has been disenfranchised in past elections, and will be in the upcoming 2016 general election, unreasonably and unduly burdened by a standardless system of assessing signature authenticity on vote-by-mail ballots (formerly called "absentee" ballots, which fails to provide affected voters an opportunity to cure their ballots.

2. Vote-by-mail voting in Florida is on the rise. In the 2012 general election, over 28 percent of all ballots cast were submitted by mail. The use of vote-by-mail increased nearly six percentage points in 2012 over what it had been in 2008, with over 2.37 million vote-by-mail ballots cast in 2012, out of 8.5 million total votes cast. In the 2008 general election, the number of vote-by-mail ballots returned was 1.85 million. And while the turnout in the 2014 midterm election was significantly lower overall than in 2012, in 2014, 1.9 million vote-by-mail ballots were returned for that election.

3. The use of vote-by-mail in the 2016 primary elections evidences the continuation of this trend, with more than half a million vote-by-mail ballots returned in advance of the March 15, 2016 primary election. *See* Steve Bousquet, *With half-million absentee ballots turned in for Florida's Primary, Miami-Dade a focal point for problems*, Miami Herald (Feb. 25, 2016), http://www.miamiherald.com/news/ politics-gov-emment/state politics/article62533382. html. The forthcoming general election promises to be no different.

4. However, each general election cycle, thousands of voteby-mail ballots are rejected by county canvassing boards for not conforming to the statutory requirements for those ballots. County canvassing boards rejected nearly one percent of all vote-by-mail ballots returned in 2012—more than 23,000 ballots. One cause for vote-by-mail ballot rejection is a determination that a voter's signature, executed across the envelope containing the ballot, does not match the signature in the voter's registration file. This is referred to as "signature mismatch."

5. Rejection rates for vote-by-mail ballots vary significantly across Florida's counties, underscoring the arbitrary and standardless nature of the statewide process for assessing whether a voter's signature on the vote-by-mail ballot envelope matches the signature on the voter's relevant registration document.

6. In the upcoming general election, not all vote-by-mail ballots that are initially rejected will be treated equally with regard to the ability of a voter to "cure" his or her ballot. Voters who fail to sign their ballots at all are provided an opportunity to cure that defect; but voters whose ballots are rejected for signature mismatch have no recourse. Their votes simply are not counted."

Counsel for plaintiffs are Mark Herron and Robert J. Tefler III of Messer Caparello, P.S in Tallahassee and Marc E. Elias, Bruce V. Spiva, Elisabeth C. Frost, and Amanda R. Callais of Perkins Coie, LLP in Washington, D.C.

The Secretary of State filed an Answer to the Complaint that begins with: "The independent county supervisors of elections and canvassing boards are solely and exclusively responsible for assessing ballot signature authenticity. The Secretary is not involved in this process whatsoever, and the Secretary does not implement or control the standards employed by those independent county supervisors of elections and canvassing boards."

2. The plaintiffs' allegations are based upon records that are open to the public, and those public records speak for themselves."

Answer, 2

The Secretary's Answer also pleaded sovereign immunity, lack of Article III standing, lack of associational standing, and failure to join indispensable parties. The Secretary also filed a Motion to Dismiss.

Counsel for the Secretary are Adam S. Tanenbaum and David A. Fugett, Florida Department of State.

This case may be dismissed in a few months unless plaintiffs can give the Court more substance to act upon. However, the lack of a procedure for curing mismatched mail-in ballot signatures is something that the Florida Legislature can work on before the next election. The 2000 election was another instance of "standardless" counting of ballots. Florida voters deserve better.

Madonna may have given some unhinged fan of hers an idea when she cried out that she wanted to "Blow up the White House." We're in dangerous, uncharted waters here. Former President Obama chimed in that, "I am heartened by the level of engagement taking place in communities around the country." There is no doubt that shortly there will be physical casualties resulting from these mass demonstrations.

But let's examine another cause which should be of interest to us, that the radical element in our own society, in league with their Islamist partners are planning to spotlight with their now familiar, easily led-by-the-nose street demonstrators. President Trump will surely take up the matter of Israel in the very near future. His campaign promise to move our embassy to Jerusalem will have to be addressed shortly. And when he officially fulfills his promise, be prepared for these same crowds, this time reinforced by throngs of Muslims led by their imams and Islamist organizations to spearhead anti-Israel demonstrations throughout the country.

The recent outcries in support of the few Muslims coming from ravaged Middle East countries being stopped at our airports have whetted the rioting appetites of radicals ready to tear our cities apart. Most of the participants in the recent non-violent street demonstrations have been white women. However, when issues dealing with Israel and Palestine are acted upon by the White House, watch for the heretofore quiet local Muslim populations to rise up and emulate their cousins in France, England and throughout Europe. That's a problem our leaders in Washington should be considering now. We are concerned.

To sum up, we view the street demonstrations over the last two weeks as harbingers of planned anarchy not only against our president but against our way of life. We are a nation of laws. Those who did not vote for Obama in 2008 and 2012 never referred to him as "illegitimate," rioted in the streets against his many questionable decisions or demeaned his family or intelligence.

But we have now reached a tinderbox point with hundreds of thousands of Americans at the ready to continue their chipping away at our democracy and with it, our security and future. We fear for the goals of these anarchists which are to disrupt our way of life, perhaps with violence and chaos. We must stand strong against them in order to remain the freest, safest, most democratic country on earth.

Book Review

Common Sense, Rights of Man, and Other Essential Writings of Thomas Paine, 20th Anniversary Edition, with an Introduction by Sidney Hook and a Foreword by Jack Fruchtman, Jr. New York: Signet Books, 2003. Paperback, 381 pp.

I read this book, *Common Sense, Rights of Man, and Other Essential Writings*, written by Thomas Paine, in 2003 and the author is, without a doubt, one of the most influential writers in history.

When it was first published in 1776, *Common Sense* was a mere small pamphlet, but it quickly created a sensation, and its incendiary ideas spread like wildfire among the American colonies. The reason this was so was due to the "common language" Paine used, which was immediately and easily understood by not just the intellectuals and highly educated, but by the ordinary people of America as well. It was a blunt challenge to British authority and a call to action to all people in the English colonies of North America, the first work to openly demand independence. This "modest pamphlet" by a man who was not well known at the time, was a match that lit a conflagration that eventually led to independence from the mother empire and the birth of a revolutionary new nation.

Ironically, Paine was a excise tax collector in England in 1774 who lost his job, his marriage and what little possessions he had to pay off his mounting debts. Late that year, to put his troubles behind him, he left England for the colonies of North America, settling in the city of Philadelphia, and immediately dedicated himself to the "Patriot cause" and became the chief writer and editor of the Pennsylvaina Magazine. On January 10, 1776, he published Common Sense, and "the first edition of 1,000 copies sold out within two weeks. By June, reprints raised the total to 150,000 copies; a phenomenal impact for a public of only 2.5 million people, a fifth of them slaves. Many more colonists read excerpts . . . in their local newspapers or heard it read aloud in taverns and on the streets. Except for the Bible, no written work had ever been so widely read and discussed in British America."

But it was the style of Paine's pamphlet more than anything else that made it so widely read among common folks in the colonies. "Previous political pamphleteers wrote in a learned and legalistic style." But not Paine. "No writer has exceeded Paine in ease and familiarity of style; in perspicuity of expression; happiness of elucidation, and in simple and unassuming language," wrote Thomas Jefferson at the time. The quotes Paine used in his work came only from the Bible, "the text widely known and revered by his intended readers." And his primary intended audience were indeed the common folk of the colonies, his message unprecedentedly revolutionary: "He insisted that common people should no longer defer to gentlemen in politics. Aptly titled, *Common Sense* spoke to and for common people." Rarely, if ever, has such a small, seemingly insignificant tract had such impact. Previously, people had revered the British monarch, but Paine excoriated George III as "the royal Brute" who had "blood on his soul" for allowing Royal troops to shoot American colonists. "He relocated sovereignty away from a royal family to the collective people of a new nation" wrote Pulitzer Prize-winning author Alan Taylor, the Thomas Jefferson Professor of History at the University of Virginia, in his book *American Revolutions, A Continental History, 1750–1804*.

Paine's conclusions in his little pamphlet thunder down through the ages, giving us all in later generations a sense of what it was like and what was at stake in those turbulent years of the late 1700s, as a weak and inexperienced people slowly became infected with the desire to break away from one of the most powerful empires in human history.

In his introduction to this edition of *Common Sense*, Sidney Hook wrote: [Paine's] "philosophy inspired two of the greatest revolutions in human history—the American Revolution and the French Revolution. In gratitude both the United States and France bestowed citizenship upon him."

George Washington has often been referred to as "the Father of his Country," but as Mr. Hook says, "If any man is entitled to be called the Father of American Independence, it is Thomas Paine, whose *Common Sense* roused the public opinion of the Colonies to a white heat. Just as important was a series of pamphlets, *The American Crisis*, he wrote to sustain the morale of Washington's army in the darkest days of the conflict. The first of them, written during Washington's retreat before greatly superior forces, galvanized the soldiers, before whom it was read at Washington's orders, into successful resistance and counterattack." Many Americans of our time, early in the 21st century, would find the first lines of this pamphlet familiar, but they are worth repeating, along with other quotes from *Common Sense* and *The Rights of Man*, and a good place to end this review:

"THESE are the times that try men's souls. The summer soldier and the sunshine patriot will, in this crisis, shrink from the service of their country; but he that stands by it now, deserves the love and thanks of man and woman." (*Common Sense*)

"The cause of America is in a great measure the cause of all mankind. . . . The birth-day of a new world is at hand." (*Common Sense*)

"A thousand years hence, those who shall live in America, will look back with contemplative pride on the origins of their government and say, *This was the work of our glorious ancestors!* But what can a monarchical talker say? What has he to exult in? Alas! he has nothing." (*The Rights of Man*)

President Trump: Free Trader or Protectionist? By Tom Mullings

Protectionism is destructionism. —Ronald Reagan

Foreigners are killing us on trade —Donald Trump

I must admit, although I voted for Donald Trump in Florida's presidential primary and agree with him on most issues, his stance on the twelve-nation Trans-Pacific Partnership (TPP) trade deal gave me pause about his candicacy. It did, that is, until I studied both his views on the subject and the pact in greater detail, and came to realize that neither of them represented the make-or-break deal in terms of America's geopolitical position in East Asia that I previously thought they did.

Back then I bought into the notion, championed by many conservative free traders and former President Obama as well, that what was at stake was "whether the U.S. or China writes the rules of global trade." It sure seemed that way when one considers who was included in the Pacific trade pact and who was not. The twelve participating nations include the United States along with Australia, Brunei, Canada, Chile, Japan, Malaysia, Mexico, New Zealand, Peru, Singapore and Vietnam, but excludes China. At the same time, an Asian pact being negotiated by the PRC includes China, but excludes the U.S. Subsequently, I've concluded that these fears were exaggerated, partly after learning that Asian nations have always intended to join both the Pacific trade pact and the regional pact proposal being negotiated by the Chinese.

Nonetheless, the Pacific trade pact does seem to offer something that impacts our security. As Charles Krauthammer has said, "In our deadly serious competition with China for influence in the region, the partnership would anchor our relations with Pacific Rim nations" and a withdrawal from the agreement would signal American retreat from East Asia, the wrong signal to be sending to our friends and allies who count on American engagement and security guarantees. If withdrawing from the TPP resulted in American influence in East Asia being replaced by China's, I would line up against it, but an honest, nuanced appraisal of President Trump's ideas on trade do not reveal a man bent on retreat into a more protectionist Fortress America. At the heart of the President's agenda for international trade is not a disillusionment with "free trade," but rather with "unfair" free trade, which is how he characterizes both the Trans-Pacific Partnership and the North American Free-Trade Agreement (NAFTA), and he has a point. "Many countries want to export to others without restrictions but limit the access to their own markets," writes Richard W. Rahn, a member of the board of the American Council for Capital Formation. As the President points out, Japan does this to some extent and China makes a living at it, enjoying open access to our "technology markets" while closing their mar-



kets to us. "Fair free trade" is what the president favors and most Americans are with him on that, including this one. He also believes that both NAFTA and the TPP were poorly negotiated from the U.S.'s point of view and he has a point there as well. After all, with regard to negotiating deals abroad for our country, who do you think would be better at *The Art of the Deal*—Barak Obama or the 45th President of the United States? It's no contest.

By withdrawing the U.S. from the Trans-Pacific Partnership free trade deal with the stroke of his executive pen, the president fulfilled a campaign promise to his supporters. "We're going to stop the ridiculous trade deals that have taken companies out of our country," he told labor leaders who met with him at the White House. "Companies that left are going to come back to our country, and they're going to hire a lot of people."

What Trump wants is to renegotiate NAFTA and the TPP on a bilateral basis with each country, which would give the U.S. much more flexibility in holding other countries' feet to the fire, with regard to violations, without upsetting the whole apple cart of international free trade. I like this way of doing things and I suspect the American people will as well. Our allies and friends abroad might grumble at the demise of TPP and NAFTA, but they would much prefer to go along with Trump's proposals than turn to the Chinese, whose ideas about free trade are anything but free. British PM Theresa May, in her recent visit here said her country was looking forward to negotiating a bilateral trade deal with the U.S. and that would be a good place to start such a process.

In the final analysis, the growing rust in the "Rust Belt" and loss of manufacturing jobs there was not primarily caused by "free trade" abroad. The lion's share of blame goes to the Democrats' insatiable appetite for ever more restrictive tax and regulatory policy that has stalled the

mighty American economic engine, chased companies out of the country and laid off millions of American workers. Conservatives have long championed "Fair Free Trade" and should continue to do so. But as Mr. Rahn advises, The best thing we can do to bring back those jobs (and entice those companies to return home, I might add) "is to cut the corporate tax rate—which is the highest in the world—and remove excessive regulation." Fair free trade abroad ensconced in flexible bilateral agreements with our friends and partners coupled with sensible and much less restrictive tax and regulatory policy here at home, that is the path upon which our 45th President intends to lead us and I for one think the course he's chosen is a wise one.
