Taxes, Explained

Happy New Year!

Clearly this is the happiest of New Years, not only for Republicans but for all Americans, except those who think a poor country is preferable to a rich one. This historic tax bill is much more President Trump's "Yuge" than Nancy Pelosi's "con job." This essay will sort it out from three perspectives: Economic Growth, Legislative Politics, and Bonus Treats.

Virtually all the near-term economic growth in this bill will come from the lowering of the Corporate Tax rate from 35% to 21%. This is arguably the single most pro-growth legislative tax change in American history. It has been decades in the making. What took so long for something that is so simple and so obvious? It's always billed as "Tax cuts for the rich," no matter how many jobs follow or how much more affordable oil we produce. The economic growth will come over time as money is repatriated (as much as \$2 trillion) and capital budgets are increased for domestic investment. There is no downside to this rate cut. There are those on the left who argue that this is no big deal because average corporate taxes are 24% already. They are either ignorant about the differences between average and marginal tax rates or they think everyone else is. Two trillion dollars sit in Europe because President Obama would not let them return without a 35% "haircut."

But what about doubling the standard deduction and lowering the other six personal income tax brackets? These provisions are what I call the benefits of Legislative Politics. They are not big economic drivers. They are vote drivers. And the first votes they drove were the fence-sitting Republicans in the Senate. The next votes they will drive will be the November 2018 mid-term elections, another good cycle for the Republicans. By then everyone's take home pay will be more and the middle class would have seen some financial benefit. But the 4% GDP growth they're going to see, feel and read about in the Fall of 2018 will be brought to us by the new 21% corporate tax rate, not by the reduction in long form filers from 30% today to under 20% in the future.

Make no mistake about it. There are a bunch of Bonus Treats in this tax package that are almost as powerful as the corporate tax rate cut. Front and center is the end of the Obamacare Individual Mandate. Obamacare was never meant to make Americans healthier. It was always meant to effectively nationalize the one-sixth of our economy referred to as Health Care. And then Obamacare was about transferring massive amounts of money from fiscally healthy families to fiscally challenged citizens and non-

citizens, legal or not. My daughter's family would have to spend \$20,000 (between the premiums and the deductibles) before they could get one dollar of reimbursement. No more. They'll now buy what they want from health insurers who will meet that market. Remember when John McCain kept us from repealing Obamacare? Well, what John McCain took Chuck Schumer gave. Remember when President



Obama and his Democratic Congress locked the Republicans out of the Obamacare conferences? This time Chuck Schumer and the Democrats locked themselves out. Ergo, repeal of the Individual Mandate. Thanks, Chuck.

And another big Bonus Treat is drilling in the Arctic. No Democrats, no drilling opponents. No muss, no fuss. Energy Independence, here we come. And last, but certainly not least, is the cap on state property, sales and income taxes. For high-tax states (think, new York, New Jersey, Connecticut, Illinois and California) this could start a brain drain. For low-tax pro-business states like Florida and Texas, the beat goes on.

So what were the Democrats thinking? They had two thoughts. The first was that the John McCain Republicans would never let this bill pass. The second was, even if the bill passed, tax cuts, repatriated dollars and the gutting of Obamacare would never be popular. You can't make this stuff up. As good as 2017 has been, 2018 is going to be even better.

CRC to offer Voters School Board Reform

The Constitution Revision Commission (CRC) is a group of 37 people appointed to review and recommend changes to the Florida Constitution. Every 20 years the commission is appointed to examine the Florida Constitution, hold public hearings and possibly recommend changes to the Florida Constitution for voter consideration.

The commission began its work in April 2017. It is holding public hearings throughout the state where citizens can attend, share ideas and feedback on potential proposals for the ballot. After gathering public input, the commission will recommend proposals for the November ballot, where 60 percent of the vote will be required to pass.

A much-needed proven effort to reform Florida's school boards by reducing the influence of special interests on career politicians is to limit the terms of school board members. As our Florida "Eight is Enough" rule has greatly improved the quality of the state legislature, it would do the same for school boards.

As testimonial to that effect I witnessed when Governor Jeb Bush invited a group of us who worked on his education voucher project were invited to the mansion to celebrate its successful passage in the legislature. He gathered us around him and thanked us for our support and concluded with "we couldn't have succeeded without the term-limited legislature." The entrenched politicians and their supporting lobbies always fought reforms that limited their power.

Proposals by CRC Erika Commissioner Donalds to limit Florida school board members to two four-year terms and to end the election of district superintendents won strong support with 5–1 vote last month from the CRC's Education Committee. Donalds serves on the Collier County School Board and co-founded the Florida Coalition School Board Members, plus other impressive qualifications for her position.

Nick Tomboulides, executive director of U.S. Term Limits, was not surprised by the overwhelming support, "The issue of term limits enjoys wide bi-partisan support with voters," he says, "however, it's less favorable with lobbyists and career politicians. This was made clear when Commissioner Bob Solari expressed his opposition to the measure and the lobbyists gave him a standing ovation!" Tomboulides concluded, "It's refreshing to be working with the CRC which is closer to the citizen legislature model that term limits would ensure if implemented."

Florida State Sen. Gregg Steube of Sarasota is introducing a bill for the 2018 legislative session that began Jan. 9. The goal and language of the bill is nearly identical with that of the CRC proposal and, if approved, would put the term limit Amendment on the November 2018 ballot.

Commissioner Donalds promoted a trio of ideas—the third being elimination of paying salaries to school board

members—to overhaul school district governance.

She called her ideas "best practices," explaining that board members should not be careerists serving for decades, becoming creatures of the institution rather than public servants. The superintendent job is considered more as a profession than a



political post—superintendents need to be viewed as chief executives, with higher qualifications than being registered voters in their districts and having no disqualifying criminal background.

Commissioners generally agreed with the concept that a school board seat should not become a career, while the superintendent job should be one. As state education commissioner Pam Stewart, who sits on the Constitution Revision Commission, put it, the superintendency "is in fact a career and should be treated as such. As much of the politics as can be taken out of it,,, should be taken away from the office."

The pay proposal is not likely to pass, as four commissioners oppose it. Donalds called Florida an extreme outlier in providing salaries to board members, whose posts are volunteer in most other states.

The school board remains one of few areas in Florida government where there are no state term limits yet, only Duval County has them.

The CRC intends to make a second state tour to get input from voters before taking a final vote.

Other education issues being considered: The CRC also heard lengthy reports on the class size amendment and the use of state funds for religious schools. It has proposals on those issues coming forward in future meetings. Previous quotes on those two potential amendments by our Education Governor Jeb Bush are followed by my opinion:

"We have a Class Size Amendment in our Constitution that has nothing to do with student learning, it was done for a political purpose." The tiny class size amendment is a waste of a lot of money that could be spent on learning.

"Why should we trap kids in schools that aren't working?" In 1999, under his gubernatorial oversight, Florida became the first state where students could get vouchers to attend private and parochial schools.

Busy Week for Politics—Bad Boy Bannon Bites the Dust

In a previous commentary, I predicted that the Alabama GOP loss was the swan song for political gadfly Steve Bannon. He seemed to be victim of his own repeatedly bad judgment. One could not then know that he actually had a more serious propensity for political suicide. However, his participation in the Mike Wolff attack book has shown that his lack of judgment, political loyalty and malignant ego have no bounds.

The problem with Bannon is that he had come to believe that he resided at the pinnacle of political importance. He was the Pied Piper and the puppet master of a nationalistic movement that only he could lead—a movement that was less popular than his imagination would allow him to believe.

Ironically, the very Steve Bannon who the mavens of the media disbelieved and discredited at every turn is now the credible source based only on his book quotes attacking the Trump administration and the Trump family.

Trump blasted his former advisor, but that is not the worst of Bannon's problems. His key financial backer has now had enough of the pompous political operative. His return to his platform publication, Breitbart News, has not stemmed its decline of recent years. His reputation as a political guru is now laid waste by promoting and backing a series of candidates who were worse than just bad. His reputation and influence are as tattered and disheveled as his just-back-from-bivouac appearance.

Bannon may have been the worst of the political baggage Trump took on during the campaign. There were good reasons why he and Michael Flynn were short-lived denizens of the West Wing—and people like Paul Manafort and George Papadopoulos never got past the Pennsylvania Avenue gate. Bannon's only access to the limelight is the never Trump media that will be more than willing to give his damaging rants more airtime than they deserve.

Hatred and Terror Are a Plus on Academic Resumes

In December of 2016, Drexel University Professor and strident Communist (by his own admission) George Ciccariello-Maher gained a bit of national notoriety when he tweeted that "All I Want for Christmas is White Genocide." Following a wave of outrage by alumni and the general public, University officials issued a condemnation of his racist rant and Ciccariello-Maher claimed his obnoxious wish was only satire even though one would be hard-pressed to see

anything satirical in his comment. Also, his satire excuse does not hold water in the face of his own clarification. He wrote, "To clarify: When whites were massacred during the Hattian revolution, that was a good thing."

His Christmas wish was not a one-off sentiment that might be contributed to imbibing a bit too much at the faculty Christmas



party. Ciccariello-Maher also hates the military. During a flight, he posted on Facebook this observation. "Some guy gave up his first-class seat for a uniformed soldier. People are thanking him. I'm trying not to vomit or yell about Mosul." Mosul? Is the professor siding with ISIS against the Iraqi government and the United States who combined forces to rid the city of the Islamic terrorists?

His inbred self-righteous venom appeared again after the October massacre in Las Vegas. Despite the lack of any racial motivation or targeting, the good professor tweeted "It's the White Supremacist Patriarchy, Stupid"—targeting white folks and especially men. He added, "White people and men are told that they are entitled to everything. This is what happens when they don't get what they want." Finally, Drexel had enough and put Ciccariello-Maher "on leave"—meaning, "we are going to give you time to find a new job."

Well ... after a year of criticism from those he describes as "right-wing, white supremacist media outlets and internet mobs" and complaining that Drexel was "bowing to pressure from racist Internet trolls," the unhinged professor announced his long overdue departure from Drexel—from whence he should have been dismissed more than a year earlier

Based on his vile and irrational hatred, it should be nighon impossible for Ciccariello-Maher to find a job at any respectable academic institution. But noooo! Apparently, the repugnant professor has found a home as Visiting Scholar(?) at New York University.

Ciccariello-Maher is as bad as any of the white supremacists he simultaneously condemns and emulates, and far worse than the majority of white Americans he slanders with his baseless broad-brush racist rants. Yet, he is given the cloak of undeserved credibility by the liberal elitist press. His hateful opinions can be found on the editorial

It is impossible to explain why academia gives prominence and prestige to the worst of the left-wing misanthropes, such as Ciccariello-Maher. It brings to mind such people as Bernadette Dorn, whose terrorist activities resulted in the death of a police officer and a prison term after years hiding from the law. The law? Oh, she spent her later years as a law professor at Northwestern University. Her husband, co-conspirator and terrorist bomber Bill Ayes, taught education at the University of Illinois.

Ciccariello-Maher reminds me of something I first penned a long time ago. No one is entirely worthless because they can always serve as a bad example.

Farewell to Legacy

One of the themes of current elitist media narratives is that President Trump is purposely unraveling the legacy of President Obama. Well, duh! If the press had been paying attention, they would have noticed that the people of America have been opposing the leftward drift of the Obama administration since the GOP reclaimed the United States House of Representatives in 2010—a time when Obama himself said on behalf of his fellow Democrats, "we took a shellacking." That spin has come from news anchors, guest journalists and panelists over many programs throughout the broadcast week.

But is Trump wrong? If there has been any bipartisan consistency since the Affordable Care Act was introduced into Congress, it was that the ACA was not economically feasible without the public mandate forcing all those healthy young people to purchase insurance they did not want or face a fine they could not afford. The lack of such a mandate, however, was considered the death knell of Obamacare. Everyone agreed.

While it is true that the Tax Bill did not technically terminate Obamacare, it struck a lethal blow—which is largely being ignored despite the fact that Obamacare will have to be dealt with again in the future. Obama's health plan was crashing even before the public mandate was ended—with even Democrats admitting the ACA had to be "tweaked" if it was to survive With the removal of the mandate, Obamacare is now in political hospice. It is terminally ill—or as Trump put it, "ESSENTIALLY dead."

UN-American

The resolution by the UN condemning the United States' decision to shift the American embassy to Jerusalem was meaningless but not surprising. The resolution was purely symbolic, meaning that it has no effect in the real world.

It was not surprising that even many of our allies voted against the U.S. since they all have deep interests in the Middle East and do not wish to upset the Arab leadership in the area—which understandably is unhappy with the decision.

Since the resolution ripped the scab off an old wound—the fact that America pays too much and gets too little out of the UN—the U.S. is now starting to reduce our investment in the international alliance and curtail some of our more excessive foreign aid expenditures with various individual nations. That is not necessarily a bad plan.

failing nation in the world without strategic considerations. That appears to be coming to an end—finally.

But, what about the move of the embassy itself?

Moving on Trump Style

Apart from the political gnashing of teeth, was moving the embassy a good idea? The answer to that is an emphatic "yes!"

The current criticism from the Democrats is their height of hypocrisy. The policy of moving the embassy to Jerusalem has been the bipartisan national policy for decades. The United States Senate had previously voted overwhelmingly to move the embassy. It had the full support of congressional Democrats until a president they do not like decided to actually do what they only intended to promise. That is what they call diplomacy.

It brings reality to the formal position of not only the United States, but to many western nations that follow the liberal practice of establishing a policy and then doing nothing to impose or enforce it. (Think of our red line in Syria, the demand that the Russians withdraw from the Crimea and the no nukes in North Korea.)

What is widely recognized in the world community is that Jerusalem IS the capital of Israel. In fact, it has been the center of the Jewish people throughout history. For too many nations, however, that policy is only lip service—a diplomatic game of virtual reality. Trump's decision also gives meaning to our strong alliance with Israel, something over which the Obama White House cast a shadow of doubt.

Israel's current sovereignty over most of the city is a matter of unquestioned international fact. The only controversial issue is the claim of Palestinians over a portion of the city as part of a two-state solution—should that ever become a real possibility. That debate is not necessarily affected by the U.S. action. While we recognize Jerusalem as the national capital, we are not committed to any specific boundaries, as independent Senator Joe Lieberman points out. It does not prevent a section of the city from becoming a part of a future Palestinian state should such an agreement be reached—but that is a much longer and more complicated discussion.

Yes, there has been a flare-up of international anxiety. That is always the case when there are changes in the status quo. But in the larger and longer sense, the issue of Israel's capital has now been settled. The contretemps of the moment will pass. Other nations will eventually move their embassies to Jerusalem—and I see Guatemala has already announced its intention to follow suit. The enforcement of America's longstanding policy will at least take one of the contentious issues off the table for future negotiations.

Clean Water Is Still A Long Way Off—Maybe Further Than Mars

Back in September 2017, I wrote an article about "Water, Water Everywhere" to sum up a few of my discoveries about what is being done about the toxic algae problem in Florida with a focus on Palm Beach County and Lake Okeechobee. The problems are much bigger than any of us expect.

The effects of toxins in water on human health, especially brain health, are being studied around the world. The problems are complex, but we can study it and find how to reduce the damage and deaths.

What brings this subject to my mind to share with you is my personal knowledge and involvement in brain health issues. It is hard to grasp the enormity of the science involved, but we do have the means to unravel some of these biological secrets if we keep studying the problems. A little simplified and condensed history about smoking tobacco might help.

Seventy years ago before I was a teenager, cigarettes, cigars and chewing tobacco were commonplace. When I was in my thirties, my father died of a heart attack. He smoked 5 or more cigars a day sometimes. That probably led to his death at age 60. Next I learned that the husband of one of my mother's cousins died of throat cancer at about age 50; he was a smoker and chewed tobacco. Next one of my grandfathers died of emphysema at about 78. In those days tobacco was king and it was lightly regulated. Then came the science.

I remember learning about Dr. Bruce Ames, a scientist in California, who was one of the pioneers in developing laboratory tests to determine the "hits" on mice and rat DNA from being raised in a tobacco smoke rich environment. A "hit" is when it could be determined that the DNA was reconfigured because of something the animal had breathed or eaten. As time when on these tests became more accurate. When DNA is modified, it can cause cancer to develop.

In the past 20 years, we learned that nicotine, in tobacco, was also addicting and the growers and sellers knew this before the public did. Tobacco is now regulated by laws and regulations administered by the Food and Drug Administration. But people still smoke and chew, though not as much.

On television today we are inundated with commercials selling prescription drugs that extoll the virtues of the drugs and ask you to ask your doctor. The idea of drug science is becoming a second nature to a new generation of TV watchers.

Everyone who keeps up with the news for the past 30 years knows that the Environmental Protection Agency (EPA) has expanded its authority so much that President Trump's election was supported by many to rein in the broad grabbing of authority by EPA. This was a problem the Congress caused in many ways.

Before retiring to Florida 14 years ago, I was a supporter of the Chesapeake Bay Foundation for many years. It has

done some good work in the states that have the water sheds that flow into the bay. The CBF Winter 2017 magazine just came and Will Baker, the CBF President, described the problems being done by the chemical pesticide, chlorpyrifos, "which is acutely toxic to Bay life and has been found to cause brain damage in children." Baker quotes Fernando Stein, the President of the American Academy of Pediatrics, writing in the NY Times, "This chemical is unambiguously dangerous and should be banned from use." Baker quotes other people familiar with the chemical. Then he proposes support for two bills in Congress, S.B. 1624—The Protect Children, Farmers, and Farmworkers from Nerve Agent Pesticides Act of 2017 and H. R. 4420—The Chesapeake Bay Farm Bill Enhancements Act of 2017 which also supports multi-state water quality challenges. Senate cosponsors are all Democrats. House cosponsors include a couple or Republicans from bay districts.

Now we move on to what the 11th Circuit Court of Appeals wrote back in June of 2017 about Florida's water. The 11th Circuit is an intermediary court between the local U.S. District Court and the Supreme Court of the U.S.

The Court was a three-judge panel of Circuit Judges Tjoflat and Rosenbaum, plus Hon. Jane A. Restani, U.S. Court of International Trade sitting by designation. Judge Rosenbaum wrote the 52-page opinion. The opinion began by reviewing background issues. Notice how three judges described the "algae blooms."

"Plaintiff-Appellants Florida Wildlife Federation, Inc., Environmental Confederation of Southwest Florida, Inc., and Conservancy of Southwest Florida, Inc. (collectively, "Conservationists"), complained about serious environmental problems in this channel and the surrounding areas where Lake Okeechobee's waters flow. They asserted that decisions by Defendant-Appellee U.S. Army Corps of Engineers (the "Corps") about when and how to release water from certain locks along the Waterway violate the Clean Water Act and Florida law because they negatively affect the quality of the waters the Corps regulates. In response, the Corps invoked sovereign immunity, and the district court dismissed the Conservationists' complaint on that basis. The Conservationists now appeal.

But they aren't the only ones. The South Florida Water Management District (the "Water District"), an agency of the State of Florida, also appeals the judgment. It does so, though, on the basis that the district court first should have decided whether the Conservationists failed to join the Water District as an indispensable party under Federal Rule of Civil Procedure 19(b)."

"To the Conservationists, this case is about the quality of water and the ecological conditions along the Waterway. To the Corps, it is about federal regulation of navigation through the Waterway. And to the Florida Department of Environmental Protection ("DEP") and the Water District, the case is about protecting any authority the state might have over the waters at the center of this controversy. So resolving this case requires us to consider complex and overlapping interests. Because understanding these interests is critical to finding the right answer here, we review relevant background information below about Florida's water geography, Florida's water-ecology issues, the roles that the federal and state entities play in regulating the waters at issue in this case, and federal and state law concerning water quality."

* * *

"B. Florida's Ecological Water Issues

Florida suffers from a Goldilocks problem when it comes to water in the Waterway: too much or too little results in serious consequences. The waters in the Waterway are healthiest and most useful when they fall within a range that is just right. In this lawsuit, the Conservationists complain about only the problems that arise as a result of low water in the Caloosahatchee River, a condition they attribute in part to the Corps's management of S-77, S-78, and S-79 under its 2008 regulation schedule. See generally U.S. Army Corps of Eng'rs, Jacksonville Dist., Cent. & S. Fla. Project: Water Control Plan for Lake Okeechobee & Everglades Agric. Area (2008) ("2008 LORS").

Low water levels can have adverse effects on navigation, water supply, and fish and wildlife in the area. Among other negative effects, low water levels can aggravate ecological conditions in the Caloosahatchee and St. Lucie Estuaries by causing too high a level of salinity and saltwater encroachment into the freshwaters of the Waterway. But the Conservationists draw special attention to another serious problem associated with lower water levels: the emergence of algal blooms. Often characterized by the bright-green appearance of the water in which they are occurring, algal blooms represent a serious environmental problem because they consume an excessive amount of oxygen from the water when the constituent cells die. The remaining levels of oxygen may be too low to sustain aquatic life, which can die off as a result. Algal blooms also can result in taste and odor problems with drinking water, contribute to the formation of carcinogenic substances in drinking water when it undergoes chlorination, and produce toxins that are not removed by the treatment process. Algal-bloom toxins, in turn, can cause liver and neurological disease in animals and humans who drink or come into contact with the water. They can induce skin irritations, kill fish and other animals, and seriously impair the recreational value of the body of water. And eating fish taken from waters during algal blooms is dangerous. Algal blooms have happened in the

Caloosahatchee River eight of the eleven years between 2001 and 2012. In 2011, eight weeks of algal blooms proliferated." [emphasis added.]

The remainder of the opinion and specially concurring opinion by Judge Tjoflat dealt with the procedural position for dismissing under Rule 19 or the claim of sovereign immunity. Rule 19 was selected as the primary reason for dismissing the case. No ruling was made on the operational procedures for the locks or the dangerousness of the algae blooms, but the court explained what it understood of the science that was put before them during the case.

Conference on the Middle East in 2017

I attended a conference on the Middle East in Boca Raton on November 17, 2017, and it was most enlightening. The talk was given my Mr. Moty Ruham, who is Chief of Staff for the Israeli Vice Prime Minister, Silvan Shalom. What follows is his view of the present situation in the Middle East, which, happily, seems to bode well for Israel's future and gives some interesting facts about the changing nature of what is happening there:

- The situation between Hamas and Fatah. Egypt has attempted to force a reconciliation between these governing bodies in order to show President Trump that all goes through them, but actually the sides signed a paper in which Fatah and President Abas rely on Saudi Arabia and Hamas relies on Iran.
- The situation with ISIS. Despite the demise of Islamic State, ISIS has effectively smashed away all the borders in Iraq, Iran, Turkey, Syria, Saudi Arabia and Egypt, and its message will never disappear as an idea. Although in decline, the land they control in the Middle East is still double the size of the state of Israel.
- The situation in Egypt. ISIS attacks the Egyptian army day by day, especially in the Sinai Desert region of the country. Soldiers join the army just to secure enough food and water for themselves and their families. Without heavy government subsidies and rationing of electricity and water in Cairo, the city would collapse. Egypt's GDP is \$2,500 per capita as compared to Israel's \$40,000.
- Sunnis and Shiites. They've been in conflict with each other for 1,300 years. Sunnis represent 85% of Islam. The Shia, which is regarded as a cult, represents only 12% of Islam. Sunnis dominate Egypt, Saudi Arabia and Hamas in the Gaza Strip. The Shia are dominant in Iran, Hezbolla in Lebanon and Assad's Syria.
- The situation in Syria. Assad is running out of soldiers for his army and only one in 17 Syrians supports his Allawite Regime. His army has only 25,000 soldiers today and is being propped up by thousands of fighters from outside the country like Iran and Russia. 2.5 million refugees fled the country, going to Jordan and Europe and the brutal conflict has left 75% of Syria lawless and uncivilized.
- The situation in Bahrain. 1.5 million with Shia majority, but Sunni regime that controls the country is likely to be stroked by Iran.
- The situation in Qatar. 2.3 million people are mostly Sunni, but support Iran against Saudi Arabia. America has its largest air base in the region there, from which it attacks ISIS.
- The Iran Nuclear Deal. It's all about the money! At least from France's perspective, who did a \$55 billion energy deal with the Ayatollahs. Effective sanctions are possible that would cut off much needed funds to the clerics and prevent the Iranians from paying for weapons from abroad.
- Situation in The Iran Saudi Arabia war which has begun.
 Iran has an old army and virtually no air force. The target of its missile forces is to ultimately bring down the

- Saudi Regime. Saudi Air Force is attacking targets in Yemen on a daily basis. Saudi Arabia has done a huge weapons deal with America, of which Israel approved, their view of such deals with the Kingdom having dramatically changed as of late. Today their exists a much closer relationship between the Jewish State and the Saudi monarchy that borders on a de facto alliance.
- Who wins from Iran Saudi war? Mr. Ruham's view is that
 the U.S. will not go to war with Iran, instead cooperating
 with Kurds, Saudi Arabia and others to stop Iran from
 dominating the Middle East. Fascinatingly, with fear of
 Iran growing to unprecedented levels, former enemies of
 Israel such as Egypt, Saudi Arabia and Jordan are no
 longer concerned about growing Israeli economic might.
- The situation in Europe. What's happening there is most troubling. Muslim immigration to the continent has only just begun and will be in the millions! Europe is governed by weak utopian thinking left-wing governments, whose main policies are dominated by out-of-control social and welfare spending which is very attractive to many refugees who don't speak the language of their host countries and have limited skills.
- Conclusions. Some interesting stats provided here by Mr. Ruham that raises eyebrows and reveals some surprises. For example, in Europe the birthrate of Muslims is going up while in Israel their numbers are doing down. 15% of the France's population is now Muslim and that number is increasing. In Austria 10% of the population is Muslim (8 million). Ten percent (10 million) of the population of Sweden is Muslim also and each year 50,000 Swedish leave the country for Canada, the United States and Australia. When Jews emigrate around the world they only go to Israel. The European birthrate is 1.5. The Muslim birthrate is in steep decline (because of despair over the kind of life their leaders have given them) in the Gaza Strip and the West Bank, while the Jewish population in Israel is increasing at one of the highest rates in the world.
- Obama focused on the Palestinians being the main issue and key to bringing about peace between Israelis and Arabs, but today all recognize that the Israeli/Palestinian conflict is not the main issue in the region.
- Consequently Israel, for the most part, is on the sidelines and is not interferring in the Middle East conflict.
- The conflict in the region today is, in essence, a collapse
 of the old states established in colonial times which has
 been replaced by the rise of the tribes. This conflict is
 essentially without borders and we are only in year eight
 of this war, which will probably last 50 years or more.
- The discovery and exploitation of oil lifted up the Arab world and dramatically increased their power, and now oil (fracking revolution) has collapsed the Arab world and just as dramatically lessened their power.
- The technology gap between Israel and the Arab world is continuing to grow day by day.
- The situation for Israel today in the Middle East and prospects for its future is the best it has ever been in its history.



The JCRC Meeting with "The Professor and the Student"


Dear Friends,

On the evening of January 9th, the Judeo-Christian Republican Club with its usual packed meeting welcomed as its guest speakers Dr. Irving Berkowitz, a professor and dean at a local college and Michael Furnari a Boca resident and currently a freshman at a top NY state university. The professor discussed the history of Communism in Russia and its disastrous effects on the world for 100 years. 

HB 7069 Case Hits a Bump in the Road

November 19, 2017 in the Florida Supreme Court over the passage of HB 7069 by the legislature. The Boards asked for issuance of Writs of Quo Warranto and Writs of Mandamus so that the legislature and state officials are required to adhere to the School Boards' interpretation of the Florida Constitution. The papers filed total 715 pages.

The Florida Supreme Court looked at the case, CASE NO.: SC17-1996, and on December 19, 2017, transferred the case to the Leon County Circuit Court. The Supreme Court also ruled in a four-to-three decision that it would not entertain a rehearing, and that the Leon Circuit Court should

rule on all issues. LABARGA, C.J., and CANADY, POL-STON, and LAWSON, JJ., concur. PARIENTE, LEWIS, and QUINCE, JJ., would request responses.

The Palm Beach County School Board issued a notice on August 25, 2017 that it would file a separate suit because joining the other counties' case would make it easier for the state officials to defend themselves. However, it is believed that the Palm Beach County School Board is waiting to see what happens.

Book Review

Being There: Why Prioritizing Motherhood in the First Three Years Matters. By Erica Komisar, LCSW. New York: Penguin Random House, 2017. Hardcover, 271 pp.

I like the quotes from the front of this book. They say much about what's inside. Try them on and see if you like them too:



The author of *Being There*, Erica Komisar, is eminently qualified to speak out on the subject of her book, being a clinical social worker, psychoanalyst, and parent guidance expert. She's a graduate of Georgetown and Columbia Universities and the New York Freudian Society. According to her bio she's "psychological consultant bringing parenting and work/life workshops to clinics, schools, corporations, and children settings including the Garden House School, Goldman Sachs, Shearman & Sterling, and the Stephen Wise Free Synagogue Early Childhood Center." In the way of qualifications, Mrs. Komisar also has three teenage children of her own.

I spent an inordinate amount of time delving into Mrs. Komisar's qualifications because of the vital subject of her book—our children's upbringing, particularly the first three years of that upbringing. It is her contention that a mother's desire to satisfy her children's physical and emotional needs declines in intensity as they grow older and is most needed early on in their lives.

Conservatives, I suspect, will like this book. Like I said, the author contends that a mother's presence is most required in the first three years of a child's life and the lack of doing so on the part many American mothers these days is responsible for what she believes to be a "dramatic increase in emotional, social, and behavioral difficulties like Attention-Deficit/Hyperactivity Disorder (ADHD), anxiety, depression, and increased aggression in children from tod-dlerhood through adolescence." She cites troubling statistics to support her claims that America is failing its kids. "According to the Centers for Disease Control and Prevention (CDC), 11 percent of children between the ages of four and 17 years have been diagnosed with ADHD," an increase of 16 percent in the last 10 years. "Two-thirds of those children have been treated with stimulant medications like

Ritalin and Adderall, which have significant side effects." As a result "11 percent of [children] over the age of 12 now take antidepressants. There has also been a dramatic increase in eating disorders and "hospitalizations of children twelve years and under for eating disorders have increased 119 percent in the last decade." Violence among the nation's young has also risen significantly in recent years.



Mrs. Komisar believes that the reason for these disturbing trends in America as of late are the result of working mothers putting their careers and their own personal needs ahead of their children's needs, especially in the first three years of their lives when they are the most vulnerable.

I believe it took a great deal of courage for the author to write and publish this, and here's why. According to Mrs. Komisar [and I strongly suspect that she is correct] "Clinicians are reluctant to make direct correlations publicly between an emotionally disengaged or physically absent mother and a child's personality, social functioning, and even mental illness, but it is what [she and her colleagues] discuss as clinicians among themselves. A growing body of evidence from neuroscience and hormonal, attachment, and epigenetic research supports the link that [they've] seen in [their] clinical practices."

In my humble opinion the author makes a convincing case for her contention that our innocent children need their mothers perhaps more than many Americans believe today, and along the way she points out some obvious truths. For example, she says that "before age one your baby's cries should always be assumed to be caused by need or fear, but after age one, children may cry for many reasons, including frustration and anger."

I thought *Being There* was a most valuable book and well worth reading, giving one expert's enlightened opinion on the price we've paid in the Post WW II era of the "working mom" of subcontracting the care and upbringing of our children to people other than their mothers. Had you told me when I started reading this book that I would end my review of it with a quote from the Rev. Jesse Jackson, I would have not thought it was possible, but here goes. As the reverend once said and Mrs. Komisar strongly contends, "Your children need your presence more than your presents." Read her book and see if you agree.

Book Review

What Do We Really Know About The Bill of Rights? James Madison and the Struggle for the Bill of Rights. By Richard Lubinsky. Oxford University Press, 2006, ISBN: 13: 978-0-19-518105-0 and ISBN: 10: 0-19-518105-0.

The above titled book was published in 2006, so you are already ten years behind if you have not read it. But if you get it now, it will be worth your while if you cherish the Bill of Rights like I do. From the opening page to end of the Epilogue there are 264 pages packed with details about James Madison's work on the Constitutional Convention and the ratification in Virginia and other states, plus the election of Madison to the First U. S. Congress and his more than two year effort to pass the Bill of Rights.

Remember that the Continental Congress was meeting in New York City for several years during the Revolutionary War. James Madison was from Orange County, Virginia, a several day trip to New York and a trip that Madison dreaded because of his long-time illness that comes to light in this book. Madison had a gastrointestinal problem that frequently caused diarrhea and other discomforts that were embarrassing to him during long trips on a stage coach or other conveyance with a couple of other people. For me this was the first glimpse of the personal fortitude that Madison had in dealing with his personal health problems while he was the instigator and daily shepherd of the assembly of the Constitutional Convention, the adoption, the ratification, and the struggle to adopt a Bill of Rights.

The advance praise for the book comes from James Madison organizations and individual historians like Garry Wills, Philip Bigler, Charles F. Bryan, Jr. and David B. Mattern on the book cover. I am confident that if you read this book it will open your eyes to the divergence of views about adopting the Constitution in the first place to the switch by Madison from opposing a Bill of Rights to being the only real champion of adopting the Bill of Rights. This took Madison over two years of meticulous letter writing and personally speaking to hundreds of people.

You will learn that Madison was not a dynamic speaker like Patrick Henry. Madison was a soft voice of reason who preferred to work behind the scenes, but if called upon to address a legislative body, he could hold his own with detail after detail. Madison was particularly good in legislative committees where a few people often recognized his intelligence and deferred to his solutions for the problems under discussion.

The beginning of the book was somewhat dull to me, but essential to understand what was happening during the constitutional developments. I began making notes at page 174 when Madison's election to the first U.S. Congress was described. Madison detested having to give up his work with the Continental Congress in New York and come home to Virginia to run for office to the House of Representatives.

He did not like to ask for votes or do things like make promises. He thought everyone should know what he stood for and accept him for those characteristics.

There were secret political goings-on that prevented Madison from being nominated for the U.S. Senate from Virginia. Some people tried to get Madison to run for Congress in a district where he did not live because those people want him to represent them. Patrick Henry, a former governor of Virginia and an ardent Anti-Federalist, had succeeded in designing districts for the ten Virginia House seats (Virginia was the largest state in the Confederation at the time. Remember it included today's West Virginia and Kentucky) that would place Madison in a district that Henry thought Madison could not win. Henry was against the adoption of the new Constitution because he thought that the document took too many powers away from the individual countries, such as Virginia. This is the first book that I have read that shows the people of the time flat-out described the states as "countries" and it is obvious to me now that all of the thirteen colonies thought of themselves as individual countries at that time.

But finally Madison was persuaded to come home four or five weeks before the election to campaign in ten inches of snow in the hills and hollers of Virginia. Madison managed to show up in county seat after county seat and talk to the people. Madison was frost bit a little during his travels in the counties of Orange, Louisa, Culpepper, and others, but he won the election over his friend, James Monroe, another individual who needs to be explored more by serious constitutional learners and scholars. Only 44% of the eligible voters came out in Madison's district that first Virginia election, and in his district Madison was the victor.

Madison and Monroe were so close that they invested in land together and invited Thomas Jefferson to join them in a venture at one time. Madison made more money in land, perhaps, than he did from Congress or his estate at Montpelier. This was another interesting discovery in the book.

In that first election the Sheriffs of each county took down the voters' preferences orally and made a record. Because of the bad weather, some Sheriffs took votes for three days because it took some hearty souls that long to get to the county seat to vote at considerable risk.

Think of this and contrast it with how easy it is to vote in the 21st Century. We are now coddled, one might say, with our voting machines and fraud prevention systems that sometimes allows double voting, false registrations, and other devious election irregularities.

Another item that piqued my interest was the beginning of Chapter 8 where it is disclosed that New Yorkers wanted to make that city the permanent capital of the United States. I live in Florida in a district where most of the voters are from a single ethnic group who used to live in New York,

mostly New York City. My neighbors are democrats and I am a republican, so this struck me as especially interesting. Also my family and I lived in the Philadelphia area for five years during which time I accompanied my three boys and other Cub Scouts to the Independence Hall in Philadelphia where the Declaration of Independence was debated and signed on several occasions. The place still has the ability to produce memories and dreams of the 1770s.

Here is some detail about this time period that I learned from the book that will give you a good example of Labunski's writing style:

Even the state's Anti-Federalists, many of whom had wanted to prevent ratification at the New York convention in July 1788, agreed to approve the Constitution only because Federalists had strongly hinted that the city would likely become the permanent seat of government. Anti-Federalists knew that if New York did not join the union, its largest city would have no chance of hosting the new government.

New York officials worried with good reason, that Philadelphia would persuade lawmakers to return to that city, which was the home of the First Continental Congress in 1774 and where the Confederation Congress had met for nine years. Representative John Page of Virginia said that New York 'is not so half as large as Philadelphia; nor in any manner to be compared to it for Beauty & Elegance.' Benjamin Rush, a prominent Philadelphia physician, who wrote a long letter to John Adams in early spring to remind him of his home city's many amenities and virtues, including 'Philadelphia is the centre of the State of the Union: she is wholly & highly Federal.' Another Pennsylvanian Timothy Pickering, said that 'In Philadelphia, the Congress will find convenient lodgings & public buildings—provisions good, elegant, plenty & cheap—& the most extensive libraries adapted to the use of public bodies, that are to be found on the Continent.' Those libraries appealed to John Adams, who as vice president would be expected to be involved in the selection of a permanent capital. He told Benjamin Rush that "I love Philadelphia quite as well as New York, and the noble Libraries there [in Philadelphia] would be Strong temptation to me." [footnotes omitted.]

Around page 180 I was interested in the reference to Representative Elias Boudinot from New Jersey as he is another founder I have recently studied and written about in regard to his religious beliefs. Boudinot, earlier under the Continental Congress he was the second president of the Congress when the country only had officers of the Congress. We only had three of those presidents as I understand it. Boudinot told his wife in a letter that when they arrived in this "dirty city [New York City]"—"The difference of the wholesome Country Air, from the Stench of the filthy Streets was so apparent, as to effect our smelling Faculties greatly." My own visits to New York City from the 1960s to present day did not exhibit what Boudinot found upon his arrival, so the years have allowed New Yorkers to make appropriate improvements.

I cite Boudinot for another reason at page 220 of Lubanski's book where it is disclosed that Elias Boudinot was the chairman of the House Committee of the Whole when Madison was introducing the Bill of Rights in August. Someone raised the issue of whether the committee of the whole had to recommend the Amendments to the full House by a two-thirds vote. "The chairman, Elias Boudinot of New Jersey, ruled that a simple majority was sufficient, and his decision was upheld by a vote of the members." [Footnotes omitted.]

This book covers the complicated story of the adoption of the Bill of Rights from 40 or more amendments to the twelve submitted to the states by President Washington to the final ten amendments ratified and adopted as additions to the Constitution. There were complications throughout the debates over the amendments as to whether they would be incorporated into the Constitution or appended to the end of the document. We know now that the ten amendments were added to the end and the Supreme Court is still interpreting what the founders meant by each Amendment.

You will not waste your time or money reading this story that can lead you to many other wonderful tales and happenstances about the Bill of Rights. If we let our children graduate from college, perhaps even high school, without knowing what is in this and similar books, we have to accept a degree of blame for letting them down.

Who Will Deliver the Descendants of the Legendary Persian Empire From Tyranny?

In the June, 2011, issue of this Newsletter, I argued that the massive protests that broke out in Iran, and similar protests that eventually spread throughout the Middle East that came to be known as the Arab Spring, presented a golden geopolitical opportunity for the United States that should have been exploited. I further opined that better organized Islamist elements in the Middle East could easily co-opt these uprisings from weaker democratic movements if the U.S. did not take on a more central role in aiding and guarding these budding movements. I also warned that thanks to the Obama Administration's policy of "leading from behind," we faced the specter of a takeover of much of the Middle East by antidemocratic religious fanatics.

Sadly, that is what happened, and thanks largely to American withdrawal from the region, Iranian dominance spread in the area, ISIS was born and established in numerous countries, and a caliphate was declared in conquered parts of Syria and Iraq. Happily, at least some of these developments have been reversed, thanks largely to the Trump Administration, and the murderous obscenity known as Islamic State has been all but eliminated. Still, major progress in Iranian ambitions to be the regional hegemon accomplished during the Obama years thanks to U.S. indifference remain unassailed.

But now a new opportunity to reverse the damage to our strategic interests in the Middle East has emerged in the form of a significant new Arab-Spring-like protest movement in Iran that has taken to the streets in recent days. With friendlier, not to mention wiser people in power in Washington these days, it's fair to ask how can a more willing Trump Administration help Iran's protesters, who seek better economic opportunities for their families and relief from the oppressive theocratic regime in Tehran? "Be quiet," tweeted former Obama senior advisor Susan Rice the other day. That is exactly the policy that was followed by her boss in 2009 that left us with the mess we have today in the region, enabling a greater level of Russian/Iranian influence than has been seen in decades. With American indifference at its nadir during Obama's eight years in office, the clerics in Tehran deployed many thousands of their Islamic Revolutionary Guard Corps and Quds Force operatives in Syria. They've also sent thousands of their surrogate Shiite militias to that brutal civil war, including elements of Hezbollah from Lebanon and some of the 150,000 they've trained and control in Iraq. Tehran tells the outside world that their presence in these countries is necessitated by their need to fight the Islamic State, but that's just a cover story. What they are

really after is "fulfilling a strategic goal of stretching a Red Crescent of domination west from Tehran through Iraq, Syria and Lebanon to Israel's doorstep," with regional Iranian domination and Israel's destruction being their ultimate objectives.

Obama tolerated all this creeping harm to our interests and Israel's in the region in order not to disturb his Iranian



Nuclear Deal which he thought was worth the price. It clearly wasn't. As President Trump has often said, it may very well have been the dumbest international deal the United States has ever negotiated. Although he hasn't nixed the pact, on October 13 he made public that he was "decertifying the Iran nuclear deal and called on Congress to fix it," giving them a deadline of 120 days. But the deal's continued existence has made our European allies most reluctant to confront creeping Iranian regional domination for the same reasons the Obama Administration thought it unwise. Consequently Tehran continues to spread their power in preparation for their future show down with the "little satan," Israel.


How to upset these diabolical plans of the ruthless clerics in Tehran? My take is to support the protesters in the streets of Iran in a meaningful way that will give us a good chance of taking down the regime. "The current uprisings in Iran have so far been relatively limited, although they have been broadly distributed throughout the country [but] have grown in scope," according to Middle East expert Anthony Cordesman at the Center for Strategic and International Studies in Washington. Democrats like former President Obama and Susan Rice believe that protesters in Iran don't "represent fundamental change," but they could if we gave them real support. According to a book I read years ago by Wall Street Journal reporter Jay Solomon, The Iran Wars, the CIA sought Obama's permission to launch a clandestine effort to overthrow the theocratic regime in Iran, and he turned them down. President Trump should give his permission to such an undertaking and go all-out to make it succeed. The ayatollahs are responsible for the death of thousands of Americans since the Iranian revolution in 1979 and they have much to answer for. If we really want to stablize the





Republican Executive Committee Membership Application

The Republican Executive Committee (also known as the REC) is the governing body of the Republican Party of Palm Beach County. The REC elects the Chairman, Vice Chairman, Secretary, and Treasurer of the Party. Members of the REC also approve the Party's constitution; Rules, Policies & Procedures; and budget.

Members of the Republican Executive Committee represent the registered Republicans who live in their precinct. They serve as the Party's liaison to the Republicans in their precinct. REC members are expected to maintain contact with the Republicans living in your precinct and to keep them informed as to what is going on in the Republican Party. This can be done through E-mail or other means like regular mail, phone calls ad walking your precinct. The REC is the basis for our grassroots efforts and we rely on REC Members to organize and develop their precincts, recruit new volunteers, recruit candidates to fill vacancies on the REC, find sign locations for Republican candidates, register new Republican voters and work to get out the Republican vote in their precincts during elections. The role of committeeman or committeewoman is essential to Republican Party's and our candidates' success in Palm Beach County.

REC Committeeman & Committeewoman Duties and Responsibilities

- 1. Expected to donate financially to the Republican Party of Palm Beach County
- 2. Attend REC Meetings
- 3. Organize your precinct and carry out the policies and programs of the Party within your precinct. Active participation in the various programs of the Party is expected.
- 4. Serve on a Party Committee.
- 5. Develop a presence in the broader community by joining a Republican Club; serving on a local board or committee; or monitoring local media for relevant material.
