



For Such a Time As This

Remarks Delivered to the Praise and Worship Gathering at the Summer Meeting of the RNC, Thursday, August 24, 2017

The Bible verse for this time, this period in U.S. history, is:

Esther 4:14

"For if you remain completely silent at this time, relief and deliverance may arise for the Jews from another place, but your and your father's house will perish. YET, WHO KNOWS BUT THAT YOU HAVE COME TO YOUR ROYAL POSITION FOR SUCH A TIME AS THIS?"

The context for this verse—It was learned that there was a plan that the Jews in Persia were going to be annihilated by the Persian King. In this verse, Mordecai is urging Esther, the Queen (who had kept her Jewish heritage hidden), risking death, to approach the King and save God's people, the Jews, from the wrath of the Haman who had the King's ear and had convinced the King to sign a proclamation that all Jews should be killed.

Esther, reluctant at first but showing courage, answered God's call on her life. She fasted, requested prayer and support from her people, and, risking rejection and death, approached the King, eventually undoing the plan hatched by Haman to destroy the Jews. Esther saved her people for that time.

What message does this verse have for us today?

The early settlers of New England viewed themselves as establishing a New Jerusalem. It is from this vision, this view, that the concept of America as "a city on a hill," a "beacon of hope" for the world, took root.

As John Winthrop led the Puritans out of England in the 17th century, on board the ship, he delivered this message:

"The eyes of the world will be upon us. We are as a city upon a hill, raised up. You may think you're in the howling wilderness. You may think we're out beyond the farthest beyond. But in fact, God's providence is such that, as the latter days begin to unfold, this may indeed be the city, THE NEW JERUSALEM, that's unfolding before, not only our eyes, but the eyes of THE WORLD."


These are astounding and prophetic words. John Winthrop did not live to see them fulfilled, but his words became prophesy.

After the establishment of the colonies, some of that vision was lost, as the settlers just tried to survive. But in the decades leading up to the American Revolution, a great spiritual revival took place. "The Great Awakening" historians have called it.

The Great Awakening gives birth to a sense of, not just spiritual freedom, but political freedom.

Something was about to spring forth which the world had never seen. A new young nation in North America is going to show the world the way to the New Jerusalem.

And so, the Declaration of Independence, among other



For the first time in history, a government is established based upon the proposition that our rights come from GOD . . . not from a Pharaoh, a King, a monarch, a dictator, or any form of government. And what GOD endows, no man can take away. So, for the first time in history, a government is constructed to **protect** God-given rights, not to dispense them.

This was indeed revolutionary.

As the song "America, the Beautiful" says, "America, America, God shed His grace on thee." I believe God honored that. America prospered in the 19th century beyond what those early settlers ever could have imagined.

Kennedy in 1963, the race riots between 1965 and 1970, the anti-war riots during the same period, the assassination of Robert Kennedy, the assassination of Martin Luther King, the attempted assassination of George Wallace, (though his life was spared, he was rendered paralyzed from the waist down), the crazy 1968 Democrat National Convention in Chicago, the Watergate scandal and the attempted impeachment and resignation of Richard Nixon in August of 1974. Those years changed and scarred this nation forever.

In 1980, Ronald Reagan was elected and brought forth a new revival of the American spirit. Regan revived the talk

Bitcoin

It's break time. Time to take a breather from Russia, FISA, the NRA, DACA and taxes and look at the lighter side of life: Bitcoin. Everyone has heard about Bitcoin. We've seen the wild price swings. We've read about fortunes made, lost, and made again in relatively short time periods. We harken back to the dot.com mania and see Bitcoin as an opportunity to make the money now that we should have made then. If only it were that easy.

So here goes. My own excursion into the world of crypto-currencies began about two years ago. A friend asked what I knew about Bitcoin and I honestly answered: "Nothing." So I bought a book. And two hundred pages later I went back to my friend and said: "I read a book and I still don't understand a thing about Bitcoin." I tell you this not so you can feel intellectually superior to me, but so you can respect the difficulty of the Bitcoin dynamic and proceed with utmost caution. As the Bitcoin noise got louder I paid more attention. Eventually I gained a small understanding and a unique perspective. And that's what I'm about to share with you.

First, the small understanding: Crypto-currencies, of which Bitcoin is just one of many, fall into a technology called Blockchain. All crypto-currencies fall into the Blockchain technology but not all Blockchain technologies involve crypto-currencies. Blockchain technology involves decentralized ledgers. Our lives revolve around centralized ledgers. I wish I could easily explain the difference. I can't. The centralized ledgers we live with mean that our information, like medical records or credit card transactions, are kept in somebody's really large computer. A decentralized ledger is dynamic. It means that as more data or transactions are gained the ledger expands at the location of the new data. I told you I couldn't explain this easily. This expansion is in the form of Blockchains, hence a new technology.

That is why you hear that the Bitcoin universe is both growing and capped. Of course, as a non-government-issued currency, Bitcoin is very different from our green-backs. Bitcoin is private in ways that we are not used to. They're not only private but they're effectively secret. You can only access your own Bitcoin account through your own personal "key" (or password). Forget the key, lose your Bitcoin account. Scared yet?

So why does the world need crypto-currencies? Aren't dollars, euros and yuans enough? Here's my answer. The world GDP is \$77 trillion. And I would guess that the national (fiat) currencies are good enough (if you don't live in Venezuela). But that's because you're good guys. But

what if you were a bad guy? I have no idea of the world Fraudulent GDP. But I guess it's in the fourteen digit range, upwards of \$10,000,000,000,000. What's in it? How about drugs, human trafficking, illegal anti-sanction sales or tax avoidance. Also, how about your neighbors' use of cash-only illegals to cut his lawn or cash-only citizens to do odd job or housekeeping tasks? It adds up. All of these people



might consider a "private" currency that no other person, financial institution or government could access or audit? I can see the wheels churning from here. Remember the old numbered Swiss bank accounts. Eventually the governments opened them up. Bitcoin? Not so easy.

So what to do? In or out? If you're in, is it off the high board or just dipping a toe in the kiddie pool? I bought a Bitcoin/Blockchain related security. I read. I Googled. I thought. And then I said "buy." Now I'm somewhat underwater. It's your turn. But I'm not an investment adviser. If you want to get in you must do your own research, make your own trades and assume your own risk. Just don't bet the ranch.

So what's the moral of this story? The moral is that you have a choice. You can enable global fraudsters by supporting the crypto-currency prices with your trades. Or you can invest in new technology with the hope that it plays a positive role in raising the global standard of living, and makes you a few bucks along the way. Your move.

Talking Points: A (Partial) Look at the Tricks of the Biased News

Will the media ever realize its own bias?

As a regular viewer of all the news outlets, I am reminded of an old saying that, "I am only misinformed because I read newspapers." This suggests that new credibility, or lack of credibility, is not fundamentally a new issue. I usually write critically about the Big Seven (ABC, CBS, NBC, CNN, MSNBC the *New York Times* and the *Washington Post*) because I believe they are in the vanguard of misinformation. In terms of President Trump, Republicans and conservatives, the Big Seven are not functioning as news journalists but as prosecutors in the court of public opinion.

The hours upon hours of so-called news coverage is crafted to advance a one-sided case to achieve a specific goal. In a real court, the goal of the prosecutor is to convince the jury that the plaintiff is guilty and should be put away. In the court of public opinion, the goal of the prosecutorial press is to convince the public (jury) that the plaintiffs (Trump, the GOP and conservatives) are guilty and should be defeated in the next election.

The Big Seven and others have abandoned their role as journalists, to become part of the Democratic Party's liberal strategy to rule over America. That is a perfectly appropriate ambition for the Democratic Party. It is not the proper role of the press. When members of the press proclaim their importance in a free society, they are alluding to a fair, ethical and fact-based news media.

Because a free press is critical to a free society, when the news media become a vehicle of partisan propaganda the damage to the Republic is significant—and that is what we are seeing in America today. Individual news outlets have always leaned to the right or the left, but this was mostly restricted to editorials and columnists—the opinion side of the press. The news side was to tell the story objectively, covering the five basic questions that were once the backbone of reporting—who, what, when, where and how. The "why" question was left to the editorial pages.

Let us take a closer look at the corruption of the media in terms of specifics.

The supremacy of the "why" question

The Big Seven have made the "why" more important than the who, what, when, where and how. A few moments of the latter produce hours of the former. It is most egregious when it comes to CNN and especially MSNBC. I omit FOX News and One American News from this criticism because they can be empirically shown to produce more actual news content. FOX, like CNN and MSNBC, does employ panelists and contributors but is much more likely to present legitimate opposing views. AON provides straightforward hard news during its newscasts, and restricts their conservative opinions to personality programs—the equivalence of newspaper columnists.

I date the beginning of the corruption of news to the 1960s, when the radical left began infusing news stories

with partisan spin. As is often the case when the left corrupts an institution, they first deny the corruption, but once it becomes too obvious to deny, they invent a nice sounding term. (Moving student up from grade to grade without meeting educational standards became "social promotion," giving special benefits to people became "entitlements" and balancing budgets by declar-



ing large expenditures to be "off budget Items.") In the case of journalism, the euphemism became known as "advocacy journalism."

The concept of advocacy journalism was made even more corrupting by the fact that the profession of journalism became very one-sided politically and philosophically. This has been because the nation's journalism schools teach to the far left-ergo left-wing advocacy. Two other factors exacerbate news corruption—the concentration of the most powerful news outlets in a very small culturally liberal community—the east coast generally and New York/Washington, D.C. specifically—and the introduction of so-called cable news, which provides a 24-hour ability to offer up news and opinion. The problem is that opinion dominates what was once thought of as news. Despite their generic title, CNN and MSNBC are not news channels. CNN's motto, "the most trusted name in news" is factually wrong. MSNBC leaves open the reply to the view with "this is who we are" as a motto. Even I could agree with that motto, they may not agree with my personal definition of who they are.

The Media Bubble

There are two news practices that demonstrate just how narrowly focused the news business is—one general and one more specific. The first is the tendency of news media to interview each other. One might expect news reporters to dominate the real news—those 4 Ws and an H—but intra-profession personalities now dominate the opinion side and they represent most of the interviewees.

As if cable opinion personalities misrepresenting themselves as news providers and using journalism colleagues of like mind as panelists and interviewees, is not bad enough, the folks who play those roles come from a very exclusive media cabal. CNN and MSNBC rely mostly on *New York Times* and the *Washington Post*, with occasional interviews with reporters and editors of a few other New York-based liberal publications. It is not uncommon to see representatives of the *Times* and *Post* on the same program—even with multiple representatives of one or the other.

I Know Nothing, but can tell you . . .

The affable German Sergeant Schultz on the old Hogan's Heroes comedy show embedded his emphatic "I know nothing" into the thesaurus of American clichés. The difference between the portly Schultz and the news media is that the good sergeant actually knows something but pretends he does not so he does not have to talk about it. The Big Seven readily admit that they truly do not know the facts, but proceed to analyze their ignorance to support a preconceived narrative.

In terms of the investigation by Special Counsel James Mueller, you will hear those television talking heads confirm that they have no idea what Mueller knows, what he is pursuing and what the results will be. They often claim that they can only wait for the Special Counsel's announcements. But, they do not wait. After every confession of wedo-not-know ignorance (and you can count them as I have), they proceed with hours, days . . . nay . . . months of speculation, conjecture, hypothecating and spin on the very subjects of which . . . they know nothing.

The most flagrant example is the Russian investigation. By intimidation and direct accusation, the press has maintained a narrative that President Trump and others colluded with the Russians to win the election. Whether this is true or not is yet to be determined, but the facts to date have not supported that ongoing narrative emanating from the elitist eastern press.

Opinion as Facts

Since the known facts to now support the opinion, the media elevates their opinion to the level of fact. One means by which they turn fact into opinion is by reporting the opinions of others as a fact. President Trump Example: Some unnamed source said that Secretary of State Rex Tillerson called President Trump a moron. Tillerson refused to respond to the question and his communications officer said it was not true. No one actually knows if he did or not. But for the media, such a comment would fit one of the many established anti-Trump narratives. Hence, it is repeatedly delivered as a fact—and one eagerly embraced by the never-Trump people and even believed by many casual observers—and of course, that is the objective of the misrepresentation.

If you pay attention, you will be amazed that the pertinent FACT is nothing more than the fact that someone said it. Think of all those White House conversations that are supposedly leaked. There is rarely ever any hard evidence offered—just the FACT that someone may have told the reporter. In many cases, this fact is not even from someone in the room, but supposedly from someone who heard from someone else who was supposedly in the room. Such facts would be disallowed in a real court. In other words, what is being reported is . . . for lack of a better word . . . gossip.

Unnamed Sources

That brings up the issue of "unnamed sources." This means the person passing along the gossip to the reporter has no fear of being challenged. Over the years, the use of unnamed sources has greatly increased. Back a generation

or two, it was considered improper to use unnamed sources except in the most extreme cases—and even then, there had to be a second credible source.

As unnamed sources became increasing used—often more than named sources—the quality of the sources diminished. Many reports are based on single sources and the credibility greatly diminished—often stretching the source further down the gossip chain.

One-Sided Panels

Journalism ethics are based on fair and balanced reporting. Nowhere do you see the corruption of the media more than in the selection of panelists and contributors—with MSNBC the most egregious. Shows like Morning Joe will feature half a dozen or more panelists sitting around the big table or piped in from distant locations and every one of them will reflect the same biased opinion. In a display of faux credibility, they will feature folks with conservative or Republican pasts who proffer the same biased opinions as the liberal Democrat majority.

Out of Context

The out-of-context quotes have been a violation of journalistic ethics forever, but it is used regularly today to create false impressions that reinforce the preconceived narrative. A recent example involves one of President Trump's statements after the Parkland shooting. In support of the narrative that Trump is braggadocios and boorish, MSNBC and CNN repeatedly reported that Trump had said "I'd run in there even if I didn't have a weapon" . . . period. To drive the narrative home, the panelists discussed his comment in the most negative terms. The late-night show hosts used the reports to mock the President. Those who actually heard the President's statement had quite a different impression. Addressing those in the audience, Trump said, "I really believe I'd run in there even if I didn't have a weapon, and I think all of you would have, too."

The List goes on . . .

This is merely a sampling of the techniques deployed by a corrupted news media. More of the list of shameful abuses will be addressed in some future Part Two commentary—maybe even requiring a Part Three or Four.

Donald J. Trump Got Tired of Winning . . .

Remember when candidate Trump said that we're going to be winning so much with his policies that we'll tire of winning?

As the *Wall Street Journal* put it, Trump made "... the biggest policy blunder of his presidency..." It was to "impose tariffs of 25% on imported steel and 10% on aluminum. This tax increase will punish American workers, invite retaliation that will harm U.S. exports, divide his political coalition at home, anger allies abroad, and undermine his tax and regulatory reforms."

After a year of winning—GDP growth hit 3%, increased manufacturing production, and both business and consumer confidence up smartly—the president, against the best advice of his top economic advisor Gary Cohn and economists Steve Moore, Larry Kudlow, et al., decided to impose the tariffs. That takes care of the winning streak, for sure. Mr. Cohn guided Trump's signature accomplishment, a major revamp of the U.S. tax code and a significant rewrite of the financial rules but couldn't abide the tariffs and resigned.

Treasury Secretary Steven Mnuchin told lawmakers that the administration wasn't looking to get into a trade war. But Trump said, "trade wars aren't so bad." Apparently, Mr. Trump can't stand all this winning. His tariffs will benefit a handful of companies, at least for a while, but they will harm many more.

Frederic Bastiat explained that in the economic sphere an act or a law produces not only one effect, but a series of effects. Of these effects, the first one is immediate—it is seen. The other effects emerge only subsequently.

President Trump has threatened to impose tariffs on steel imports and if he does, jobs will be added in that industry. You see that and say "great!" What you don't see—unless you look—is that everything made of steel goes up in price. We all pay for the relatively few jobs created compared to the cost. Worse, we invite retaliatory tariffs on our exports which cost our economy jobs and further costs to all of us. And in which industries would the money have been spent if not on the higher priced steel?

These tariffs will benefit a few companies, at least for a while, but they will harm many more. Steel-consuming manufacturers that would be harmed by the proposed tariffs employed roughly 6.9 million Americans and the construction industry that uses these metals supported another 10.1 million jobs. That compares to just 140,000 directly employed by the steel industry who might benefit because of the rise in the price of steel.

Simply stated, a tariff is a tax. Tariffs are imposed on foreign competitors to protect certain domestic industries. In the extant case, steel and aluminum. Domestic consumers of the end products are the ones who pay the tax. Competition protects consumers so less competition plus the tax (tariff) causes



higher prices on all the products that use steel and aluminum, and therefore, lowers of our standard of living.

How can the president dictate the new tariffs? Where is Congress on this issue? Absent, as usual—probably too busy running for reelection. Article 1, Section 8 of the United States Constitution states that "... Congress shall have power . . . to regulate Commerce with foreign nations." Congress has delegated its authority on trade to the executive branch.

For example, the Department of Commerce released a report on the effects of steel imports on U.S. national security with recommendations to restrict imports of steel products under Section 232 of the Trade Expansion Act of 1962.

Tori Whiting, trade economist at the Heritage Foundation, is skeptical. "The current Section 232 investigation has shed light on the flaws of the law and the plain lack of congressional oversight during the investigation process. Section 232 does not define 'national security,' leaving the term up for interpretation by bureaucrats at the Department of Commerce. The law also does not require a cost-benefit analysis of recommended tariffs or non-tariff barriers, allowing the Department to ignore industries or consumers that could be harmed by the trade restrictions. Restricting steel imports under the guise of protecting U.S. national security is not warranted in this case."

Commerce Secretary Wilbur Ross, a billionaire, made a fortune in 2002 by buying bankrupt steel companies on the same day the Bush administration imposed tariffs on steel imports. Ross and U.S. Trade Representative Robert Lighthizer are committed protectionists and staunch supporters of tariffs in the Trump administration.

The U.S. has trade pacts with 20 countries individually; two other countries with NAFTA; six with CAFTA; and 164 with the World Trade Organization. These tariffs are, no doubt, in violation of most of them. The head of the WTO issued a stark warning against "tipping the first dominos" in a trade war that could trigger a deep recession.

The president should heed his warning.

A New Look at Super Voters

New data gives us a chance to determine what we are dealing with in our attempts to get the voter registration rolls cleaned up. We are still waiting on Judge Beth Bloom to decide what the evidence in the Broward County case will allow her to do with regard to enforcing federal laws on this subject. That case was first started by a required notice sent to Brenda Snipes in January 2016. The trial was held in July and August 2017. The attorneys in the case filed their responses to the Court's requests in October 2017 and we are patiently waiting for a decision.

Data base expert, Kirk Wolak, who is helping us look at millions of lines of data, recently did some very good comparisons and sorts of the voter lists for Florida and New York again for our use to see what is going on. The Florida data was obtain in February 2018 and the New York data is from October 2017. The data changes weekly and monthly, so this is just a snapshot. This set of data was carefully inspected for fonts, word order and date number order because of the fact that New York places many years of voting history in a single cell of its data base. New York has 62 counties and does not have a uniform method or format for collecting its data in Albany.

Overall the data confirms we still have super voters. These include special voters like judges and political office holders whose personal data is exempt from Florida Sunshine Laws disclosure requirements. The new tally indicates there are still about 12,000 to 16,000 registered voters in each of Broward, Dade, and Palm Beach Counties who are also registered to vote in various counties in New York State. These dually registered voters in the two states were legally cleared to vote in the Presidential Primary and the General Election in both states if they had showed up. There are still some persistent double voters who voted in the November 2016 presidential election in both states. It is doubtful they cancelled their first vote with their second vote.

The data shows voter rolls are not clean up yet in these 3 of Florida's 67 counties. The Supervisors of Election were notified in August 2016 that the election was in peril if these folks decided to vote in both states in November 2016 as many of them believe they are allowed to do. But Broward and Dade SOEs did nothing. Palm Beach's SOE delayed and delayed and waited until 2017 rolled around. They ignored the Florida law that says they must act in seven (7) days.

In Broward where the federal case in pending, it is like Broward officials are doing nothing for fear of making admissions of guilt if they do what the Florida law requires them to do. Someone must be advising them to not act yet because they might make things worse than they are already.

The Florida legislature has noticed the need to again tighten up the loop holes. Under F.S. 98.075 (7) the SOEs are obligated to use:

(7) PROCEDURES FOR REMOVAL.—

- (a) If the supervisor receives notice or information pursuant to subsections (4)-(6), the supervisor of the county in which the voter is registered shall:
- Notify the registered voter of his or her potential ineligibility by mail within 7 days after receipt of notice or information. The notice shall include:
 - A statement of the basis for the registered voter's potential ineligibility and a copy of any documentation upon which the potential ineligibility is based.
 - b. A statement that failure to respond within 30 days after receipt of the notice may result in a determination of ineligibility and in removal of the registered voter's name from the statewide voter registration system.
 - c. A return form that requires the registered voter to admit or deny the accuracy of the information underlying the potential ineligibility for purposes of a final determination by the supervisor.
 - d. A statement that, if the voter is denying the accuracy of the information underlying the potential ineligibility, the voter has a right to request a hearing for the purpose of determining eligibility.
 - e. Instructions for the registered voter to contact the supervisor of elections of the county in which the voter is registered if assistance is needed in resolving the matter.
 - f. Instructions for seeking restoration of civil rights following a felony conviction, if applicable.

The Florida legislature is working on a bill to add another source of information for SOEs to use. That would be that when Circuit Court Clerks make jury duty inquiries that determine jury duty was excused to non-citizens, this must be reported to SOEs. The SOEs would be required to contract with the Court Clerks to get the data on these ineligible voters periodically and take them off the voters list. If this does not pass this year, it will be because other citizenship-qualified voters are not taking part.

Voters should realize that the 67 SOEs in Florida have an association that hires lobbyists to look after their interests during the legislative session. Who is taking care of monitoring your interests? What is your Florida Representative and Senator doing about this? Why are we allowing SOEs to ignore the voter registration laws? Why do we have to sue to enforce the laws we elected the SOEs to administer?

Read the entire F.S. 98.075 and you will see other office holders have some responsibility to use the data if SOEs do not. Why are we also excusing these other public servants? Do we have too many laws to read or are legislators using the wrong words? Does anybody still know the meaning of "public trust?" Who is going to clean the rolls in all 67 counties?


On February 6, 2018, Rush Limbaugh left his gold microphone at EIB HQ to make his very first public appearance to honor William F. Buckley at the National Review Institute's "A Tribute To William F. Buckley."

The Colony Hotel held the sold-out event for 100 people who paid \$250.00 each to hear *National Review* Editor, Rich Lowry; National Review Institute's senior fellow John O'Sullivan; WFB biographer, Alvin Felzenberg; and special guest, Rush Limbaugh. Mr. Limbaugh explained his admiration for Mr. Buckley.

"The single greatest motivation I had to learn to read, write, speak the English language the best I could, to expand my vocabulary, came from Bill Buckley.

"Bill Buckley is indescribable. He's irreplaceable. There will not be another one like him. And although that's true of all of us, once you take the time to learn about Buckley and his life and look at what all he did with it, he did not waste a moment, did not waste a moment. He was able to pursue, as he called it, his sybaritic delights, his pleasurable delights, such as sailing around the world numerous times, traveling the world with his work. He was prolific in output, but it was his intellect and it was his good humor that was literally inspiring to me.

"Even after I went through one year of college and I was having trouble, flunked speech, should have called the course Outline 101. Flunked speech, did every speech, showed up at every class and still flunked it. I said, 'This is not for me.' And one morning I was sitting in the house at

20 years old and I said, 'I'm quitting.' I told my dad, 'I'm quitting. I can't handle this. I'm leaving. I've got a job offer in Pittsburgh, and I'm going. He was very concerned he was a failure as a father, and I remember telling him, 'Well, I want to be like Bill Buckley.' He said, 'What do you mean?' 'Well, I want to be able to sit around and write and think and speak,' and so forth, and my dad blew up at me. 'What are you talking about?' He gave me a two-hour lecture on, 'Where do you think Bill Buckley went to become what he is? Do you think Bill Buckley just sits around and writes and thinks and speaks, and people like you have this reaction to him?' I got a serious lecture on how hard and timeconsuming achievement is. When you see the output of someone's work but you don't see what goes into it, you can make the mistake of assuming it comes easy to them, especially those who are great at what they do. They make it look so easy that you think you could do it, too. And you form impressions of how they do it, and you see these people on television and so forth, you really don't see any of the prep or any of the hard work that goes into the final product, and my dad was right about that.

"So it wasn't until I left the formal academic setting at age 20, that I got serious about education above and thought Buckley was so unique and special that when I found out about *National Review*, I thought you had to be invited to read it. I didn't think anybody could. I didn't know he was writing a magazine and publishing one just for profit. I thought there was select group of people that were entitled to be part of that. I'd never seen it on a newsstand. I had never seen it anywhere at anybody's house. But I heard about it and I read about it and so forth.

"So one day I called National Review in New York when I was in Sacramento. I was very sheepish, a woman answered the phone and I felt like I was calling God. I didn't ask to speak to Buckley. I said, stammering, 'Can I subscribe to your magazine?' 'Of course, of course. Where can we send it?' I was taken aback. I was in that much awe, is what I'm trying to say. I was as nervous making that phone call as any phone call I can remember making. So I began to subscribe to it, got a hold of more and more, continued to read his column. And, of course, he was one of the formative forces in my worldview, political, conservative view of all things: domestic, cultural, political. My first real understanding of the concept of lowering tax rates to generate revenue came from Bill Buckley. I could cite countless other things of conservative orthodoxy. It's a shame to even attach the term conservatism to this because it's too narrow. It's just right. These are principles by which people live and Rush Limbaugh—continued from previous page



Buckley was so prolific that in his nearly 60 years of public life he published 55 fiction and non-fiction books, wrote over 225 obituaries, over 800 editorials, dozens of book reviews and introductions and prefaces to other authors' books, hundreds of articles, and approximately 5,600 newspaper columns. Buckley hosted 1,429 separate "Firing Line," television




shows with guests ranging from Ronald Reagan and Margaret Thatcher to Rush Limbaugh, Billy Graham, and Henry Kissinger.

Parkland: Epic Failure, More Politics

P arents, students, teachers, and our community are grieving over the needless loss of life of children, friends and neighbors. As a parent, there can be no greater pain than losing a child to violence.

Los Tres Amigos 2018

Los Tres Amigos, for the third year running, were the highlights of our February meeting at Grande Bella Cocina.

Michael Barnett, PBCGOP Chair and vice chair of RPOF, was fresh from his recent Oval Office visit for the Black History Month event, where he rubbed elbows with Herman Cain, Alveda King and others.

The county GOP is in great shape he reported, raising lots of money. Lincoln Day was sold out in December, even without announced speakers, but it will be a great lineup. Sarah Palin will be the headliner, with guests Diamond and Silk, James O'Keefe, and Charlie Kirk of Turning Point USA.

Michael gave us an update on outreach activities and reported that the local Haitian community is still supporting the President, in spite of media attempts to drive a wedge over alleged comments, because he keeps his promises. The Puerto Rican evacuees—estimated at over 300,000 and settling around the I4 corridor from Osceola to Hillsborough counties, are a toss-up. About 90% are expected to settle permanently and many have registered to vote—but there are more Independent registrations than either Democrat or Republican. The African American community is harder, but Trump carried a larger percentage of that group than a typical Republican and the Economy will help in the 2018 election cycle.

Next up was attorney **James D'Loughy**, who (with Sid as plaintiff) is suing Palm Beach Gardens over the misleading ballot questions for the March election. James was a city council candidate in 2013, jumping into the race to speak out about dirty politics, and one of the driving forces that put term limits on the ballot in 2014. That measure passed with 80% of the vote and all 5 current council members were able to run and win because of it. Now that same council has decided that they really want more terms than permitted, and want to be able to run again when their limits are up—a measure that they have placed on the March ballot to "let the voters decide." The city is using large amounts of taxpayer money to promote a YES vote on the four questions in a misleading way—part of the reason for the lawsuit. James suggests you vote NO on all four questions.

The third "Amigo" was former County GOP Chairman Sid Dinerstein, whose topic was "Honey, I shrunk the Dems!" Invoking the "Gretsky Rule" (go to where the puck will be. . .), Sid was very upbeat about the 2018 and 2020 elections. "I'd run with a 4% GDP growth anytime." He believes that 80% of the 2020 votes are already "cast"—they were locked in with the Carrier Deal in December 2016, especially in Michigan, Pennsylvania and Ohio. Dems have become the "no jobs" party and have shown they will not stand up for the working man in those states.

In 2018, he thinks Brian Mast will win by 20 points. The national Democrats listed CD18 as a target race, but only because it is a closely divided district (by registration) and he does not think they will pour money into it as there are other districts where the pickings are better. He then listed many of the things which have made the Democrats weak and shrinking:

- Voter Fraud—a foundation of their strategy, will be less effective because we are talking about it and the fraudsters will keep their heads down.
- Good Help—the association with Black Lives Matters, Antifa and other groups of paid, professional thugs
- MS-13 and Sanctuary Cities—Trump is leading on these issues and Obama was absent
- The NFL—stupidity on many levels
- Political correctness—New York has renamed Columbus Day, "Indigenous People's Day"—angering Italians everywhere
- Doubling Down on the tax bill—the Dems still call a widely successful and popular program "Armageddon"
- DACA—Trump has the high ground on this and the Dems will abandon the Dreamers in favor of an "issue"

With all of these Democrat negatives, Sid thinks Trump will win in 2020 easily.

To wrap it up, Sid described the State of the Union as "Trump hearts America," and paraphrased the best line of the speech: "Americans are Dreamers too—AGAIN."

He and I became very good, and close, friends who talked all the time, and when my children were students at Douglas during their respective times, it was Aaron Feis who kept me abreast of everything "good and bad" that they were doing. He was their Guardian Angel during those days, in more ways than you could ever know, or that I will ever reveal.

So, it is through a lot of tears that I write this in memory of all those who lost their lives on last Wednesday, but especially for Aaron Feis, who was among those killed during what has become an all-too-familiar scene in America.

Not only was Aaron a friend, but whenever he needed advice about a career move in the Broward School system, he would call me. However, no matter how many openings he applied for within the District, he always ended up back at Douglas, so I told him in one of our final conversations that I thought The LORD wanted him to be at that school.

Why??

Because, Aaron graduated from Douglas, which opened in 1990, and he played football at the school, as both an offensive and defensive lineman. Aaron Feis WAS DOUGLAS HIGH SCHOOL THROUGH AND THROUGH!!

He was always there for students, either to help them, encourage them, or to discipline them, as only he could :-).

And, for that reason, I believed completely the first reports that came out of the situation on Wednesday. It was reported early on that a member of the school staff threw himself in front of several students to shield them from the gunman's bullets.

When I heard that . . . I INSTANTLY KNEW THAT THE PERSON WHO SELFLESSLY GAVE UP HIS LIFE TO SAVE OTHERS, BEFORE A NAME OF THAT PERSON WAS EVER RELEASED, WAS THE SAME GUARDIAN ANGEL WHO WAS THERE MANY TIMES FOR MY CHILDREN IN THE PAST.

There are times in this life, when you just know something. On Wednesday, I JUST KNEW. . . !!

There is a passage in the Bible that says, "The greatest gift anyone can give, is to give his life for a friend." Aaron Feis gave students at Douglas yesterday . . . THE GREAT-EST GIFT!!

So, it is through heartfelt tears of pain that I say Good Bye, and Thank You, to a Friend, and to say that I will NEVER FORGET YOU.

Book Review


Grant, by Ron Chernow. New York: Penguin Press, 2017. 1,074 pp.

I've read biographies of all our presidents, but for some of our most distinguished past leaders, dissatisfaction with the bios I've plowed through have led me to read others in the interest of finding more definitive examinations of the lives of those great men. Washington, Jefferson and Lincoln come to mind in the way of examples, and I can now add the name of Ulysses S. Grant to that list. *Grant* was written by Pulitzer Prize-winning author Ron Chernow, and, in my opinion, it surpasses the level of achievement accomplished in two of his previous highly-acclaimed works—*Alexander Hamilton* and *Washington*, which I also read and greatly enjoyed.

Great books make you feel great, and this is one of them. At 1,000 pages, it requires considerable time to read, but is well worth the effort. To begin with, in the way of introduction, consider what legendary writer Walt Whitman had to say about Grant the man: "What a man he is! . . . he proves how an average western farmer, mechanic, boatman, carried by tides of circumstances into a position of incredible military or civil responsibilities . . . may steer his way fitly and steadily through them all, carrying the country and himself with credit year after year—command over a million armed men—fight more than fifty pitch'd battles—rule for eight years a land larger than all the kingdoms of Europe combined—and then retiring, quietly (with a cigar in his mouth) make the promenade of the whole world, through its courts and coteries, and kings and czars . . . as phlegmatically as he ever walk'd the portico of a Missouri hotel after dinner. . . . Seems to me it transcends Plutarch. How those old Greeks, indeed, would have seized on him! A mere plain man-no art, no poetry. . . . A common trader, moneymaker, tanner, farmer of Illinois—general for the republic ... in the war of attempted session—President following (a task of peace more difficult than the war itself)—nothing heroic, as the authorities put it—and yet the greatest hero. The gods, the destinies seem to have concentrated on him."

It may be possible to give a more accurate, poignant, brief summation of the life of U. S. Grant than the touching effort I just quoted by Walt Whitman, but I doubt it. In a few brief words, Whitman not only captures the essential greatness of our former president, but more importantly reveals the disservice done to him by history's negative verdict of his life's work, which this wonderful book serves to correct. In that regard, Grant reminds me of George Armstrong Custer, who has also been much maligned by historians who concentrate on his impetuous errors in the legendary Battle of the Little Big Horn, while ignoring his

much more important heroic contributions on the decisive final day at Gettysburg, where his actions represent a crucial contribution to the Union victory. Grant too, has been denied his rightful place among the great men of America by historians who concentrate instead on his alcoholism, failure in business and his contribution to the Jim Crow era that followed his presidency, instead of the things that made him such a



great man as outlined above by Whitman.

With regard to history's negative outlook of Grant's views on race in America, one should note that during the Civil War it was he who recommended to Lincoln that blacks should be enlisted in the army to fight, to which Frederick Douglas gave much praise, stating, "Once the black man had a musket on his shoulder, and a bullet in his pocket, no power on earth could deny that he has earned the right of citizenship in the United States." Historians have also ignored the fact that Grant regretted his administration's missteps in post-war race policy, considered it his single greatest failure, and did not wish for things to turn out as they did in the Jim Crow era. Author Chernow does a masterful job in the telling of what happened and how that sheds a more sympathetic light on the president's actions in the postbellum era, which was one of the most challenging times in our country's history.

One of my favorite parts of the book tells the stirring story of the final months of Grant's life, when dying of cancer and in constant pain, he miraculously produced a lucrative autobiography that saved his family from destitution. Unlike virtually all other leading figures in America's Civil War, he had steadfastly refused to make money off of it, but in the end, just as he had done for his country during the war, he rose to the occasion in his darkest hour to provide for his family after he was gone.

A reappraisal of the life and times of Ulysses S. Grant is long overdue, and biographer Ron Chernow delivers it in this book which probably won't win a Pulitzer Prize among those who, perhaps, place more emphasis on the man's failures than they should. But it will go far, I suspect, in rehabilitating the reputation of this former president and commander of the Union Armies in the Civil War, and recasting him in his rightful place among our country's greatest heroes.

Book Review

Culture at Dead End, Unless . . .

Recently, we have been hearing about the decline of the American culture in the United States. Witness four separate venues telling us that the U.S.A. is about done in. Just a few days ago, in February 2018, on the Fox News Channel, Tucker Carlson told us that our American culture had changed so much in recent times that he would be devoting some time on the subject every so often with guests to explain what is happening. About a week later, on February 19, Carlson introduced Kentucky Gov. 

Then he discussed the recent Freedom House report on worldwide democracy, pointed out that 71 counties suffered net declines in political freedom, and only 35 registered gains. The recent annual report said the U.S. is now a "flawed democracy" because of a polarized political system and a decline in trust in its institutions. Seib wrote that: "Congress has consistently failed in efforts to enact stronger background checks and is currently failing to devise a formula to deal with Dreamers." Gridlock is at hand and that is what Russia wants, Seib wrote.

NRA Executive Vice President Wayne La Pierre, in the March 2018 issue of *America's 1st Freedom*, describes the Democrat Party as socialists. He points out that socialists always take your guns. He asked that we take a look at Venezuela as the latest example. La Pierre writes that Soviet Socialism, National Socialism, and Maoist Communism are all on the march in the U.S., backed by an assortment of people like George Soros.

Finally, the fourth venue was hearing Glenn Beck on his radio show at WJNO 1290-AM on February 21, 2018, interviewing a person familiar with some Syrian monsters' activity that includes enslaving children and adults and collecting body parts from them for sale in various countries where the parts are being implanted into "needy" folks with lots of money. As this discussion continued, the informant pointed out there was much more slavery today in the world than there was during the 400 to 500 years Africans were being enslaved and some were brought to the New World before America's founding. This helps us understand better that it only took from America's constitutional founding in 1789 to the Emancipation Proclamation in 1862 for the American way to make a near fatal blow to slavery in those 73 years, while the personal imprisonment conduct still abounds all over the world.

Just when I was feeling the perpetual gloom and doom these four strains of ideas express, I opened my mail to find a new book by a group of enthusiastic Christians. As I settled down and read through this 189-page book in the next two days and reflected, I decided that this is a book I want my grandchildren to read so they can protect themselves from the mess my generation and earlier ones had created for them.

This book was not the Bible, or a book about the Bible. But it was about what our Founders



believed the Bible and other educated sources taught them when they designed the new nation and wrote the Mayflower Compact, the Articles of Confederation, the Declaration of Independence, the U.S. Constitution, and the Bill of Rights, as well as a whole series of prayers, pronouncements, and resolutions establishing local, statewide and national days of thanksgiving.

After ordering a batch of books for the grandkids, I felt good. But then as if to punctuate an ending to these revelations, I learned that America's Pastor, Billy Graham, had passed away at age 99. Graham spoke to more people in the world about God than any other man since Saul of Tarsus. A part of Graham's message: "Faith is Powerful" and "Make Your Days Count!"

Be assured that I know that Billy Graham was not a Jewish Rabbi, a Catholic Priest, or a Muslim Imam. I personally do know some Rabbis, Priests, and one Imam. The people who founded the United States were 98 percent or more of some kind of Protestant Christian. There were few Catholics and just a small number of Jews in the land. There were from time to time a Muslim ambassador or two from northern Africa or the Eastern Mediterranean area, but no group of them. These religious labels and percentages are not the same in 2018; these differences are a large part of the change that our culture has endured over the last 250 years. These facts are historical facts that cannot be changed by tearing down monuments to the Founders.

This new 2018 book is written by eleven authors, one a co-author who is deceased, and one author who is female, each writer with an important position in the hierarchy of religion and public affairs. Each one has written many books, pamphlets, sermons, letters, budgets and plans for the future. Edited by Dr. Jerry Newcomb with a Foreword by Dr. Frank Wright and an Introduction by William J. Led-

erer, these are followed by nine chapters. A paragraph from the Introduction explains the contents well:

Included here are essays by a number of distinguished contributors: John Soronsen, president of Evangelism Explosion International, looks at the source of our hope for America. Peter Lilliback, president of Providence Forum and president of Westminster Theological Seminary, comments on America's Christian roots. Former Congressman John Hostettler, senior executive director of the D. James Kennedy Center for Christian Statesmanship, writes of the genius of the Constitution. I, William J. Federer, writes about the misunderstanding of church and state relations. David Gibbs, III, president of the National Center for Life and Liberty, apprises us on threats to religion in our time. D. James Kennedy [deceased] and co-author Jerry Newcombe, sound the alarm on the major moral crisis of our day the problem of abortion. Linda W. Smith, president of the D. James Kennedy Center for Christian Leadership, comments on another serious problem, that of incarceration. Jerry Newcombe, columnist and senior producer a D. James Kennedy Ministries, shows America's need for God. Frank Wright, president and chief executive officer of D. James Kennedy Ministries, concludes with a hopeful message for a new era of cultural engagement in America.

Sorenson asks if there is any hope for America and he answers that we need to make more effort to live life as if we really believe there is a God who can help us. We are reminded by Lilliback that the first act of the first Congress was to open the Philadelphia meetings with a prayer. I was in awe of the quotations from George Washington over many years about Providence, the Supreme Director, Almighty Ruler of the universe, Almighty being who rules over the universe, the Great Governor of the Universe, and his farewell address which includes: "Of all the dispositions and habits which lead to political prosperity, Religion and Morality are indispensable supports"; and this admonition "reason and experience both forbid us to expect that national morality can prevail in exclusion of religious principle."

Hostettler writes that the U.S. Constitution can be truly understood in light of the Framers' understanding of one of

the most fundamental precepts of Holy Writ—the fallen nature of man. Federer's chapter on history covers the religions of the countries of Europe at the time before the crossing and helps explain what the people were looking for as they settled in the New World.

David Gibbs starts off his chapter by telling us the state of religious liberty in the U.S. is in peril, how the new country was organized around the principles found in the Judeo-Christian religion, and ends with a discussion of the 20 religious principles in President Trump's and the Department of Justice's memorandum on religious liberty. Kennedy and Newcombe review the problems with the U.S.A.'s present stance on abortion. Linda Smith points out the problems with incarceration. Newcomb analyzes our need for God. Frank Wright challenges us to step up to the plate and make an effort to hit the ball out of the park for God. Become a Christian Statesman.

The book is not a manual for small groups of Christians, but it is a relevant historical treatment of what is wrong in the land and how these things can be fixed. This book can be used by readers of any faith to get your bearings in what to do with your life. It is not the only thing you should ever read, but you should take the time to see if you are inspired by our Founders, our subsequent national history as a country, and the real opportunities to get some help from having a faith that prods you to do more. Restoring that knowledge could help restore our culture. So could a faith like that of Billy Graham.

h how they howled! On both the left and right as President Trump announced his planned 25% tariffs on steel and 10% on aluminum, aimed at countries with unfair free trade policies. As usual, the President was right and the howlers were wrong. Now when I refer to "howlers" I'm not talking about all those who disagree with Trump's trade policy. 

Republican Executive Committee Membership Application

The Republican Executive Committee (also known as the REC) is the governing body of the Republican Party of Palm Beach County. The REC elects the Chairman, Vice Chairman, Secretary, and Treasurer of the Party. Members of the REC also approve the Party's constitution; Rules, Policies & Procedures; and budget.

Members of the Republican Executive Committee represent the registered Republicans who live in their precinct. They serve as the Party's liaison to the Republicans in their precinct. REC members are expected to maintain contact with the Republicans living in your precinct and to keep them informed as to what is going on in the Republican Party. This can be done through E-mail or other means like regular mail, phone calls ad walking your precinct. The REC is the basis for our grassroots efforts and we rely on REC Members to organize and develop their precincts, recruit new volunteers, recruit candidates to fill vacancies on the REC, find sign locations for Republican candidates, register new Republican voters and work to get out the Republican vote in their precincts during elections. The role of committeeman or committeewoman is essential to Republican Party's and our candidates' success in Palm Beach County.

REC Committeeman & Committeewoman Duties and Responsibilities

- 1. Expected to donate financially to the Republican Party of Palm Beach County
- 2. Attend REC Meetings
- 3. Organize your precinct and carry out the policies and programs of the Party within your precinct. Active participation in the various programs of the Party is expected.
