The Humdinger of a State of the Union and the Witless Women in White

What a State of the Union Speech! I've never seen anything that compares to it in my lifetime and I'm not the only one. A poll taken of people who watched the address by President Trump indicated 76 percent approved as opposed to 24 percent who disapproved. And that's a CBS poll from one of the "drive-by" channels, so you know it couldn't be agenda driven! And how could there not be that kind of positive response from the American people given the brilliant themes of that address by the president of the United States. The results were nothing short of amazing, as will be apparent in the following in-depth review, but first a little background on how we got there.

Remember, at first there was the limited government shutdown overthe Dems refusal to help the president secure the southern border. In the court of public opinion the president appeared to be losing that showdown, especially when House Speaker Pelosi withdrew her invitation to the president to give his State of the Union speech at the House of Representatives in DC, denying him that most attractive of venues to educate the public about what the crisis on our southern border was really all about. Then Mr. Trump turned the tables on her by reopening the government and forcing her to re-issue the invitation to speak before a joint session of Congress, an opportunity which he took full advantage of in one of the best political speeches I have ever heard. Never

have I seen the Democrats more flummoxed, confused, outmaneuvered and uncomfortable in public. As Palm Beach County GOP Chairman Michael Barnett said, they were made to dance "like puppets on a string" and President Trump was the commanding puppet master in chief.

From start to finish the address was brilliantly crafted, structured and staged. Not wasting any time, the Sgt. at Arms announced the president and, bucking tradition, Mr Trump went straight to the podium and began his speech instead of being introduced a second time, which has always been unnecessary and irritating. Setting out his most dominant theme at the start, he appealed for bipartisanship, saying "millions of our fellow citizens are watching us now, hoping that we will govern, not as two parties, but as one nation." A thundering standing O was the response, but not from the Democrat Women in the Chamber, dressed in white ostensibly to show solidarity with the women's movement, but in effect making it easier to see who it was that was really opposed to bipartisanship and unity. Leading lady in white, Pelosi, tried openly at times to signal these intransigent snow-white Dems not to telegraph their blatant partisanship and resistance to everything Trump to the vast American audience looking on, but nothing could stop

them, especially their leader, 28-year-old self-acclaimed socialist, Alexandria Ocasio-Cortez from New York, who remained defiant throughout.

The president boldly called for a new standard of living for Americans in the twenty-first century, reminding viewers that his policies have launched an economic boom not seen in decades, creating 5.3 million new jobs in only two years. He said that the U.S. economy was now growing at nearly twice the rate it was when he first took office, and reeled off statistics that were undoubtedly new to viewers who got all their news from CNN, MSNBC and the Rachel Maddow Show. Unemployment is the lowest it's been in 50 years and African-American, Hispanic-American, Asian-American and disabled-American unemployment has fallen to the lowest levels in history. He rightfully took credit for other accomplishments in the first two years of his presidency, like the massive tax cut for working families, the doubling of the child tax credit, and the fact that more unnecessary regulations have already been cut than during any other previous administration's entire tenure. Companies were coming back to America from overseas in record numbers, and a revolution has been launched in the countries energy sector that has made us the world's number one producer of oil and natural gas. "Members of Congress," he said, "the state of our union is strong," and the only thing that can stop our economic miracle is "foolish politics and ridiculous partisan investigations."

All presidents at these joint sessions of Congress play to people's emotions with invited guests, but none more effectively than President Trump did last night. At one point he introduced a grateful teary-eyed woman he'd pardoned from prison, who'd been given a life sentence for a seemingly low-level drug-offense. As most in the chamber on both sides of the aisle applauded this poor victimized grandmother, a camera shot of the women in white revealed three of them, heartlessly huddling together in an apparent strategy session, while oblivious to the emotional outpouring of support going on all around them.

Trump challenged Congress, saying they had ten days to craft legislation to end illegal immigration on our southern

border and putting the ruthless coyotes, cartels, drug dealers and human traffickers out of business. Once again, the response in the chamber from most was a standing ovation, but a quick camera close-up of presidential hopeful Kamala Harris showed her scowling and shaking her head.

"As we speak," warned the president, "large caravans of illegals are heading for our southern border and we have a moral duty to create an immigration system that protects the lives and jobs of our citizens. This includes an obligation to the millions of legal immigrants living here who followed the rules and respected our laws." Once again when the women in white booed, Pelosi tried to silence them by holding up her hand, but to no avail.

"Legal immigrants enrich our country and I want them to come into our country in the largest numbers ever, but they have to come in legally. No issue illustrates the divide between America's working class and America's political class than illegal immigration. Wealthy politicians and donors push for open borders while living their lives behind walls and guards. Toleration for illegal immigrants is not compassionate, but actually very cruel. One in three women are assaulted in the journey north. Smugglers use children to exploit our laws and gain access. Traffickers smuggle in women to sell into prostitution and sex slavery. Tens of thousands have been killed by illegals who cross our borders. Last year ICE made 200,000 arrests of criminal aliens including those convicted of 100,000 assaults, 30,000 sex crimes and 4,000 murders." Then the president reiterated his proposal to secure the border that includes, a physical barrier and many other technologies "that most people in this room voted for in the past, but the proper wall never got built."

Another memorable part of the president's State of the Union Address was when he charged that "We in the U.S. are alarmed by calls to adopt Socialism [Cortez, Gillibrand, Sanders] in our country, but America was founded on liberty and independence and not government domination, coercion and control. We were born free and we will stay free. Tonight we renew our resolve that America will never be a Socialist country."

He ended with a final appeal for bipartisanship. "Think of this very chamber where lawmakers voted to end slavery, defeat fascism, secure civil rights and face down evil empires. Here tonight we have legislators from all across this magnificent Republic. What will we do at this moment? How will we be remembered? I ask the men and women of this Congress to look to the opportunities before us. We must choose whether we are defined by our differences or dare to transcend them. This is the time to rekindle the bonds of love, loyalty and memory that link us together as citizens, neighbors and patriots. I am asking you to choose greatness. We must go forward together and keep America first in our hearts, and freedom alive in our souls, and always keep faith in America's destiny that one nation, under God, must be the hope and the promise and the light among all the nations of the world."

As that finished and the chamber erupted in genuine appreciation for a truly inspiring speech and the camera backed up



for a wide-angle shot of the whole chamber, the women in white seemed to be tripping over one another in their haste to exit, no doubt oblivious to the fact that they'd been totally out-classed and hopelessly out-maneuvered.

2020—Part I

Feb. 27 is the First Term Limits Day!

Every month is a National (something or other) month. February is Black History Month, Grapefruit Month, and about 20 other titles. Every week has observances, too: National Jell-O Week for one, and there's almost 100 daily designations, including a couple of serious ones—like Presidents' Day and Valentine's Day—but mostly silly ones like Bubble Gum Day.

OK, time to get serious. Mark your calendars: **February** 27 is now a most serious one: **Term Limits Day!**

Thomas Jefferson saw the potential of the country deteriorating into the swamp when he warned: "To prevent every danger which might arise to American Freedom from continuing in office, it is earnestly recommended that we set an obligation on the holder of that office to go out after a certain period."

Term limits are needed to ensure competitive elections that bring real-world experience instead of the professional politicians whose primary goal is reelection. Those career pols with no experience outside of politics are making laws on areas they know nothing about—except what the lobbyists tell them. Term limits bring their reps closer to the people. What better approach to draining the swamp?

I have felt strongly about this costless reform for over 40 years. Many will remember the Palm Beach County Term Limits Committee—Eight is Enough!—formed with my son Philip (now president of U.S. Term Limits) and others, including REC members. One notable member, Bill Gorman, was our champion petition-getter at well over 1,000 signed petitions to limit the County Commissioners. It passed with 70 percent of the vote in 2002. In 1992 the effort to pass term limits on the state legislature passed by 77 percent. Both have measurably improved the quality of representation we enjoy in Florida.

Why Feb. 27? February 27 commemorates the ratification of the 22nd Amendment in 1951 which imposed term limits on the president of the United States. That date was chosen among other ideas after public discussion among activists coordinated by the No Uncertain Terms podcast.

On **February 27** each year, citizens are encouraged to show public support for term limits. This can be as simple as posting a pro-term limits yard sign available at the www.termlimits.com/shop. Citizens should use **February 27** to send a reminder to their federal *and* state representatives that they support term limits. Go to www.termlimits.com/legislators and use the online tool. This takes only minutes.

The battle for term limits is taking place on two major fronts simultaneously. In the U.S. Congress, a term limits amendment bill was introduced by Sen. Ted Cruz and Florida Rep. Frances Rooney. Sixty-six members of Congress have signed a pledge to co-sponsor and vote for the Resolution. U.S. Term Limits urges us to call our reps on

February 27 and ask them to co-sponsor the bills. Florida Sens. Rick Scott and Marco Rubio are already co-sponsors, as well as Florida Rep. Matt Gaetz.

There is also a movement calling for an amendment-proposing convention of states under Article V of the U.S. Constitution *limited to Congres*-



sional term limits. Three states—Florida (of course!), Alabama and Missouri—already passed resolutions calling for the term limits convention, and it is being introduced in at least ten states during the 2019 legislative sessions.

Congress has less than 20 percent approval ratings but 90+ percent incumbent reelection rate. Why not just vote them out? Because incumbents have an enormous advantage that discourages challengers from spending the time, effort and money necessary—not to mention the abuse from the opposition. Lobbyists don't want to lose their "honest politicians" who they describe as "once bought, stays bought." So, besides the big money from special interests, they enjoy name recognition that few challengers have. The establishments support their incumbents even when they stray from Party platforms because of the odds and at least they'll vote for party leadership. Power is a goal of career pols, especially the leadership.

On **February 27** citizens can add their voices to those calling for fundamental change in our political system. Here are some other ideas to promote term limits:

- Organize a sign-waving at a busy intersection.
- Take a selfie holding a sign and post it on your social media.
- Send an email to your friends wishing them a Happy Term Limits Day and suggesting they sign the online petition for congressional term limits.
- Send pictures to termlimitsday@termlimits.com and they will be shared with one-million-plus Facebook followers.

Each of us who acts on Term Limits Day **February 27** will be helping apply additional pressure on our politicians to pass a term limits amendment. What is starting as a day of action may well result in an annual celebration of the people's victory.

Ballot Integrity Update—Texas Edition From "The Backhoe Chronicles"

Many of you will recall my numerous posts during the Florida Recount as more and more "new" votes were discovered after election day in Broward and Palm Beach Counties, almost all of which were for Democrat candidates. . . .

Governor Scott and others screamed "fraud"! He held on to win and now the Supervisors of Elections in those two counties are GONE, thanks to bold leadership from former Governor, now Senator, Rick Scott, and Florida's new Governor, Ron DeSantis.

This bold action has inspired other state leaders to investigate ballot integrity and the results, so far, are astounding. Voter integrity hawks are hailing an investigation by the Texas Secretary of State that uncovered 95,000 noncitizen residents who illegally registered to vote!!!!!

It is one of the largest discoveries of non-eligible voters by any one state. Conservative groups say Secretary of State David Whitley's inquiry produced real numbers to support their years of lawsuits and research. The Democrats and left contend, of course, that voter fraud is rare.

Those of us on this post instinctively know better. Why? Common sense.

How come in almost every case, the after-election day votes are overwhelmingly for the Democrat candidate, reversing from Republican to Democrat the eventual winner?

Let's hope this is only the beginning.

As expected, The League of United Latin American Citizens filed a lawsuit on Tuesday challenging the voter purge.

"It is the tip of the iceberg," Tom Fitton, director of the conservative watchdog group Judicial Watch, said. "This shows the urgent need for citizenship verification for voting. The Department of Justice should follow up with a national investigation."

Mr. Fitton operates an election integrity project. On January 4, he announced the settlement of a lawsuit with the state of California and Los Angeles County to expunge as many as 1.5 million inactive voters for their rolls.

"Los Angeles County has more voter registrations on its voter rolls than it has citizens who are old enough to register," he said.

Chronicle fans, let that sink in for a moment.

Here is the problem:

Liberal states are moving in the OPPOSITE direction. Maryland this year became one of 14 states that allow voters to register on Election Day!!!!!!!

They need to show only that they live in the state. Like other state's voter registration form, the citizenship question is on the honor system.

"Every single instance of illegal voting threatens democracy in our state and deprives individual Texans of their voice," the Texas Attorney General said. "My Election Fraud Unit stands ready to investigate and prosecute crimes against the democratic process when needed."

The non-citizen debate reached the national level in 2014 when Jesse T. Richman, a professor at Old Dominion University, and two colleagues, began publishing estimates of thousands and perhaps millions of illegal voters.

Focusing on the 2008 presidential election, he concluded a wide range, from 38,000 to 2.8 million non-citizens, voted!!!!!!

Mr. Whitley's report said that of 95,000 non-citizens, 58,000 non-citizens have voted in the past 20 years.

President Trump's post-election assertion that millions of non-citizens voted in 2016 was roundly critized.

Once again, maybe he is right after all.

"We know for a fact, you have massive numbers of noncitizens registered to vote in this country," White House adviser Stephen Miller said in 2017.

Stay tuned. In the absence of honest elections, a free republic cannot survive.

Penultimate Chapter: Misuse of Discretion by Supervisors of Election

For several years now I have been checking for double-state voters in Florida and New York voter registration lists. At the time of the 2004 election, the Florida Department of State was advertising to the general public on its website a \$5,000 reward for reporting voter fraud. I also learned that the *New York Post* published an article about the double voters in Florida and New York. I decided to find out how many were voting twice here in Palm Beach County. Arthur Anderson was elected the Supervisor of Elections (SOE) in August 2004 to replace Theresa LePore, the "butterfly ballot" designer SOE lady of the 2000 Bush v. Gore election in 2000. You can read more about this earlier research on double voters in my book.

During the 2016 calendar year, Kirk Wolak and I conducted several new comparisons of double voters with fresh data obtained from New York and Florida in an attempt to get the voter rolls in the three South Florida counties cleaned up. We sent these comparisons to the three SOEs. SOE Bucher responded several times to us, but took no action to remove double voters we identified. SOE Brenda Snipes in Broward ignored us as did Christine White in Dade County. We ended up testifying in 2017 in the federal case filed by the American Civil Rights Union against SOE Brenda Snipes in 2016. That case is still alive in the 11th Circuit Court of Appeals in Atlanta and will be scheduled for oral argument in Miami in March 2019. When it will be decided is not sure, but probably the late summer or fall. This article will bring you up to date on some of our related activities to protect the vote.

Skipping back to September 10, 2018, it was time to send new data based on then current voter rolls concerning the November 2016 election to Susan Bucher, SOE in Palm Beach County, so I wrote to her in a certified letter, return receipt requested, to once again provide her detailed data^{2,3} this time about 119 double voters in her County and two other states—Ohio and New York. I was hoping she had finally received proper advice about cleaning the voter rolls of people who voted in two states by using the Florida Statute 98.075 (6). Bucher did not respond, the November election came and went, so I sent her a reminder letter on December 17, 2018. There was finally a response dated January 2, 2019 which I received on January 9, the letter to me was postmarked, January 7, 2019.

In Bucher's January 2, 2019 letter, SOE Bucher responded saying, in part:

Florida law does allow a supervisor to receive information from "other sources"; however, the public data that you reviewed from other states, first name, middle name, last name and date of birth are less than what we would consider preponderance of the evidence, as

required by Florida law. I understand that your efforts were an attempt to be helpful to the process, but we are unable to rely on the data you provided. We usually match to more data points, such as driver's license number, social security number, national change of address, that is not available to the public.



I also added to my Public Document Request by asking:

Also, your letter mentions "preponderance of the evidence" as a standard you use is required by Florida law. Could you please cite the source of that standard if it is in a statute, rule, procedure, guidance or other format and provide a copy that would be part of Request No. 7, above.

So, on January 9, 2019, I sent a response to Bucher reiterating my requests for documents enclosing a check for payment of 50 percent of the estimated charges for researching and providing the documents. All of this was done to make sure some action would be taken by the SOE's office to determine if these voters were going to vote again in two states.

At this point, we all know now, SOE Bucher was about to be or was suspended from office by newly-elected Gov. Ron DeSantis. She was accused of not having proper equipment to recount ballots, for being very late with the recount, and other matters in the performance of her duties. SOE Bucher first said she would appeal to the Florida Senate to be reinstated, then days later she issued a written resignation from office, claiming she could not get a fair hearing in the Senate.

These personnel changes prompted me on January 23, 2019, to write the newly-appointed SOE Wendy Sartory Link to revive my Public Documents Request a week after she was appointed to become the Palm Beach County SOE. Mrs. Link responded by email on January 29, 2019, telling me that Robin Rorapaugh would be in touch with me. I was contacted by Ms. Rorapaugh and set up February 4, 2019 at 11:00 AM to see her. I spent an hour discussing the circumstances, receiving some of the documents requested, and got promises for more information to follow.

One thing I have learned in this work is the major obstacle to getting official follow-up to citizen reporting of suspected double voters by the SOEs in Florida is the reliance on Bucher's faulty reading of the law as stated in the quoted paragraphs above from her letter of January 2, 2019. This is what I am calling a "misuse of discretion," or making up the law as you go along.

As far as I can find there is no "preponderance of the evidence" standard in Florida Statute 98.075 and unless the old or new SOE can show otherwise, a citizen's report should be investigated by the SOE. The hearing process set out in F.S. 98.075 is a perfectly good process to use and does not require the use of social security numbers or driver's license numbers. During my earlier exchange with SOE Bucher in 2016, she flat out stated that Supervisors have no authority to "investigate" voter fraud. But she was wrong then and still is wrong if she would read:

104.42 Fraudulent registration and illegal voting; investigation.—

- (1) The supervisor of elections is authorized to investigate fraudulent registrations and illegal voting and to report his or her findings to the local state attorney and the Florida Elections Commission.
- (2) The board of county commissioners in any county may appropriate funds to the supervisor of elections for the purpose of investigating fraudulent registrations and illegal voting.

Bucher overlooked the following part of F.S. 98.075 at paragraph 6 in misusing her discretion:

(6) OTHER BASES FOR INELIGIBILITY.—If the department or supervisor receives information from sources other than those identified in subsections (2)–(5) that a registered voter is ineligible because he or she is deceased, adjudicated a convicted felon without having had his or her civil rights restored, adjudicated mentally incapacitated without having had his or her voting rights restored, does not meet the age requirement pursuant to s. 97.041, is not a United States citizen, is a fictitious person, or has listed a residence that is not his or her legal residence, the supervisor must adhere to the procedures set forth in subsection (7) prior to the removal of a registered voter's name from the statewide voter registration system.

Nowhere does F.S. 98.075 say only government sources of information can be used to removed voters from the voter rolls. "Sources other than those identified" may be government sources, but the "other than" means there are other possible sources expected.

The problem is that Bucher misused her discretion to avoid doing what the law tells all SOEs to do. She made up her own law. Bucher decided she should only take information from government sources. Rorapaugh and I discussed this on February 4, 2019. I explained how and why I disagreed with Bucher's discretion. I told her F.S. 98.075 was self-executing as far as "due process" was concerned and there no legal problem with doing the hearing for each person who contested the notice given properly under this statute. If a hearing is requested and it is conducted right, the voter will get "due process."

In addition, there is no Florida law giving an SOE discretion to consider only government sources of information.

F.D. 98.075 is specific and can be read and understood by someone with a high school education in my opinion. I asked Ms. Rorapaugh if she needed a ruling from a judge or a new version of the law from the legislature that she and the SOE personnel could understand better. Rorapaugh agreed she should see what happens with the 119 double voters from New York and Ohio.

Rorapaugh, a middle aged, nicely presenting lady, impressed me as a competent second-in-command at the SOE office. She explained she had only been employed here a couple of years after a 17-year career in a federal government position. Rorapaugh advised she would obtain from the Secretary of State any documents that define what county SOEs should be following.

Rorapaugh advised she learned that New York state had joined the multistate Electronic Registration Information Center (ERIC) group last year so that might provide an opportunity to get better cooperation during 2019 for 20-plus states to reduce double registrations.

Susan Bucher had personally controlled all Public Document Requests during Rorapaugh's time there and Bucher also handled discussions with citizens who wanted to report voter registration problems, Rorapaugh told me. She added that SOE Link would be appointing a Public Documents Officer to handle requests. She said violations would be referred to the State Attorney. I suggested that previous referrals to the State Attorney were not processed by the Palm Beach County State Attorney and that a more certain and thorough avenue for handling the double state voters would be giving the hearing under F.S. 98.075.

Rorapaugh said there has never been a hearing after notice for double voting during her time of employment at the SOE office. I asked if there was a standard list of questions for the hearings and who would handle the hearings. Rorapaugh suggested it would have been Bucher, but no such hearings have been held.

Although I am preparing a more detailed analysis of some of the documents I was provided on February 4, 2019, I want to report here that Rorapaugh explained that before the PBC SOE sends a notice under F.S. 98.075 (7) procedure, they undertake several preliminary steps. These steps start with checking the voter's address with the post office system. Readers can learn more about the use of the post office by looking at F.S. 98.065 that describes what are also federal requirements for cleaning voter rolls.

Among the documents for the years 2016, 2017 and 2018 I was provided two completed forms titled "Certification of Eligibility Records Maintenance" and "Certification of Address list Maintenance Activities" for each year. These are labeled DS DE#117 (rev.07/2011) /R1S-2.041. F.A.C. and DS DE#118 (rev.07/2011)/R1S-2.041. F.A.C. You can find these forms on the Department of State website.

These forms show reasons for removal from the voter rolls. One such reason is "Listed residence is not his or her

legal residence." For 2016, 45 people were removed for this reason; 33 removed in 2017; and zero were removed for this reason in 2018.

During 2016 through 2018 no hearings were requested. This means after checking addresses and sending notices by mail to offer a hearing by spending more than \$40,000 postage and notice printing over three years, nobody asked for a hearing. So much for uncovering double voters using the government sources of information that contains drivers' licenses and social security numbers. It looks like the process results in spinning wheels without accomplishing any results. There are people removed under F.S. 98.075 because dead people do not respond; felons did not respond to hearing notices up to the November 2018 election because the constitutional amendment had not been voted on until then.

But remember, if someone in New York or Ohio buys a house in Florida and registers to vote in Florida and does vote in Florida, and also in their original state, that is voting more than one ballot in any election. Another potentially applicable statute is:

104.18 Casting more than one ballot at any election.— Except as provided in s. 101.6952, whoever willfully votes more than one ballot at any election commits a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

Snipes and Bucher have now resigned from office. The two new SOEs of Broward and Palm Beach Counties, Peter Antonacci and Wendy Link, are both lawyers who will read and understand the election laws. Hopefully they will get a handle on the process to clean the voter rolls in 2019. The process must start now. But we must remain vigilant. Our government is one that the founders said requires an educated citizenry to function properly. Abraham Lincoln said our government was "of the people, by the people, for the people," so we need to participate fully. We should not leave it to the discretion of a few election officials.


Start reading the election laws and determine if officials are following the law. These SOEs needed to be counseled by more people than those who took the time to provide their input in recent years.

In that spirit, you need to know that the Florida State Association of Supervisors of Election has recently submitted a list of legislative priorities to the Florida legislature for action. Item No. 3 on this list is to restrict the voter registration rolls for use only for political purposes. Do you understand this could mean many different things, including prohibiting citizens from having access to the voter registration rolls? - 2. This included FN, MN or Initial, LN, date of birth, addresses in both states, registration to vote date in both states, and other data. This same information was accepted by the Florida Division of Elections in the 2006-2008 time period as "legally sufficient" and the Florida Division of Law Enforcement was asked to investigate the voters by interviewing some of them. Before completing the investigation, FDLE ascertained that the Palm Beach County States Attorney would not prosecute the cases for voter registration violations because "they did not vote in the same election", and the agency declined to finish the investigation.
- 3. The Excel files sent to SOE Bucher in 2018 contained 23 columns of data for each voter, but no social security numbers or driver's license numbers. These two points are not essential to give a double voter notice that their "eligibility to vote" in Florida is in question and to provide each of them a "due process" notice and hearing in which the voter can explain where their voting residence is and clear up where they are going to vote in the future.

Talking Points:

When Did Assimilation Become so Bad?

Was Tom Brokaw's statement racist or is that the radical left making it all up?

Veteran newsman Tom Brokaw recently made news for making what were termed as racist remarks against Hispanic students during an appearance on NBC's Meet the Press. He had suggested that immigrant Hispanic students should do a better job of assimilation by learning English as expeditiously as possible.

He specifically said, "You know, they ought not to be just codified in their communities but make sure that all their kids are learning to speak English, and that they feel comfortable in the communities. And that's going to take outreach on both sides, frankly."

What appears to have been intended as helpful advice to these new or future American citizens was seized upon by the left-wing politically correct *policia* as derogatory racist remarks. Being a good and loyal guilt motivated liberal, Brokaw responded to the criticism with a series of *mea culpa* tweets that began with, "I feel terrible a part of my comments on Hispanics offended some members of that proud culture."

In follow-up tweets, Brokaw further lamented his self-inflicted indiscretion. He tweeted: "I never intended to disparage any segment of our rich, diverse society which defines who we are."

Brokaw was politely challenged by PBS correspondent and frequent panelist on left-wing media, Yamiche Alcindor, who said: "We also need to adjust what we think of as America. You're talking about assimilation. I grew up in Miami, where people speak Spanish, but their kids speak English. And the idea that we think Americans can only speak English, as if Spanish and other languages wasn't always part of America, is, in some ways, troubling."

Of course, Brokaw did not say—or even intimate—that young Latinos should ONLY speak English. Being bilingual has always been considered an asset in our diverse American culture. Why else do we teach languages in our school systems? Duh! But for the left-wing media, spin always trumps accuracy and truth.



For a time, it seemed like every left-wing Hispanic interest group and media was devoted solely to trashing Brokaw—and for a dyed-in-the-wool liberal, being criticized by minorities can be an ego-crushing and career ending experience.

LatinRebels.com founder Julio Ricardo Varela whined that the Meet the Press segment was



"difficult to watch." He called it, "a punch in the gut to a lot of people. It was not only factually incorrect, it was also xenophobia in action." For a guy whose organization sounds like one of those street gangs I recall from my days in Chicago—and who administer punches to the gut that are not figurative—Varela sounds like a bit of a *copo de nieve*.

CNN's ever-present panelist, Maria Cardona expressed her "love" for Brokaw, but said he is a bit out of touch—which in liberal-speak means he is an old white guy. Or as she put it, "I'll give him a pass because he's probably not up to speed as to where things are today and age, especially with young Latinos in this country."

In an example of minority media hyperventilation, Aura Bogado, at Reveal, accused Brokaw of "arguing classic white supremacist talking points in a deeply racist rant on national television."

The National Association of Hispanic Journalists were particularly harsh on their Fourth Estate colleague. The organization's President Hugo Balta—also a senior producer for MSNBC—said that assimilation is "denying one culture for another." In other words, assimilation is a big bad thing.

How did this happen?

For the better part of 200 years, America was a culture of assimilation symbolized in words and graphics by the "melting pot." It seemed to have stemmed from the national motto with which the Founders christened America—*e pluribus unum*—which translates "out of many, one."

This was not some advertising-style slogan. It was a profound statement through which the Founders envisioned their new civic creation. It was designed to influence the culture forever more.

In these three simple Latin words, the remarkable men who crafted the Declaration of Independence and the Constitution recognized that America was a process into which newcomers could bring their backgrounds and skills and yet

become part of one unifying culture. It was at the onset and forever to be a society of immigrants.

For two centuries, virtually every new immigrant wanted to be like an American—to BE an American. It was more than a name on a citizenship certificate. It was the embrace of the greater culture of freedom and opportunity. America was the place where they could provide their labor in return for the hope of a better life for them—and especially their children. They were eager to learn American history and speak English—often needlessly apologizing for their foreign accent.

They would initially gather in ethnic conclaves for a generation or two. That is why my hometown of Chicago was often called the "city of neighborhoods"—each with its unique ethnic composition. But the first settlers were more than willing to watch their children move away—physically and socially—into the greater American culture. That was assimilation. That was the melting pot. After a generation or two, their ethnicity was homogenized by inter-ethnic marriages and their ancestry—or ancestries—just a matter of personal interest. They evolved into ethnic Americans.

The melting pot was not a one-way process. Even as the immigrant families assimilated into the unique American culture, they added a bit of their own ingredients (culture) to the pot—their food, their music, their religious customs and the fashions. All those things became part of the evolving American culture—but at the core, there remained a fixed set of dominant values.

This began to change in the last half of the twentieth century. Thanks to the political characteristics of liberal ideology, the assimilation process was resisted by a concept of identity politics and tribalization—a culture in which permanent ethnic identity takes precedence over assimilation.

The melting pot is replaced by a bucket of rocks—a white rock, black rock, brown rock, red rock and yellow rock—never to congeal into a common culture, but to be ever more managed as competing forces within our national boundaries. The political management of these political competitors is the foundation of power of the radical authoritarian left.

Many on the left and in their media echo chamber like to blame President Trump for the acrimony and divisiveness in today's America. While it is arguable that his acerbic and pugnacious personality have not been a positive contribution to national unity and harmony, the wellspring of tribalism, goes back decades and is largely the resolute of the modern progressive movement and its emphasis on identity politics.


Since the 1960s, the left has been engaged in the I-winyou-lose game with the race card in constant play. They push aside the obvious overwhelming harmony and tolerance of the American people to create false enmities. They speak against various and sundry "isms" while creating their own class of stereotypical enemies—white people (especially we older men with our "toxic" genes), people of faith, business people and almost anyone who is rich and does not donate to left-wing causes.



With its people, contacts and experiences in the intelligence and national security arenas, and its concept of two-way dialogue with its members, CFNS offers an efficient forum and format that bring the general public into the national security mix. It also serves as a vital resource for law enforcement officials, the intelligence community, and lawmakers.

Sunday's seminar presenter was Dr. Laurie Cardozo-Moore. She is the founder and president of Proclaiming Justice to The Nations (PJTN) which educates, advocates, and activates Christians, Jews and all people of good conscience in building a global community of action and prayer in support of Israel and the Jewish people. She is Special Envoy to the United Nations for Human Rights and Anti-Semitism, representing 44 million members of the World Council of Independent Christian Churches. Opinion: FAU Should Stop Forcing Student Organizations to Attend Their 'Leadership' Conferences

From political bias to the endorsement of false facts, FAU's Lead and Serve conferences are not about leadership, nor do they promote diversity.

As a leader of a bipartisan student organization called Right on Campus, which creates political opinion magazines, I was required to attend WeLead: Diversity Matters Student Leadership Symposium in Spring 2018.

WeLead is a seminar on diversity and was something I was actually looking forward to attending.

We are lucky to study at Florida's most diverse public university. With over 30,000 students and hundreds of faculty members, we have the opportunity to learn from people of differing races, cultures, ethnicities and beliefs.

Yet, during my attendance at WeLead, an event that is advertised to promote diversity, I was shocked to find out that the focus of the conference was taught entirely from one political perspective, from the keynote speaker right down to the smaller "breakout" sessions.

My first experience at WeLead opened my eyes to how politically biased their conferences are

It did not take long for me to realize that WeLead wasn't focused on diversity or inclusion at all.


The first event of the conference was a keynote speech from Rosa Clemente, a self-described activist and former Green Party vice presidential candidate.

Shortly after her speech began, she went on an anti-Trump rant that berated white women who voted for Trump and called Republicans racists. Clemente taught us that if you do not agree with her political beliefs, you must be a racist or bigoted person.

While I was well aware of how divisive the political atmosphere from the 2016 election had been, I was hoping that if her speech were to be political it would be one about putting aside our differences and coming together as fellow Americans.





Perhaps FAU wasn't expecting Clemente to give such a bigoted speech, but even a quick review of her social media gives away her hateful nature.

One month before her speech at FAU, Clemente posted a picture on Instagram featuring a coffee cup with "WHITE TEARS" written on it in bold lettering. The caption says "... you crazy white supremacist pedophile loving Trump supporters can sit down, shut the fuck up and put your tears in this cup."

And two months before that post, she had uploaded a picture on Instagram of a poster that reads "Fuck the US Military." More recently her retweets have even included disgusting rhetoric that I feel is anti-Semitic, such as "Fuck Zionism," which is a movement supporting the independence of Israel.

This means our school either did not bother to do any research about who they were inviting to speak, or knew whole-heartedly just how hateful she is and thought she would be great for a speech about promoting diversity.

"The committee does not control the content of any particular speech, and does not select speakers on the basis of political ideology," Joshua Glanzer, the FAU Media Relations representative said about the speaker selection process.

Yet it seems evident that the university is well aware of Clemente's political ideology since the current WeLead 2019 website describes her as "one of the most raw, honest, political, social and cultural voices in the country."

I suppose I was unaware that Clemente's unrelenting bigotry qualifies her to be "a cultural voice in our country," as FAU so claims. I reached out to Rosa Clemente for comment, but she did not respond as of publication time.

I'm not the only one who is disappointed

It should be noted that conservative students weren't the only ones who took issue with the content of Clemente's speech.

"Clemente was speaking about a lot of issues with left-leaning viewpoints, and although I agreed with her on parts, it has no place at a forced diversity conference held by the school," Hannah Schimko, a sophomore marketing major and the social media director for FAU Young Democratic Socialists of America, said.

"The event should be nonpartisan" she added. "It's an event about diversity, not politics left or right."

A student who ran one of the "breakout" sessions at WeLead after Clemente's speech, who chose to remain anonymous, called her keynote speech a "disgrace."

"FAU sanctioned a bigot to speak at an event that the school hosted and forced students to attend. By extension, the university was foisting hateful rhetoric on us," he said. "It was mildly surprising to see how many people, including staff, agreed with her. It was sad, disturbing, and utterly disappointing to see so much hate accepted in public."

The smaller sessions ran by FAU faculty and students were just as one-sided

During iLead, a different conference that is advertised to focus on leadership in Fall of 2018, I attended a breakout session titled "Healthy Leaders." I soon found out that the true intention of this session was to promote political correctness—as opposed to actually encouraging awareness about how to live a healthy lifestyle.

Shortly into the presentation, which was conducted by FAU faculty who were not physicians, we were told irresponsibly that one's body mass index (BMI) has no reflection on whether or not they're healthy. We were additionally told that you can be healthy at any size.

These were irresponsible statements that are undeniably opposed to commonly accepted facts within the medical community.

The American Heart Association's website asserts that "for every additional unit of BMI, there was a slight increase in blood pressure readings and in the thickness and size of one of the heart's main pumping chambers," which leads to heart problems.

The idea that BMI has no reflection on one's health was taught to us in our session about preventing "fat shaming"—which we were lectured on for almost an hour.

I reached out to Jill Rubin, a coordinator from the Women and Gender Equity Resource Center who was one of two presenters during the Healthy Leaders seminar, but she did not respond in time for publication.

During a breakout session at WeLead, the presenters encouraged us to introduce ourselves. They told us we should begin our introduction by stating "what gender we identify as." This appeared as yet another instance of forcing students to abide by politically correct terminology that aligns with left-leaning viewpoints.

I reached out to Lead and Serve, who are involved in organizing both iLead and WeLead, but they did not respond in time for publication.

The university should be using the event's focus on diversity to challenge multiple viewpoints not just one

FAU anticipated "the possibility . . . that attendees may be exposed to views that are controversial or contrary to their own deeply held beliefs," Glanzer said. "As an institution of higher learning, we always encourage students to challenge those ideas, while treating members of the university community and our guests with respect and civility."

But is a speaker who berates students and calls them bigots for supporting a candidate that they disagree with truly teaching us to treat others with "respect and civility"— and is a political tirade really the right way to challenge students deeply held beliefs?

If FAU wants to challenge conservative students' beliefs—which they have every right to—then they also have an equal responsibility to challenge liberal students' beliefs.

I reached out to the Center for IDEAs, formerly known as the Office of Diversity and Multicultural Affairs, who was involved in selecting Clemente, but they did not respond in time for publication.

If FAU wants to keep their conferences politically biased, then our attendance should not be mandatory

As a defender of free speech for all people, I have absolutely no problem with having Clemente speak on our campus.

If FAU wants to host a conference that is politically biased—one that promotes groupthink rather than true diversity of thought—I am completely ok with that.

But if they are going to do this, the mandatory attendance of all student organizations should not be required. Better yet, they could make their next WeLead conference, on January 26th, actually embrace diversity by having speakers who teach from different political perspectives.

The diversity of our students extends farther than just our differences in skin color. FAU's political thought is also diverse, as indicated by the plethora of different political student organizations that we have on campus.

If the opinions of our students are so diverse, then the curriculum and speakers present at iLead and WeLead should be too.

Attendance rules for student organizations

Attending both conferences requires major time commitments that have strong penalties if you do not attend.

FAU requires two members from all registered student organizations to attend an iLead conference each semester. The conferences take place on either Friday or Saturday and

Book Review

Magna Carta, The Birth of Liberty, by Dan Jones. New York: Penguin Books, 2015. Softcover, 272 pp. ISBN No. 9780143108955.


This book is about a most important subject: Magna Carta, to this day, "admired as a foundation stone in the Western traditions of liberty, democracy, and the rule of law." I like the author, Dan Jones, and have read other books by him, namely *The Plantagenets* and *The Wars of the Roses*. The former tells the story about early kings of England while the latter chronicles their fall and the rise of the Tudors, who succeeded them. Reading both before digging into *Magna Carta* was useful in that it gave one an idea of historical context for the revered document that many regard as the birth of western liberty.

The Magna Carta document itself "is dry, technical and difficult to decipher and should be of interest only to serious scholars of the thirteenth century, yet it is one of the most hallowed documents in the world, revered from the Arctic Circle to the antipodes and written into the constitutions of numerous countries." Why it is regarded with such reverence is the story of this book. By the way, the entire text of Magna Carta is included as an appendix in the back of the book. I read it and as the author says, it's "dry and technical," but there to peruse if you care to.

Magna Carta was a peace treaty between John, the third Plantagenet king of England, and his barons, who feared the king's tyrannical power and sought to restrain it. The charter agreed to at Runnymede in June of 1215 threatened that the barons would withdraw their support for the king if he failed to live up to his promises in the document. In essence, it was an attempt, if you will, to force the king to give up some of his omnipotent power and "that fateful day in the meadow at Runnymede over eight hundred years ago

has become, in a sense, year zero in the story of the struggle for freedom from tyranny."


And tyrannical those times in England in the early 1200s certainly were. Back then "the king made the laws," but with the advent of Magna Carta, "he had to obey it as well. For the first time in English history, a mechanism was created that allowed the community of the realm to override the king's authority, when that authority was abused."




Amazingly there are four surviving copies of the original Magna Carta document still in existence today. One is at the British Library, another at the Lincoln Cathedral, and a third at the Salisbury Cathedral. I've seen the fourth copy, which is at the U.S. National Archives in Washington, DC. It was purchased at auction for over \$20 million in 2007. Fragile, it thus "sits, dimly lit, as the physical and metaphorical starting point for the history of American freedom. It is captioned with a quotation from President Franklin D. Roosevelt, who claimed that "the democratic aspiration is no mere recent phase in human history. . . . It is written in Magna Carta."

In 1687 the Magna Carta was published in the American colonies for the first time and over a hundred years later in 1775, "Massachusetts adopted as its symbol an American patriot holding a sword in one hand and the Magna Carta in the other." As Americans, it is important that we all have an understanding of why they did that and reading Dan Jones's book, *Magna Carta*, *The Birth of Liberty*, is a great place to start.

The Threat of Sino-Russian Condominium

uring much of the Cold War, the greatest existential threat to the United States was thought to be an alliance between the Soviet Union and the People's Republic of China based on their mutual communist ideology. Many in the West believed that just such an alliance existed, but as the decades passed, fewer and fewer observers held to that view. For one thing, animosity and distrust, borne of centuries-old historical disputes, boiled over into a brief border clash between the two communist giants in 1969, which resulted in thousands of casualties among their solders. But whether a formal alliance existed back then or, for that matter now, doesn't really matter. The fact is that the two countries share a mutual ambition to increase their own power and influence in the world, and believe that the only way to realize those goals is by jointly cooperating in an effort to weaken the power and influence of the one country capable of thwarting those ambitions—the United States of America. Call it what you will, the two great powers, at the very least, are engaging in a marriage of convenience at our

expense, and the danger to us is on the rise as the military might of China increases with every passing year.

According to multiple media outlets including the BBC and *The Guardian*, China, Russia and Cuba are reopening a joint military base at Lordes, Cuba, which is near Havana. *The Guardian* reported during a recent visit to Latin America,



Russian President Vladimir Putin: "... signed agreements to establish positioning stations in Argentina, Brazil and Cuba for Glonass, Russia's answer to the United States' global positioning system (GPS). He also made a surprise stop to discuss placing a Glonass station in Nicaragua, where president Daniel Ortega called Putin's first visit to the country a "ray of Light." The goal of Putin's visit to Cuba, Nicaragua and Argentina was to "strengthen geopolitical connections with Latin America in response to the United States' attempt to isolate Russia," Alexei Pushkov, the chairman of the foreign affairs committee in Russia's parliament, tweeted after the trip.

Also "reportedly China signed an agreement in 2000 with the Cuban government to use Cuba's satellite intercept facility at Bejucal, the facility, located near the Russian facility at Lourdes, [where] in addition to other infrastructure, a possible missile launching platform is present." Given our

recent exit from the Reagan era Intermediate and Short Range Nuclear Weapons treaty due to Russian violations, if there really is a possible missile base there, any rampedup Sino-Russian activity would be most alarming.

In an article penned three months ago, highly-respected Georgetown University Foreign Affairs Professor Robert Sutter wrote that "Presidents Xi and Putin met in September for the third time [in 2018]. The two leaders spend more time together than any other two world leaders [and] the values and outlook of [those] authoritarian leaders in Moscow and Beijing converge in opposition to U.S. interests and goals."

Back in the 1950s, the Soviet Union was the senior partner, while Communist China played the role of junior partner in their relationship, but today, their roles have reversed and China leads while the Russian Federation, the truncated successor to the U.S.S.R., follows. Increasingly they are moving as one to confront us, and all other foreign policy challenges to our security pales in significance compared to the threat arising from growing Sino-Russian cooperation. That cooperation is occurring all over the world and it is incumbent upon the United States and its allies to work together to forestall the alignment and spoil the ambitions of the world's two greatest dictatorial powers.
