2020 State of the Union Address: What the Democrat Party Does Not Want You to See and Hear

Every year at this time we report on the President's annual State of the Union Address, but this year's speech and presentation to the American people by President Trump was one for the ages. In all my 72 years I've never seen anything like it, so I've decided to do my best in giving you a sense of what got Nancy Pelosi, Chuck Shumer and the rest of their Dem gang so hot under the collar. I can tell you right now, in my humble opinion it wasn't so much the President's citing of his administration's many accomplishments over the past three years, such as the resurrection of the American economy and record low unemployment numbers among African Americans, Hispanic Americans, women, etc.

No, the thing that stirred them up with furious anger like a disturbed hornet's nest was his unprecedentedly effective use of something started by Ronald Reagan decades ago and used to some extent by all presidents ever since, that being his invited guest list. survived and one of them was saved by Lenny Skutnik, a Congressional Budget Office employee, who jumped into the freezing river and pulled the drowning woman to safety. Honoring the man at the State of the Union speech was richly deserved and began a tradition of powerfully emotional visual images for the American people during this annual report to the nation.

But no president has come anywhere near perfecting it until Donald Trump gave his address this year, and no one knows that more than the Democrats, who sensed its effectiveness in conveying the president's message to the American public, and that is the real reason why Nancy tore up the speech.

Most of what follows is from CP Reporter Samuel Smith and his presentation of the President's featured guests is the best thing I've seen to give one a sense of the undeniable emotive power of President Trump's 2020 State of the Union address.

Opportunity Zones Beneficiary Tony Rankins



While touting an Opportunity Zones initiative created by the 2017 tax law to provide tax incentives for investment in low-income communities, Trump said that jobs and investments are pouring into 9,000 “previously neglected” neighborhoods nationwide.

“In other words, wealthy people and companies are pouring money into poor neighborhoods or areas that haven’t seen investment in many decades, creating jobs, energy, and excitement,” Trump said. “This is the first time that these deserving communities have seen anything like this.”

Trump noted that the initiative is helping Americans like Tony Rankins from Cincinnati, Ohio.

“After struggling with drug addiction, Tony lost his job, his house, and his family. He was homeless. But then Tony found a construction company that invests in opportunity zones,” Trump said. “He is now a top tradesman, drug-free, reunited with his family, and he is here tonight. Tony, keep up the great work.”

Venezuelan Opposition Leader Juan Guaido



Trump declared that U.S. leadership is “once again standing up for freedom in our hemisphere.” He assured that the U.S. is supporting the hopes of Cubans, Nicaraguans and Venezuelans to “restore democracy.”

“The United States is leading a 59-nation diplomatic coalition against the socialist dictator of Venezuela, Nicolas Maduro.” Trump said, calling Maduro an “illegitimate ruler” who “brutalizes his people.” Trump declared that Maduro’s “grip on tyranny will be smashed and broken.”

“Here this evening is a very brave man who carries with him the hopes, dreams, and aspirations of all Venezuelans,” Trump said. “Joining us in the gallery is the true and legitimate President of Venezuela, Juan Guaido.”

Since the 2019 election, Guaido has received the backing of the National Assembly and dozens of foreign governments. However, Maduro has maintained control.

“Please take this message back that all Americans are united with the Venezuelan people in their righteous struggle for freedom,” Trump assured Guaido. “Thank you very much, Mr. President.”

Tuskegee Airman and His Great-grandson



Trump touted the fact that his administration became the first since President Harry Truman’s to create a new branch of the U.S. military called the Space Force.

He then recognized 13-year-old Iain Lanphier who aspires to go to the U.S. Air Force Academy in Colorado and “has his eye on the Space Force.”

“As Iain says, ‘Most people look up at space; I want to look down on the world,’” Trump said.

Then, Trump recognized Lanphier’s great-grandfather, Charles McGee. McGee, who turned 100 in December, and is one of the last surviving Tuskegee Airmen, a group of African American fighter pilots who served in World War II.

“After more than 130 combat missions in World War II, he came back home to a country still struggling for civil rights and went on to serve America in Korea and Vietnam,” Trump said of McGee. “On December 7th, Charles celebrated his 100th birthday.”

Trump explained that he signed a bill a few weeks back promoting McGee to Brigadier General. “[E]arlier today, I pinned the stars on his shoulders in the Oval Office,” Trump explained. “Gen. McGee, our nation salutes you. Thank you, sir.”

Fourth Grader Awarded School Choice Scholarship



Trump told Congress that to build an “inclusive society,” the U.S. must ensure that every American gets a “great education and the opportunity to achieve the American dream.”

However, Trump stressed that too many children for too long have been “trapped by failing government schools.”

Trump praised the 18 states that have passed school choice in the form of opportunity scholarships. Trump said that the programs are so popular that tens of thousands of students are on a waiting list.

Trump recognized one of those students, fourth-grader Janiyah Davis from Philadelphia, and her mother Stephanie Davis. According to the White House, Davis loves art and math but has been assigned to “low performing schools.”

Rush Limbaugh



One of the biggest surprises of the evening was the presentation of the Presidential Medal of Freedom to conservative political radio host Rush Limbaugh by First Lady Melania Trump.

Limbaugh announced this week that he has been diagnosed with advanced-stage lung cancer.

Limbaugh was seated right next to first lady Melania Trump in the House gallery when he was recognized by the president.

Girl Born at 21 Weeks and Her Mom

As expected, Trump again called on Congress to ban late-term abortion. In doing so, Trump honored 2-year-old Ellie Schneider and her mother, Robin.



In 2017, Schneider became one of the earliest premature babies ever to survive when she was born at just 21 weeks and six days of pregnancy. At the time of birth, Trump said, Schneider weighed less than a pound.

“Ellie Schneider was a born fighter,” Trump said. “Through the skill of her doctors—and the prayers of her parents—little Ellie kept on winning the battle of life. Today, Ellie is a strong, healthy 2-year-old girl sitting with her amazing mother, Robin, in the gallery. Ellie and Robin, we are so glad to have you with us tonight.”

Trump’s call for a ban on late-term abortion drew a supportive fist pump from Robin Schneider.

“Whether we are Republican, Democrat or independent, surely we must all agree that every human life is a sacred gift from God,” Trump said.

Brother of American Killed by a Criminal Illegal Immigrant



Trump used his speech to continue criticizing states and localities that are providing “sanctuary” to illegal immigrants.

“In sanctuary cities, local officials order police to release dangerous criminal aliens to prey upon the public, instead of handing them over to ICE to be safely removed,” Trump said.

He called out the state of California, which became a “sanctuary state” in 2018. “In December 2018, California police detained an illegal alien with five prior arrests, including convictions for robbery and assault. But as

required by California’s sanctuary law, local authorities released him,” Trump said.

“Days later, the criminal alien went on a gruesome spree of deadly violence. He viciously shot one man going about his daily work. He approached a woman sitting in her car and shot her in the arm and in the chest. He walked into a convenience store and wildly fired his weapon. He hijacked a truck and smashed into vehicles, critically injuring innocent victims. One of the victims is a terrible, terrible situation. Died, 51-year-old American named Rocky Jones.”

Trump then gave recognition to Jones’ brother, R. Jody Jones, sitting in the gallery.

Border Patrol Officer Raul Ortiz



The President explained that in the last three years, Immigration and Customs Enforcement has arrested 5,000 human traffickers as his administration has “undertaken an unprecedented effort to secure the southern border of the United States.”

“Before I came into office, if you showed up illegally on our southern border and were arrested, you were simply released and allowed into our country, never to be seen again,” Trump said. “My administration has ended catch-and-release.”

He declared that immigrants who come illegally will be “removed” from the U.S. As a result of agreements with Mexico, Honduras, Guatemala and El Salvador, Trump said that border crossings are down 75 percent since May 2019.

Trump recognized Deputy Chief Border Agent Raul Ortiz, whom he met during a visit to Texas last year. “Over the last 24 months, Agent Ortiz and his team have seized more than 200,000 pounds of poisonous narcotics, arrested more than 3,000 human smugglers and rescued more than 2,000 migrants,” Trump said. “Days ago, Agent Ortiz was promoted to Deputy Chief of Border Patrol, and he joins us tonight.”

“A grateful nation thanks you and all the heroes of Border Patrol and ICE,” Trump added.

Parents of American Christian Aid Worker Killed by Islamic State

One of Trump’s 2016 campaign promises was to defeat the Islamic State in Iraq and Syria. Although IS once con-



trolled over 20,000 square miles in Iraq and Syria three years ago, Trump said in his speech that the extremist group’s “territorial caliphate” has been “100 percent destroyed.” He also emphasized the fact that IS leader Abu Bakr Al-Baghdadi was killed last October.

Trump recognized the parents of Kayla Mueller, a Christian aid worker who was raped and murdered by IS in Syria in 2015. It was reported that Mueller was the personal prisoner of Baghdadi before she was killed at the age of 26.

“We are joined this evening by Carl and Marsha Mueller. After graduating from college, their beautiful daughter, Kayla, became a humanitarian aid worker,” Trump explained. “She once wrote, ‘Some people find God in church. Some people find God in nature. Some people find God in love. I find God in suffering. I’ve known for some time what my life’s work is, using my hands as tools to relieve suffering.’”

Trump explained that the U.S. Special Forces operation that resulted in the death of Baghdadi was named “Task Force 8-14.” The 8-14 is a reference to Mueller’s Aug. 14 birthday.

“Carl and Marsha, America’s warriors never forgot Kayla, and neither will we,” Trump said.

Family of a Fallen Soldier



Trump gave recognition to the family of Staff Sgt. Christopher Hake—his widow Killi Hake and her son Gage—who was killed by a roadside bomb in his second deployment to Iraq in 2008.

Trump quoted a letter that Hake wrote to his son in 2008 promising to teach him how to ride a bike and build his first sandbox.

“Sergeant Hake now rests in eternal glory in Arlington. And his wife, Kelli, is in the gallery tonight, joined by their son, who is now 13 years old and doing very, very well,” Trump said. “To Kelli and Gage, Chris will live in our hearts forever. He is looking down on you now. Thank you.”

The President pointed out that the roadside bomb that killed Sgt. Hake was placed there on orders of Iranian terrorist leader Qasem Soleimani who was an Iranian major general in the Islamic Revolutionary Guard Corps. Soleimani was killed in a targeted attack by the U.S. military earlier this month following several attacks against the U.S. and allies in the Middle East orchestrated by Soleimani.

Family of a Deployed Service Member



Another special moment occurred when Trump gave recognition to military spouse Amy Williams from Fort Bragg, North Carolina. Trump told the audience that Williams works full time and volunteers to help other military families.

Williams’ husband, Sgt. 1st Class Townsend Williams, has been stationed in Afghanistan on his fourth deployment to the Middle East. “Amy’s kids haven’t seen their father’s face in many months,” Trump said. “Amy, your family’s sacrifice makes it possible for all of our families to live in safety and in peace. And we want to thank you.”

Trump then told Williams that they had a “special surprise” for her family.

“I am thrilled to inform you that your husband is back from deployment,” Trump said. “He is here with us tonight. And we couldn’t keep him waiting any longer.”

Williams walked down the steps of the gallery and greeted his wife and children as they celebrated his return. The Williamses then got hugs and handshakes from Melania

Trump as members of Congress chanted “USA! USA! USA!”

The president was more than just prepared for his momentous report to the American people on the State of our Union. When he first took office three years ago, he was obviously unaccustomed to reading from a teleprompter, and it showed each time he used the device. But this year’s speech in the U.S. House of Representatives was delivered smoothly and with the confidence of a leader who knows he’s done a good job for his country.

For most of the emotionally-charged moments of this superb speech, when the president’s guests, who any idiot could see were deserving of bipartisan applause from a grateful nation, Democrats could be seen scowling and sitting on their hands, and then, after the President concluded his remarks, Nancy Pelosi, Speaker of the House of Representatives tore up the address to the nation. Most media outlets reported that it was in response to his neglecting to shake her hand at the outset, but that was misleading. In her opening introduction of the President, she insultingly and intentionally left out the words “my high honor and distinct privilege” which all previous speakers have traditionally done. Session Updates Weeks 3 and 4

WEEK 4 was another busy week, as most Subcommittees met for the last time. This means that we will begin to spend more time focusing on the budget and on the floor passing bills that have been heard in their respective committees.

On the House floor lawmakers passed several bills, including one that would stop homeowner and condo associations from preventing law enforcement vehicles from parking in residential and guest spots. The next floor session is set for Wednesday, February 12th at 2:30. Watch it live at The Florida Channel.

House members took part in several other meetings where they moved legislation through committees that will make positive changes for Floridians. One of those bills is HB 1205 which we voted on in our Insurance and Banking Committee on Tuesday. Health Care providers have some flexibility in discussing costs with patients, but there may be cases when a provider's contract with an insurer limits communication related to costs of care. In committee, we approved HB 1205 to ensure open communication. This bill prohibits a health insurer or HMO from limiting the ability of any provider to discuss pricing information with a patient, ensures that insured patients do not pay more than an uninsured patient for a health care service, and safeguards a patient's right to open communication with providers regarding costs of care.

As health care costs continue to rise, many health insurers are asking consumers to take on a greater share of their costs by increasing premiums and out-of-pocket expenses. Patients should have the information they need to be able to choose less expensive health care services—or even pay for a service themselves, rather than using insurance, if it's less expensive.

Three of the bills I filed this session were heard in committee last week. HB 649: Patient Brokering and HB 1089: Trusts unanimously passed the Civil Justice Subcommittee. HB 1213: Holocaust Education unanimously passed the PreK-12 Appropriations Subcommittee. Each bill has one more committee stop before it is ready to be heard by the full House on the floor. You can learn more about any of these bills by clicking on the bill number.

WEEK 3—The Florida Capitol last week got a facelift; streamers of colorful crayon-stained construction paper cutouts cascaded from the third-floor rotunda, signaling the 25th anniversary celebration of Children's Week. I have to admit that it's not only the most beautifully decorated week in the Capitol, but it's also the week when we have the most adorable visitors.

In the spirit of the theme, we considered many policies that empower Florida families and help kids in the process. In committees, lawmakers approved sweeping reforms to the state's child welfare system and improvements to school security. During Wednesday's House floor meeting, we passed several bills, including one to protect public school student athletes from deadly heat strokes by requiring schools to have life-saving cooling tubs or pools available. As a parent of former student athletes, I was proud to vote for this good bill. You can read more about HB 7011: K-12 Student Athletes here.

Two bills I filed passed their initial committees last week. HB 1213: Holocaust Education unanimously passed the PreK-12 Innovation Subcommittee. This bill will allow the Florida Department of Education to work with the Florida Holocaust Museum and other expert institutions to develop instructional materials for Holocaust education. It also adds a requirement for the study of anti-Semitism, and an annual report from each school district and charter school to the Department of Education, with evidence, that Holocaust Education requirements are being met. This bill now heads to the PreK-12 Appropriations Subcommittee.

HB 1371: Traffic and Pedestrian Safety unanimously passed the Transportation and Infrastructure Subcommittee. As I wrote last week, this bill aims to increase safety for pedestrians and drivers at crosswalks by eliminating the confusion that is causing wrecks and costing lives. It now heads to the Transportation and Tourism Appropriations Subcommittee.

- Allow immigration judges to consider a person’s individual circumstances during deportation proceedings, allowing more people to remain with their families and move forward with their lives without fear that an old offense could lead to deportation.
- Allow independent federal judges to review certain decisions of immigration judges that the 1996 laws unfairly tried to remove from judicial oversight.
- End federal prison sentences and criminal prosecutions for people who cross the border seeking freedom, safety, opportunity, or to reunite with their families.
- Advance racial justice and address obstacles to equal justice in the criminal legal system by limiting deportation for drug convictions and other offenses that result from enforcement that disproportionately targets communities of color.

- Protect communities and local resources by ending the harmful practice of local police acting as deportation agents or carrying out mass deportations with ICE.
- Allow people previously ordered deported to apply for the opportunity to come home.

At the bottom of the home page is the following statement. The site says it is supported by: The Immigrant Defense Project, The National Immigration Project & The Immigrant Legal Resource Center | Site Implementation by Akiva Rubin

Tucker Carlson got all worked up about this development on February 6 and 7 on his TV show. He said, “The New Way Forward Act is the most radical single piece of legislation we’ve seen proposed in this country. It would allow criminals to move to the U.S. and settle here permanently.” Now that you know more about what these House Dems want to do, maybe you will want to ask the two Florida Representatives, “What are you doing?”

Republican members of the Congress will probably not support these 43 House members’ ideas in H.R. 5383, but you may want to find out for sure. This is an issue that you and your Congress members need to understand.

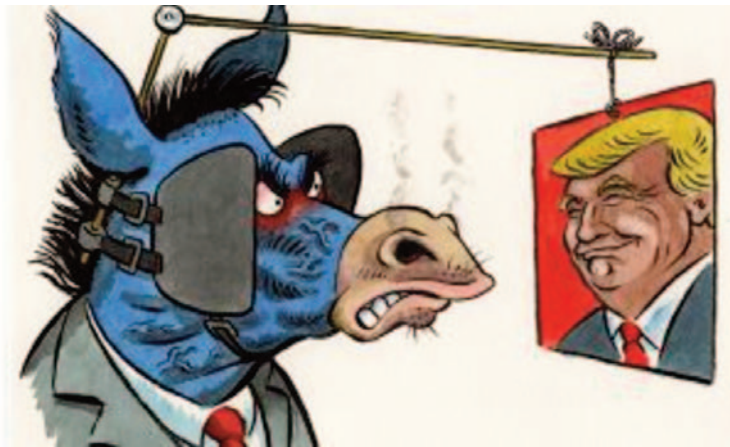

Dems Losing Their Black Sheep

I am a fourth-generation Republican, so never needed the Walk-Away movement. And it is a misconception that all Blacks came to America as slaves, because my family background shows something entirely different, as you will see if you keep reading.

We have officially traced my family history back many generations to the time that my ancestors came to this country. On my father’s side, they came to America from Portugal as businessmen and landowners, and established a homestead by opening a large fruit farm in northern Illinois, where they became Republicans. My father’s family eventually sold their land to housing developers, and used the profit, in part, to help finance their political beliefs. When I was little, and went to visit my fraternal grandparents in Rockford, Illinois, they schooled me in politics, as they were “movers and shakers” in the Winnebago County GOP, introducing me to people who came to visit my grandpar-

ents’ home, like longtime, powerful, and famed Republican Senator, the late Everett Dirksen, and many others.

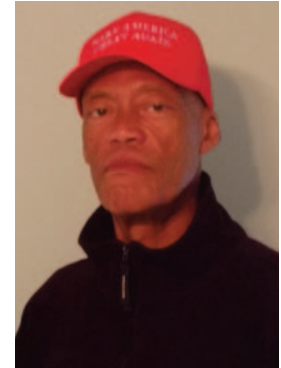
I had the above history on my father’s side, but also know the history on my mother’s side of the family. My mom’s immediate family lived, and many relatives still live, in Salisbury, North Carolina, before moving north to Massachusetts, where I was born, and that family side is a bit more complicated . . . **“But, None the Less TRUE.”**

My mother’s family came free to America from Sierra Leone as farmers, buying land, then tilling the red clay of North Carolina, before selling the valuable farmland that would eventually border on Livingstone College in Salisbury. Now, here is where my background becomes complicated, to say the least.

My great grandfather—based on “word of mouth” stories, recorded documents, and since discovered, and officially “recovered and recorded” evidence from his Salisbury Old English Cemetery gravesite—was John Ellis, the one-time white Governor of North Carolina. Ellis, who was a native of Salisbury, served as Governor from 1859 until 1861, when he died in office. The man had two legally recognized wives in his lifetime, but was known as a handsome charmer and “ladies man” who reportedly had several affairs, one being with my great grandmother. That “relationship” produced a child, my grandmother, who was so light, and fair skinned, that she looked white, but who always carried herself as a proud Black mulatto woman. She passed that proud trait on to those in my maternal line who followed her, including my mother, who had very fair skin, but had a tough character, which came in handy as the high school English teacher she became. That family lineage is where I get my skin’s fair complexion from. My maternal grandfather fell in love with, and married my grandmother, then moved the family north, where he eventually became the first Person of Color to own an automobile dealership in the Commonwealth of Massachusetts.

John Ellis, my great grandfather, was the Democrat Governor of North Carolina during the Civil War, who led the state to Secede from the Union, and to my knowledge, and family history . . . **is the only registered Democrat of note in my family’s recorded past . . . thank God!**

I have told you all of the above to let you know that I carry myself as I do, because . . . **I have never had an historical slavery mentality or considered myself to be a**

victim . . . as I know where I came from, who I am, and where I am going!

And now, many Blacks who may not have had the same kind of positive upbringing as me, and who may not know their family history as I do, have opened their eyes to see that the Democrats have used them for the their votes for decades, but left them to struggle in deplorable communities, where education, unemployment, and crime are at the worst levels in this country. American Humane’s Annual Pups4Patriots Gala

Once again, I was delighted to attend—along with my wife Cheryl, U.S. Navy vet Steve Laine and Denise Fallabella—American Humane’s annual Pups4Patriots Gala, honoring the Pups4Patriots service dog graduates and their veteran handlers.

As I’ve said before in these pages, I love this organization. They do such wonderful work providing life-saving service dogs to veterans suffering from Post-Traumatic Stress and Traumatic Brain Injury at no cost to the veterans, saving lives at both ends of the leash.

But that’s not all they do, not by a long shot. They’ve been around a long time so let me give you a historical overview of what American Humane is all about. These are just some of the things they’ve done over the years:

- 1877—American Humane founded as the country’s first national humane organization.
- 1916—Rescued 68,000 wounded horses a month during WW I.
- 1940—Launched “No Animals Were Harmed” program to protect animals on movie sets.
- 1940—Lobbied to protect the bald eagle, which President Franklin D. Roosevelt signed into law.
- 1970—Advocated for spay/neuter programs and drew critical attention to the emergence of “puppy mills.”
- 1971—Advocated for the Marine Mammal Protection Act.

- 1985—Advocated for anti-dogfighting in Colorado, South Dakota, Wyoming and Montana.
- 1991—Developed guidelines for animal shelters to foster pets of military reservists sent to Operation Desert Storm.
- 1992—Deployed during Hurricane Andrew to save animals in Florida, Louisiana and Texas.
- 2001—Following 9/11, deployed to help protect hundreds of search-and-rescue dogs.
- 2011—Launched the Hero Dog Awards to honor extraordinary dogs.
- 2014—Assisted with the second-largest dog-fighting raid in U.S. history.
- 2015—Advocated for return of military working dogs in the 2016 National Defense Authorization Act.
- 2016—Launched the Lois Pope LIFE Center for Military Affairs.

As Megan Lowry, a former Secret Service Agent for President George W. Bush, has said, “We’re trained to fight. We’re not trained to come home.” American Humane does as much as any organization around to help the veterans of our country’s wars make that transition from the battlefield to their “tranquility base” back home here in America and you can reach them online at www.AmericanHumane.org.

Book Review

***The Fertile Soil of Jihad: Terroris's Prison Connection*, by Patrick T. Dunleavy. Potomac Books, an imprint of the University of Nebraska Press, 2011. Hardcover, 143 pp., notes, index. ISBN 978-1-59797-548-3.**

The *Fertile Soil of Jihad: Terrorism's Prison Connection*, at only 120 pages, is a small book in length, but one that packs a big punch in terms of delivery and, hopefully, in the review that follows I can give readers a sense of why that is the case.

Patrick T. Dunleavy, the author, is a former deputy inspector of the Criminal Intelligence Unit of the New York State Department of Correctional Services who worked as part of an elite team of investigators for more than 26 years, infiltrating criminal enterprises. He was a key figure in Operation Hades that probed the radical Islamic recruitment movement for jihad from both inside and outside prison walls.

As you've undoubtedly guessed by now, Mr. Dunleavy's book is about jihadist recruitment in the nation's prisons, and to probe that subject we first must get acquainted with Abdel Zaben, the central figure in that story. Zaben was born in a refugee camp on the East Bank of the Jordan River in 1969, where his parents, along with thousands of Palestinians, had relocated after the formation of the nation of Israel in 1948. As he came of age, he felt that out of all the groups (opposed to Zionism), only Hamas and Islamic Jihad were united in supporting their leaders against the Israelis.

Zaben saw the Israelis as an inferior enemy occupying force, calling them "cowards" and "pigs," and he did not separate his hatred for his enemies and his fervency for his religion: both were equally strong.

Repeatedly, with forged papers, Zaben tried to enter the U.S. where his brother lived, and eventually succeeded. A young man with a forged visa was rarely seen as the potential beginning of a "cell," that smallest of organisms representing the vanguard of a terrorist organization on foreign soil, but Zaben was just such a person. His purpose was to raise support for the Palestinian cause and Hamas in particular. The enemy at the time was Israel, not America, and the goal was liberating the occupied territories, not global jihad.

At some point, he began committing armed kidnapping and robberies. One night he was overheard by one of his victims saying about the money, "this is for the cause." Eventually he was caught and became just another prisoner in a crime-ridden city, waiting to be taken into the abyss. At Riker's Island he became an aide to the Imam and began sharing his beliefs with other inmates, seeking to convert them to Islam. According to a later CIA study: *Prisons and the Internet provide easy access for radical imams to recruit lonely, angry, incarcerated individuals who are particularly receptive to learn an anti-western form of Islam and using*

violence against a government by which they feel they have been wronged.

In prison, convicts often pursue religion as a way to give structure, purpose and hope to their lives. Any religious worker could demand to enter a prison in the New York system without restriction! Imam Sahrau, was just such a civilian chaplain. He was trained as a Wahabi Sunni Muslim by the Saudi Government and that was the philosophy that guided him in hiring other Muslim chaplains for the prison system. The philosophy is a fundamentalist version of Islam that teaches followers to adhere to a strict and literal interpretation of the Koran.

Zaben became a radical chaplain's clerk in prison for five years.

Eventually, all agencies were brought in under the umbrella of the Joint Terrorist Task Force's Correctional Intelligence Initiative Program. The goal of this new program was that, working together proactively, federal, state, and city investigators would continue to monitor radical Islamic recruitment efforts. When threats were found, they would have the ability and authority to close down the cell. But even with the mechanisms and tripwires instituted by law enforcement after the Correctional Intelligence Initiative, the fruits of Islamic radicalization in the prison environment continue to come forth.

Why is that? One reason may be adaptability. Jihad isn't a singular idea that stops when discovered; it's a cultural and religious war that has no end. Likewise, the people involved in jihad don't stop their efforts when incarcerated. They merely find another path with new and clever ways to achieve their goals.

By the way, I heard author, Patrick T. Dunleavy, speak at a seminar of the Citizens for National Security recently and would have reported on it for this newsletter, but his talk that morning was not for the record. Nonetheless, his book, *The Fertile Soil of Jihad*, published in 2011, gives you a pretty good idea of his views on the subject and is well worth your investment in time to read it.

As for Abdel Nasser Zaben, he was released from prison to the Department of Homeland Security custody in early 2005. He was deported to Jordan in 2006 and all attempts to locate him by sources in both Israeli and Jordanian intelligence have proved fruitless. His whereabouts are unknown and not all of his prison converts have been accounted for.

Book Review

***Sacred Duty: A Soldier's Tour at Arlington National Cemetery*, by Tom Cotton. William Morrow, an imprint of Harper-Collins, 2019. ISBN: 978-0-06-286315-7, 301 pp. The book is available at the Palm Beach County Public Library.**

S*acred Duty* came to my attention watching Mark Levin interview Senator Tom Cotton on his Fox News Channel TV show in recent weeks. The book was part of Levin's reason for the interview. The other major focus was to familiarize his viewers with the character and caliber of the man. Senator Cotton graduated from Harvard and Harvard Law School, worked as a lawyer, became an infantry officer, served a term in the House of Representatives, then was elected to the U.S. Senate by the state of Arkansas.

Overall the book is part history of the First American Regiment organized by George Washington as the only body of professional soldiers after the Revolutionary War, part instruction manual for future generations of U.S. Army soldiers about the procedures and use of the Arlington National Cemetery, and part a love story about the U.S. Army that Cotton was and is dedicated to serving. The text covers the assignments of the Old Guard from the beginning to the present time. The book has a prologue, six chapters, an epilogue, notes on sources and acknowledgements. An index is not included so you will have to read every word to know the subjects and people mentioned.

Cotton's family has lived in rural Arkansas for seven generations raising cattle. Cotton was born in 1977 and at 6'5" tall he was the center of his high school basketball team. He studied hard and was accepted to Harvard where he graduated with an A.B. *magna cum laude* with a senior thesis on *The Federalist Papers*. Then law school followed with a J.D. in 2002. A more complete biography is found at Wikipedia.com. But Cotton was called to duty by the September 11 attack on New York, the Pentagon and Pennsylvania by the Muslim terrorists, and he made up his mind to serve in the U.S. Army. The book tells what drove his interest in serving the infantry, not in positions in military law. After graduating from law school, he clerked for a judge, and worked briefly for two law firms to help pay for college, then he enlisted and worked his way up to Captain.

Cotton tells his story like he was dictating it in streams of thought, punctuated by events and people as time rolled on. In his acknowledgements, he gives credit to lots of people and says Cowboy helped him write the book. We are not sure who that is. In Iraq he earned a Bronze Star with the 101st Airborne Division. At the end of that tour, the Army assigned him to all-volunteer Old Guard, though he had not applied for it. He looked forward to this and worked hard to meet all of the expectations. Then he served another tour in Afghanistan before going home.

When he first ran for Congress, people wanted to know about The Old Guard, not the other things he did in the Army. Cotton says he began writing this book because he wanted to tell the story of the soldiers who dedicate themselves to our collective sacred duty of honoring those who served and died for our nation since 1784, three years before the Constitution was adopted. Also known as America's Regiment, its soldiers uphold the highest standards.

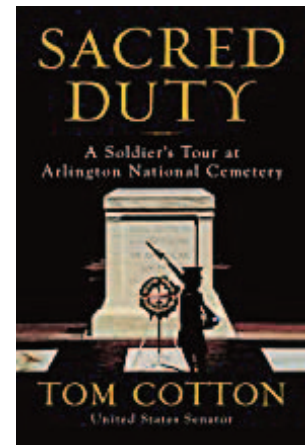
Today the Regiment conducts 20 funerals per day, each one unique, requiring continued preparation to avoid any missteps for families and observers. It conducts special ceremonies and operates the Tomb of the Unknown Soldier. The story is about how these Old Guard soldiers look, how they organize and train to assist in these services. Cotton tells the story with much detail for the reader to learn what the real deal is for the families and loved ones of the fallen. Tailored uniforms, Corfam shoes, Windex, and sole edge dressing are an ever-present part of The Old Guard.

Arlington is the name of the town and township of the area in Virginia to the south and west of the Lincoln Memorial. George and Martha Washington adopted George Washington Parke Custis. When "Wash," as they called him, grew up, he acquired the farm in the area where the National Cemetery is now. Wash died in 1857. Wash married Robert E. Lee's surviving daughter, Mary. The farm was in the Lee family at the time of the Civil War and it was protected from thieves and conscripted to bury the Union dead in the 1860s.

By the time Tom Cotton got to Arlington, the area included the Pentagon and Ft. Myer South Post. The remainder of the farm is contained in a nice two-page map drawing in the front of the book. Iraq and Afghanistan soldiers go into Section 60 which is a large area where Cotton served for a time before he went off active duty.

In chapter 3, Cotton reviews how he joined the Old Guard, including earning the Buff Strap, a special insignia for its members. In chapter 4, honor funerals at Arlington are discussed. Three types are full honors, standard honors, and dependents. During his time at Arlington, Cotton participated in over 400 funerals. He explains the process and rituals involved.

In chapter 5, ceremonies are reviewed, from "box-up" to finish. There are many different ceremonies, several recognizing retirements from the Army, but funerals take pri-

ority. The Continental Color Guard is the busiest ceremonial unit. The Fife and Drum Corps is a twelve-soldier group. They wear the 1779 Continental Musician uniform which has the reverse colors of the infantry uniform.

The Commander-in-Chief’s Guard wears a special uniform modeled on George Washington’s personal guard uniforms. “The CinC Guard’s most important outreach event is Twilight Tadoo. . . . The origins of tadoo date to the seventeenth century and to that most soldierly tradition of drinking beer. Dutch military commanders sent a drummer and bugler into the streets to recall their troops from local taverns by playing a tune known as *doe den tap toc*, which is Dutch for ‘turn off the tap.’ . . . As British and American commandoes adopted the practice, the tune’s final two Dutch words were combined and altered into ‘tadoo’” (p. 186).

There is also the U.S. Army Drill Team that offers up to 150 performances per year. Another unit, the Honor Guard Company is the busiest as it marches in almost every ceremony.

Chapter 6 is all about the tombs of the unknown. The Tomb of the Unknown Soldier was the original tomb, and Cotton discusses its history and use in detail. The original tomb was for WW I, but in 1958, tombs for WW II and the Korean War were dedicated. Later Viet Nam was added to the list of unknowns.

This book is most interesting because it explains how The Old Guard helps preserve our memories of soldiers who have kept our country safe since our founding. I am glad I read it. If you plan to visit Arlington read this book.

One of my mother’s cousins married a Master Sargent who was a culinary chef at several U.S. Army bases in Germany and the U.S. This resulted in my younger brother and sister getting to visit them at several of the places they lived while I was in college. Finally, when this Army family retired, the chef became an armored car guard for a few more years before passing in Florida. My mother’s sister in the last half of her life worked for the U.S. Army at an Indiana location. She married a U.S. Army Major who retired from the Army in the 1980s. The U.S. Army was good for these families.

Editor's Postscript
