Ballot Harvesting

It was Wednesday, January 6, 2021, and my friend John had just reached me. “Sid,” he said, “I just want to tell you how unhappy I am that everything you predicted came true.” The “everything” John was referring to was the dual U.S. Senate election of the night before. Yes, being right is not all it is cracked up to be when you correctly predict disaster. I responded this way: “John, if you think losing control of the United States Senate is a huge disaster, consider my next prediction.” It goes like this: “Donald Trump will be the last Republican President of the United States of America.” I continued: “Donald Trump will also be the last non-Democratic President of the United States of America.” In other words, the America we know, our Constitutional Republic, our Checks and Balances, our consent of the governed, is gone. Then, in 2018, California passed a broad Ballot Harvesting bill. Virtually anyone could collect (“Harvest”) your ballot and turn it in on your behalf. The collectors, “Ballot Harvesters,” could be partisan, paid, and agenda driven. The assembly line was being built. All of a sudden people marginal to the voting process became precious assets. If they could get registered, with help, they could request, also with help, a mail-in ballot, formerly called “Absentee Ballot.” The “new” voter got their mail-in ballot. The Ballot Harvester, often paid, stopped by to collect the ballot. Sometimes they were even kind enough to assist the voter in the ballot completion. Other times they might take the ballot and complete it on behalf of the voter. Kindness comes in many forms.

A couple of digressions: First, Absentee Ballots were a courtesy extended to a sliver of the electorate that could not be in town at election time, like out of state college students. It was never seen as the main voting procedure for a major political party. Too late. That genie is never going back into that bottle. Then there is the issue of paying the Ballot Harvester. I will say no more. And third, the private, volitional act of voting is now a rather public, not always volitional part of a collectivized, massive vote producing scheme.

Add to that the proximity of voters to each other in our urban centers and *Voila*, an election victory is born. So here we are in 2020 and the Democrats are the “mail-in” party.

Wow! What a Difference When the Privileged Ruling Class Faces Hostility

The demonstration that led to rioting and vandalism in Washington was the kind of public outrage we have seen hundreds of times in recent years. Most of the 20,000 protesters (as officially estimated by the FBI) were peaceful. In terms of actual violence, this one was in the lower half of the scale.

It was highly focused. There were no mobs running wildly through the streets of Washington attacking businesses, homes and vehicles. There was no mass looting and no neighborhoods being torched. There was no fusillade of rocks, urine and Molotov cocktails bombarding police.

There was one unfortunate death. A young female protester inside the Capitol Building was shot by police. The news media was not able to report the circumstances that resulted in that tragic situation, but this would not be the first riot in which people were killed.

Some media reported four deaths—also without detailed explanation. We did learn that the other three died from some “medical emergency”—perhaps heart attacks. Even under the best of circumstances, people will die wherever large crowds gather. It happens at sports events and theme parks.

Unlike many of those other so-called “peaceful demonstrations” around the nation, the crowds started to disperse quietly from Capitol Hill in the late afternoon. There was no effort to “occupy” the ground or set up some sort of “autonomous zone” as might real insurrectionists.

Most of the demonstrators were gone by the time the sun set. There appeared to be no effort to run the protest into the dark hours as the news folks direly predicted—conjecturing that that is when the violence would erupt on a grand scale. The media was wrong.

The only reported gun shot was the one that killed the young woman. In fact, considering how many of those people support carry and conceal, it is remarkable that there

was not more gunfire. Maybe that is because legal gun owners are not generally involved in non-defensive shootings.

As bad as the damage was to some windows, doors and furniture, it was relatively minor compared to the damage done in the rioting, looting, arson, graffiti and statue toppling we have seen in recent riots around the country.

About 50 people were reported to have been arrested. We do not know the charges or if they will be summarily released as has been the case in most riots where a lot more harm and injury was done.

One point on which almost everyone agrees is that the various law enforcement agencies failed in dealing with the pre-event intelligence and the actions on the ground. Severe criticism was heaped on the Capitol Hill Police, the Secret Service, the DC Police Department, the FBI and the National Guard.

It did seem obvious that their efforts to protect the Capitol Building from being breeched was an inexcusable failure—and even the press could not blame Trump for that. The fact that the rioting mostly took place inside and immediately outside the building underscores that criticalness of the police failure.

What was dramatically different about this event was the reporting. Oh my God! The morning shows were filled with hyperbolic reports emphasized . . . make that exaggerated . . . by hysterical reports of a political Armageddon. According to the folks of the Fourth Estate, this was not a demonstration. It was not even a riot—a descriptive they generally

loath to use even when city blocks are burning, and businesses are being looted. Those other riots are downplayed in the press as “mostly peaceful”—an appellation that could have as easily applied to the mostly peaceful events on Capitol Hill.

Instead, the attack on the Capitol was termed as a violent insurrection. It was sedition . . . treason. It was an attempted coup against the United States. The gathered crowd were domestic terrorists. Of course, it was none of those things. It was a bunch of people—rightly or wrongly (and mostly wrongly)—venting their anger at what they believed was a stolen election.

It appeared that most of the demonstrators understood that there was no way to overturn the results of the election. They were protesting—not looking to seize power. They wanted Congress to order further investigation of vote fraud. The Republic was in no real long-term—or even short-term—danger.

MSNBC’s Joe Scarborough was so overcharged that he went off on one of his increasingly frequent unhinged screaming rants—even f-bombing his audience. He called for the immediate arrest of Trump, the Trump family, former New York Mayor Rudy Giuliani, Senators Josh Hawley and Ted Cruz and others on charges of sedition—and falsely assured his audience that the evidence is clear.

Playing off of the poor response by Capitol Hill police, Scarborough even conjectured that they were in sympathy with the demonstrators—giving them free access to the building. He went so far as to suggest that some of them may be part of Trump’s “cult.”

Scarborough brought in members of his pandering panels. Former Admiral James Stavridis declared that what happened at the Capitol was “as bad as 911.” Ponder that, for a moment. What happened in Washington on January 6, 2021 was as bad as a group of foreign terrorists hijacking three commercial airliners and using them to kill more than 3000 innocent men, women and children—toppling the two Trade Towers in New York City, crashing into the Pentagon in Washington and a force crashed into a field in Pennsylvania by heroic doomed passengers.

Stavridis did not stop there. He went on to say that Russian agents were probably part of the crowd. If we did not believe that we were just uninformed. Of course, he offered no evidence—just another Russian conspiracy theory.

CNN declared that their belief that it was all due to a strategic effort by Trump to remain President after January 20th. CNN declared the events of the day to be “the worst moments in presidential history.” Tell that to Lincoln, Garfield, McKinley and Kennedy.

They said it was the worst assault on the “House of the people” since the war of 1812, when the British ransacked our nation’s capital in an unsuccessful effort to get the colonies back. Somehow none of these anchors, reporters, historians and pundits remembered March 1, 1954, when a

group of Puerto Rican independence terrorists actually stormed the gallery of the Capitol Building and shot up the peoples’ House while it was in session—wounding five members of Congress, one seriously.

They also seem to forget when anti-war demonstrators besieged the Capitol in the late 1960s. The photo atop this commentary was one I took during that demonstration—and yes, they entered the building, too.

Throughout the media-sphere, there were calls for justice. CNN’s Wolfe Blitzer demanded that police arrest and prosecute every one of the protestors—those terrorists and monsters, as they were called. Funny . . . I never heard Blitzer or his colleagues refer to looters and arsonists in those terms. Others suggested that the police use facial recognition to meticulously identify and arrest every possible protester.

Personally, I am all for identifying, arresting and prosecuting anyone who did damage or attacked police. It should be no problem arresting the guy posing for the camera while sitting in Speaker Nancy Pelosi’s office. That has been my consistent belief in ALL these riots—arrest and prosecute. It is just that the idea of arresting rioters *en masse* is a whole new idea from these left-leaning politicians and news folks.

The media got into a lot of whataboutism—that deal where you change the sides to suggest a difference or a hypocrisy. What—they clamored—would have happened if these demonstrators were part of Black Lives, Inc. or a group of Muslims. Apart from ginning up racist friction, we already have the answers. In riot after riot, the leftwing politicians and media were hostile to any police action—especially siding with minority rioters. How many times did we witness homes being burned and businesses being looted as the police stood down—under orders of Democrat mayors and governors?

Remember how Mayor Ted Wheeler blamed those guarding federal buildings in Portland, Oregon for provoking the violence? Or how the police were ordered to stay out of their own precinct headquarters so that the anarchists could “occupy” it with their illegal autonomous zone?

While I can believe that for a few moments, there may have been a sense of fear among members of Congress as uncertainty reigned when rioters entered the building, but for them to act like they were actually attacked is a bit extreme.

Not one member of Congress was directly threatened, shoved, shot at or injured. Their chambers were not trashed. Even Lawrence O’Donnell, on MSNBC, conceded that the Senate Chamber was undisturbed by the rioters who milled about. Both houses of Congress were able to resume normal business shortly after the demonstrators and any rioters were either arrested or removed from the building.

Inadvertently, former Republican National Chairman (and now an MSNBC parroting panelist) Michael Steele hit upon the reason for the EXTREMELY hypocritical differ-

ence in the coverage of this demonstration compared to all those other leftwing riots. He said what happened on Capitol Hill was “in our house . . . our backyard.”

The mob is not off in those distant neighborhoods populated by less privileged people. Perhaps this is all about fundamentally changing America under the guise of COVID-19? Is there any empirical evidence to back the claim that this is a major pandemic just because politicians and medical professionals with an agenda, and the media, say so? This is what this commentary is about—our freedom of choice or our bowing down to intrusive government mandates. That's where we are now—stand tall or submit. You decide. . . .

Would we still shut down the rest of the country over something less than this percentage as it related to the Philadelphia population? We have stadiums that, on any given Saturday, in normal times, hold up to 80,000 to 100,000 people who attend just to watch a college football

game. Three to four stadiums would easily equate to 330,000 people. Yet, on any given Saturday we have thousands of college stadiums across the nation holding 60,000 to 100,000 football fans. Does it sound like three or four stadiums full of sick people, if we looked at it like that, would justify shutting down our country and destroying a once thriving economy and closing businesses, some permanently, putting millions of people out of work? Am I making sense here?

In closing, COVID-19 should be taken seriously, like diabetes and obesity and cancer and alcoholism. These illnesses should never be weaponized. Yet, we have people with college degrees who have not figured out that they are being played by puppet masters pulling their strings. Our educational system has failed us, no doubt, and people have become lazy on an intellectual level, so much so, that they just accept what they are told without regard, or consideration, for the truth. In any given year, over 45,000 people die a horrible death on our roadways, and highways, but should I stop driving? Should I cease to function? Should I go back to walking to and fro long distances? The answer is no! We take precaution, that is what we do when we drive, and the show goes on. When it comes to COVID-19, we need to boost our immune systems. 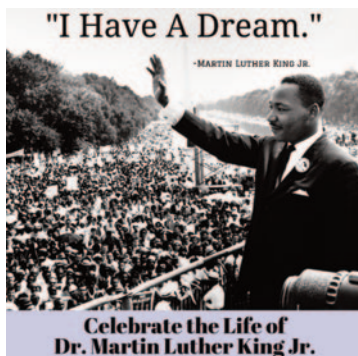

Op-Ed: Censorship in America—A Historical Perspective

As long as I don't write about the government, religion, politics, and other institutions, I am free to print anything.

—Beaumarchais

BOYNTON BEACH, FL—In 1982, seventy years after the fall of Saigon, General William Westmoreland, the former U.S. Commander in SE Asia, declared: “*Vietnam was the first war fought without censorship. Without censorship, things can get terribly confused in the public mind.*”

Censorship in America is not a modern phenomenon. During the early days of the American Civil War, Abraham Lincoln shut down all pro-secession newspapers in the state of Maryland and even had known pro-Southern state legislators thrown in prison. Had Lincoln not acted as he did, Maryland would have joined the Confederacy and the position of the nation’s capital at Washington DC would have become untenable. The history of the U.S. would have been very different.

Censorship really came of age during WWII when military censors routinely opened and read letters sent by U.S. servicemen to loved ones back home. Some of this mail survives to this very day, their blackened or cut out sections attesting to the effectiveness of the military censor.

During the first and second Gulf Wars, information was disseminated to the media through controlled briefings. The lesson of Vietnam had been learned: images of dead and mangled bodies are not conducive to maintaining public support during wartime. The lesson yet to be learned is that censorship can be used, but only in times of war and even then, only on a very limited basis.

Some two and a half centuries ago, the great English poet and critic Samuel Johnson wrote: “*Every society has a right to preserve public peace and order, and therefore has a good right to prohibit the propagation of opinions which have a dangerous tendency. . . . No member of a society has a right to teach any doctrine contrary to what the society holds to be true.*” This argument is inherently flawed. It presumes that the ideas held by the controlling elites are always correct. Every single totalitarian ruler from Hitler and Stalin to Mao and Saddam Hussein would agree. So too, would religious extremist groups such as ISIS and the Taliban, who not only executed anyone who disagreed with them, but in the process, also destroyed priceless historical artifacts all in the name of religious and ideological purity.

During the early days of the Third Reich, the Nazis made a very public spectacle of the burning of books, heaping on the flaming pyre any writings which did not conform to their ideals. Among them was the works of the great 19th century German philosopher Heinrich Heine, who wrote: “*Wherever books will be burned, men also, in the end, are burned.*” History has proven how prophetic those words were. The Communists achieved their goals not through a display of arson, but by sentencing to prison or exile anyone who did not con-

form, including Alexander Solzhenitsyn, who wrote of these times in *The Gulag Archipelago*.

Make no mistake—censorship of thought, ideas, and speech are the hallmarks of a totalitarian state and will inevitably lead to tyranny and oppression. Given the growing power of mainstream media and especially big tech, our ability to access accurate information, our freedoms and ultimately our democratic institutions, are all in peril.

In today’s age of information, more people get their news from the Internet than from newspapers/periodicals. The situation becomes even more acute given the anonymity of the Internet executives and their algorithm writers. This concentrates enormous power in the hands of big tech, who use censorship as a means to advance an ideological and political agenda. Defenders of these practices claim that they are protecting the public from harmful ideas; yet the censorship is invariably one-sided. It is always Republican or Conservative voices who are silenced or deleted. This is reverse McCarthyism and is nothing less than the weaponization of the means to access and disseminate information. It is an abrogation of the right of free speech in order to advance a radical agenda, and thanks to Section 230, they have complete immunity to do exactly as they wish. This is a far more insidious form of censorship than anything previously because it is silent and unseen. There is no public display of burning books and no Gulag Archipelago (as of yet), to which dissidents can be exiled. The burning book has been replaced by the deleted post as the weapon of choice for the ideological censor of today.

Years ago, the late Hubert Humphrey once stated: “*Freedom is hammered out on the anvil of dissension, discussion and debate.*” It is sad to note how far we have strayed from this simple rule.

In the light of history, one cannot help but wonder what Heinrich Heine would say if he were alive today. Although one cannot say with absolute certainty, it might be something like this: “*Wherever posts will be deleted, people also, in the end, are deleted.*” A long time ago, Thomas Jefferson warned the American people: “*When government fears the people, there is liberty. When the people fear the government, there is tyranny.*” As of this writing, more and more Americans are beginning to fear their own government.

Let's Reshuffle the Deck

Plain and simple, the 2020 presidential election was rigged by the Democrats. They stuffed the ballot boxes in the swing states, and they, and their lame stream media lap dogs resisted and bluffed when attempts were made to reveal the enormity of the fraud. The Dems have been doing this for decades but this time the enormity of crime was conclusively unmasked. Unfortunately, the establishment political and judicial system, including the U.S. Supreme Court, had their collective heads in the sand. They allowed the presidency to be stolen by and for the Dems by massive fraud that went unpunished. Time to strike back!

There are lessons to be learned here, though. Let's take a page out of the Dems' playbook and aggressively go after Electoral College votes. Let's reshuffle the Electoral College deck. Here are some enticing prospects to do just that.

That is, to secede from Oregon and Washington, and become part of Idaho. This is not beyond the pale. The level of outrage amongst Republicans, and some Independents, that came out of that fraud-riddled 2020 presidential election just might be lever-

aged enough to make all or part of this possible. Maybe there's a job for Donald Trump here.

Is this an enticing prospect? Damn right it is. But why limit the program to just two Pacific Northwest States? I have attached two maps as exhibits below. Exhibit One shows the results of the 2016 presidential election by county, and Exhibit Two shows the results of the 2018 congressional races for the House of Representatives, by county. There is not a lot of accurate mapping of the 2020 race, so I have no exhibits to offer for that election, but I don't believe it would significantly change the equation other than for those 2020 results for counties containing such cities as Atlanta and Philadelphia where the fraud was perpetrated in 2020.

The distribution of Republican v. Democrat counties doesn't vary all that much between the two exhibits. Of the two, the one that most accurately depicts voter preference is the 2018 House Map.

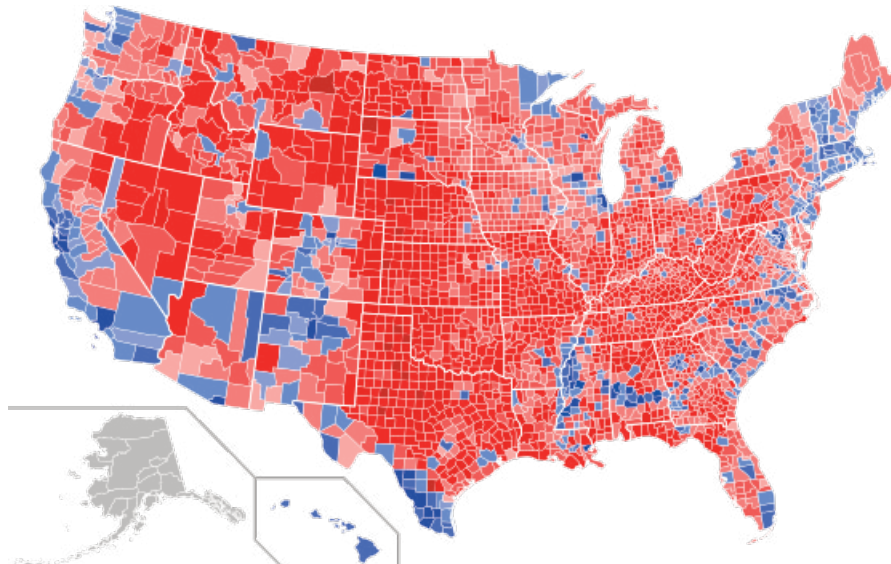
Either map you choose, there are some delicious prospects to have various "Red" states go after Republican (Red) Counties in adjacent blue leaning states.

Look at the maps, here are some obvious targets:

- As noted above, Idaho could target "Red" Counties in Washington and Oregon. Some "light blue" counties in eastern Oregon might be surrounded by "Red" counties that decide to join Idaho so they would ultimately have to go along. Same for some light blues in western Virginia. If all around them decide to move, they too would also have to go along.

- West Virginia, Kentucky and North Carolina could go after “Red” Counties in Virginia.
- Nevada could target “Red” Counties in northern California, and along California’s east border between those two states.
- Utah, Wyoming and Kansas could target “Red” Counties in Colorado
- Texas could try target “Red” Counties in eastern New Mexico.
- Iowa, Missouri and Indiana could target “Red” Counties in Illinois.
- Indiana and Ohio could target “Red” Counties in Michigan.
- Maine could target “Red” Counties on its border with New Hampshire.
- West Virginia and Pennsylvania might target “Red” Counties on their (hopefully growing) borders with Maryland.
- Despite all the red on the map. Minnesota usually goes Blue in Presidential races. The Dakotas, Iowa and maybe Wisconsin could divvy up the “Red” Counties in Minnesota. Take that Minneapolis–St. Paul! Enjoy your City State status.
- Should this succeed, you might find someday that Mt. Rainier, Mt. Adams, Mt. St. Helens are all in Idaho. Death Valley and Yosemite and Sequoia National Parks are all entirely in Nevada. Appomattox Courthouse and the Fredericksburg Battlefield might be in West Virginia. As the lyric goes in My Fair Lady “Wouldn’t it be Lovely.”

The Republican voters in those “Red” counties are beyond frustrated with the Democrat administrations that have run roughshod over them for decades. It’s an enormous

long shot, but this just might be the time to try. The Dems would be apoplectic, and considerably weakened in the Electoral College!

Should any of this be attempted, it would be vigorously resisted by the targeted “Blue” and “Purple” States. At best, it would be a huge donnybrook! Probably more like a knife fight. But a successful outcome to any or all of this would have a huge impact on the Electoral College vote, and the congressional representation of those states affected. Blue states would lose representation, and Red states would gain representation. The impact would universally be favorable to Republicans.

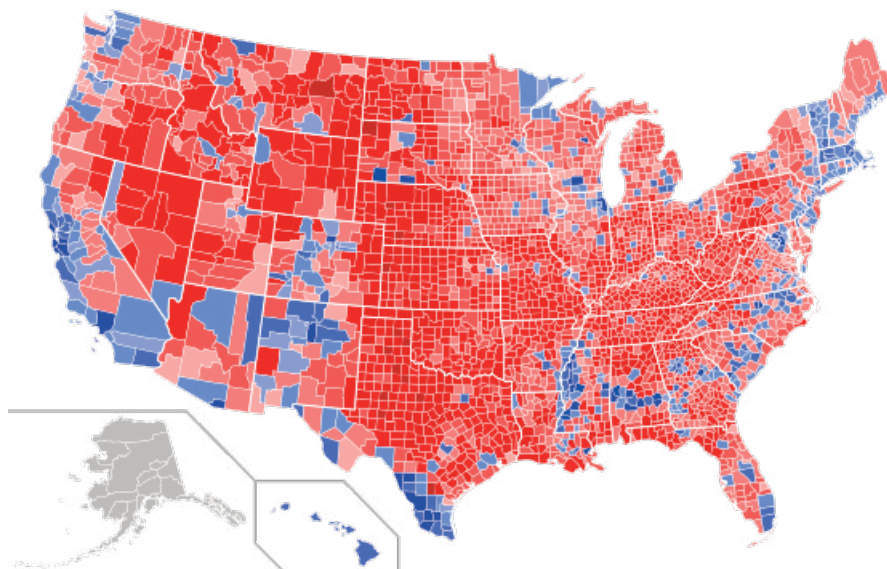

A Letter from Senator Rick Scott

This is the response from the email I sent Sen. Scott praising him for vote on January 6th.

Dear Mrs. Primoff,

Thank you for contacting me regarding the 2020 presidential election. I appreciate the opportunity to respond.

On January 6, 2021, the United States Congress convened in a Joint Session to count the states' electoral votes for president and vice president. What transpired that day, as criminals and thugs stormed the United States Capitol, was disgraceful and un-American. It is not what our country stands for. Those responsible for inciting violence should be prosecuted to the fullest extent of the law. We must always strive to protect our nation and the peaceful preservation of our rights, and we will never accept violence.

I am eternally grateful for Capitol Police and all responding law enforcement officers for their tireless service. Their efforts kept us safe and allowed Congress to return the same evening to finish our work to finalize the electoral count for the 2020 election.

Throughout the proceedings, I listened to all of the objections that were raised and the evidence and arguments that were presented on both sides. I heard from constituents across Florida and across the country and I've listened to their concerns about the way this election was carried out. I share many of their concerns.

Specifically, the situation in Pennsylvania was of particular concern to me. The actions of the Pennsylvania Governor's Administration and the courts in Pennsylvania pose a serious threat to the integrity of future elections. The Governor of Pennsylvania, along with state courts, made a decision to allow votes to be counted that came in after Election Day, even if they did not have a postmark, in defiance of state law. This is absurd, and cannot be tolerated. It also appears that Pennsylvania enacted policies in direct conflict with its own state constitution, which is also unacceptable. We simply cannot tolerate partisan political attempts to change the rules and tip the scales in our elections. In October, Supreme Court Justices Alito, Gorsuch and Thomas warned that

the reckless actions of Pennsylvania's Governor and Secretary of State might result in 'serious post-election problems' and they were right. Both of these matters are still pending at the United States Supreme Court. I voted to sustain the objection to Pennsylvania's slate of electors because these important constitutional questions are still unresolved.

This election has shown us that we need major reforms to our electoral system and that is why I proposed the Verifiable, Orderly, & Timely Election Results (VOTER) Act, which would address systemic problems in voting systems across the country and rebuild trust in our electoral process. It would mandate Voter ID in every state, institute measures to ensure timely results and create uniform national standards for voting by mail. I believe it is a strong path forward to prevent a repeat of the 2020 election and ensure Americans have faith in free and fair elections.

Voting is fundamental to our democracy, and it is a sacred right that we must protect and cherish. I look forward to working with my colleagues in the Senate to get this legislation passed and ensure smooth and secure elections.

Again, thank you for contacting me regarding your concerns. I am proud to represent all Floridians.

Book Review

***Reaganland: America's Right Turn, 1976-1980*, by Rick Perlstein. New York: Simon and Schuster, 2020. Hardcover, 1108 pp. ISBN 978-1-4767-9305-4.**

My guess is that the author, Rick Perlstein, is a liberal, but after reading, *Reaganland*, I wholeheartedly conclude that conservatives will find that investing the considerable time required to pore through it is worth the effort. He's a contributing editor and board member of *In These Times* magazine, and his essays and book reviews have been published in *Esquire*, *The New York Times*, *The Nation*, *The Village Voice*, and *Slate*, among others.

At 65 years of age, Ronald Reagan was too old for the presidency, said the *New York Times* in 1976, adding that the GOP was closer to extinction than at anytime before in its 122-year history. What a difference the next four years under Jimmy Carter's leadership would make to that bit of opining. That year, a historian of campaign advertising observed about assurances from Rosalynn Carter, that "Only in 1976 can a claim that a candidate is honest, unselfish, hard-working and concerned about the country warrant the conclusion that he will be a great president." Included in what follows are but a few examples of the decisions this man made in office that turned Republicans' fortunes around in just four short years and helps remind us that despite the Dems' phony triumph last year, it will not last forever.

Carter's first official act as president was to issue an executive order to "pardon" draft-dodgers who had evaded service in the Vietnam War. RNC chairman Bill Brock called it, "a slap in the face of all Americans and families who did their duty."

With regard to the nation's growing energy crisis at the time, brought on by Arab countries' oil embargo imposed as a response for our support of Israel, Carter implored Americans to lower their thermostats to 65 degrees during the day, 55 at night. "If we are a united nation, then I can be a good president," he concluded.

Another festering problem for Carter was his ambassador to the United Nations, Andrew Young, a black former civil rights movement hero. He had recently said that England "almost invented racism," and that Cuban troops stationed in the African nation of Angola had brought "a certain stability and order." He apologized to the British Ambassador—then stepped in it even worse on the subject of Cuban troops, averring that Americans should not get paranoid over a few thousand Communists." Retorted a Republican congressman from North Carolina, "They stabilize you upside the head."

Ronald Reagan's tax plan for the nation had some "new ideas." "For four years a young New York congressman named Jack Kemp has been urging on his colleagues a tax plan based on common sense and backed by a record of success," he said. "The pattern from his plan comes from the late president John F. Kennedy. His Keynesian advisors

swore that government would suffer a great loss of revenues. . . . Instead, the stimulus to the economy was so immediate that actual tax revenues equaled a \$54 billion increase in six years."

Jack Kemp was proposing a policy miracle and Ronald Reagan was one of his first major converts. It was a development that would be central to his political story.

A most interesting part of the book for me was how the press dealt with the Carter administration's first scandal concerning Bert Lance's First Bank of Georgia. "By not asking the president a single question about this first scandal at his press conference last week, the White House press corps completed its transformation from attack dog to lap dog," opined columnist William Safire. Despite this familiar view of the mainstream media, which did indeed display a left-wing bias, it was nowhere near the level of today's hopelessly one-sided fourth estate and Carter did have to endure considerable criticism for his policies.

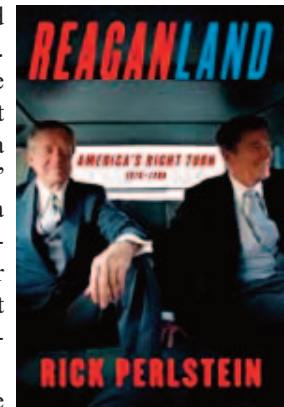
Carter's foreign policy was a target of both the right and left. A typical contribution from Norman Podhoretz to the formerly liberal magazine *Harpers*—"the parallels with England in 1937 are here, and this revival with the culture of appeasement ought to be troubling our sleep."

But it was the Democrat Party's own lack of belief in America's future prospects, led by Jimmy Carter, that paved the way for Reagan and a decade of conservative dominance in American politics. As Ronald Reagan said, "The Democrats would have us believe that the days of growth and expansion in our land are a thing of the past. They preach a philosophy of resignation and despair; the sharing of scarcity instead of the creation of plenty. They have lost their faith in the system handed to us by our fathers—they have lost faith in us.

"What is it that unites all Americans of all faiths, creeds, races, political persuasion and economic backgrounds? It is hope [and] the practical success of seeing our dreams fulfilled. It is this unique combination of aspiration and accomplishment, dream and deed, that truly sets Americans apart. . . . These have been in short supply in Washington, where politics-as-usual prevails, while our nation drifts. But the winning combination is still strong among the American people."

And I believe that that eternal Reaganesque message of brighter days ahead for our country still resonates with the silent majority of American patriots just as well today as it did forty years ago, so my advice; read this book about the Carter years in our history and see if you agree that in the fullness of time, another era of *Reaganland* is inevitable.
